

ARTICLES OF ORGANIZATION
OF
NEW NORTH INVESTMENTS LLC

1. The name of the limited liability company is New North Investments LLC (the "Company").

2. The period of the Company's duration is perpetual.

3. The purpose for which the Company is organized is the transaction of any or all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Law, including, but not limited to: (a) the buying, selling, managing, operating, renting, and owning of real estate and personal property; and (b) providing consulting services.

5. The name and mailing address of the initial member of the Company are as follows:

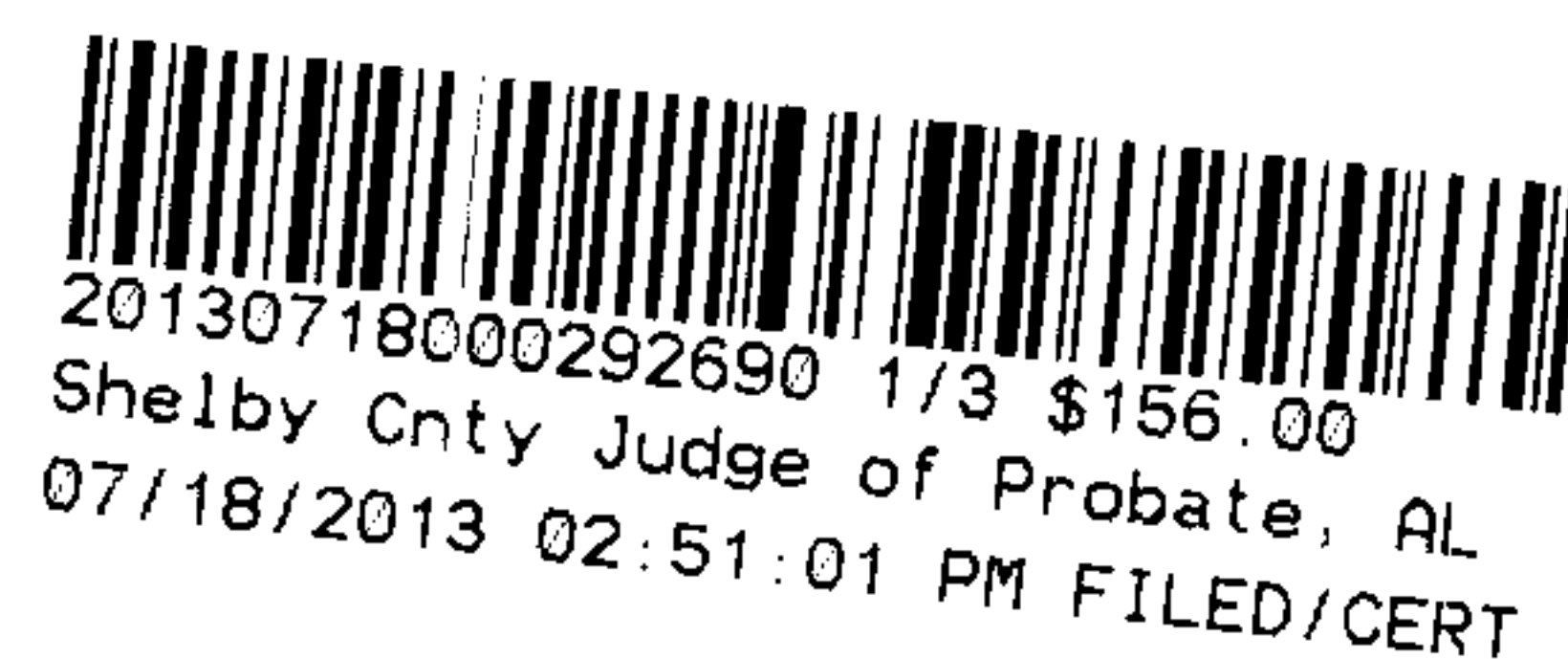

mailing addresses of the manager of the Company, who shall serve until her successor(s) are elected and begin serving, is:



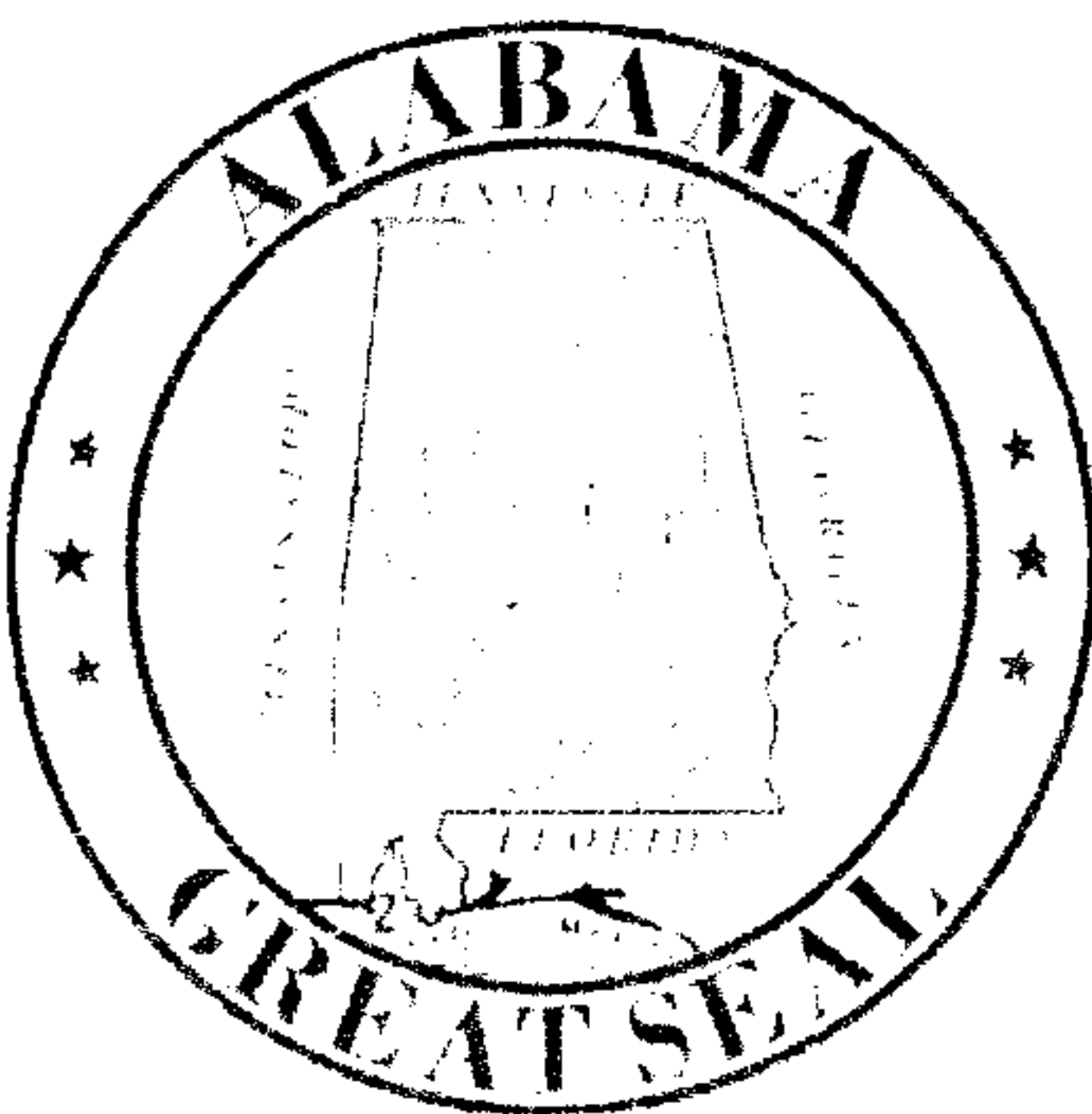
