**ARTICLES OF ORGANIZATION  
OF  
THE KEEP, LLC**

We, the undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certify as follows:

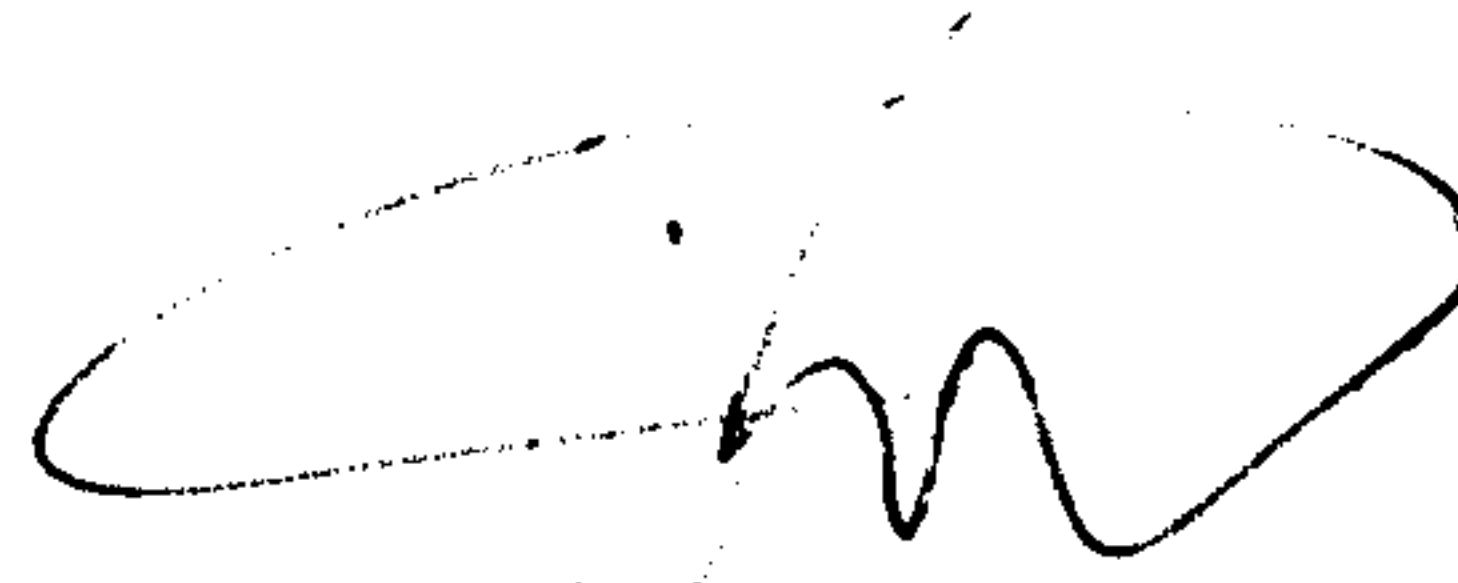
1. The name of the Limited Liability Company is THE KEEP, LLC.
2. 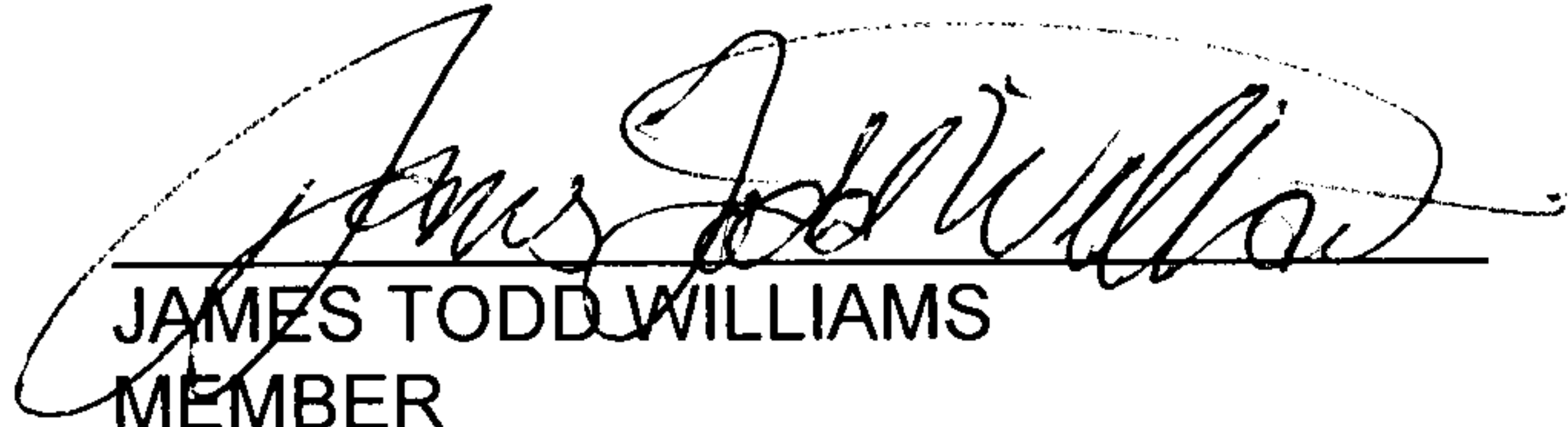
6. The membership of the limited liability company shall have the right to admit additional members to the limited liability company upon the unanimous consent of all the members of the limited liability company.

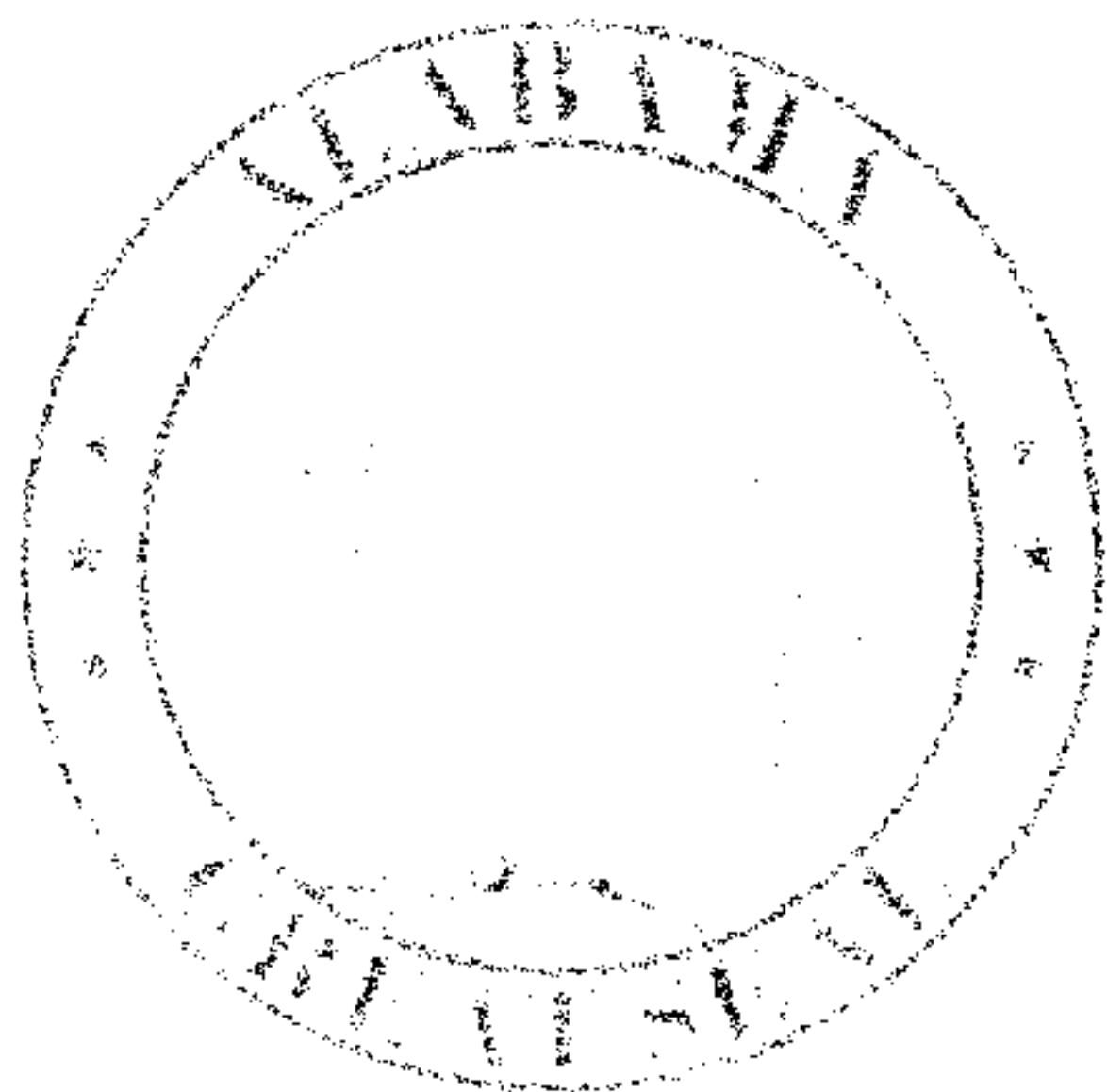
