WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this July 17, 2013, That for and in consideration of **TWO HUNDRED THIRTY THOUSAND AND NO/100 (\$230,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **GERARD A. D'ALESSANDRO, JR and MEGAN D'ALESSANDRO, husband and wife** (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **RONALD J. COYNE and PEGGY M. COYNE**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 43, according to the Final Plat of Subdivision, North Lake at Greystone, Phase 4, as recorded in Map Book 24, Page 119, in the Probate Office of Shelby County, Alabama.

Subject to:

2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
