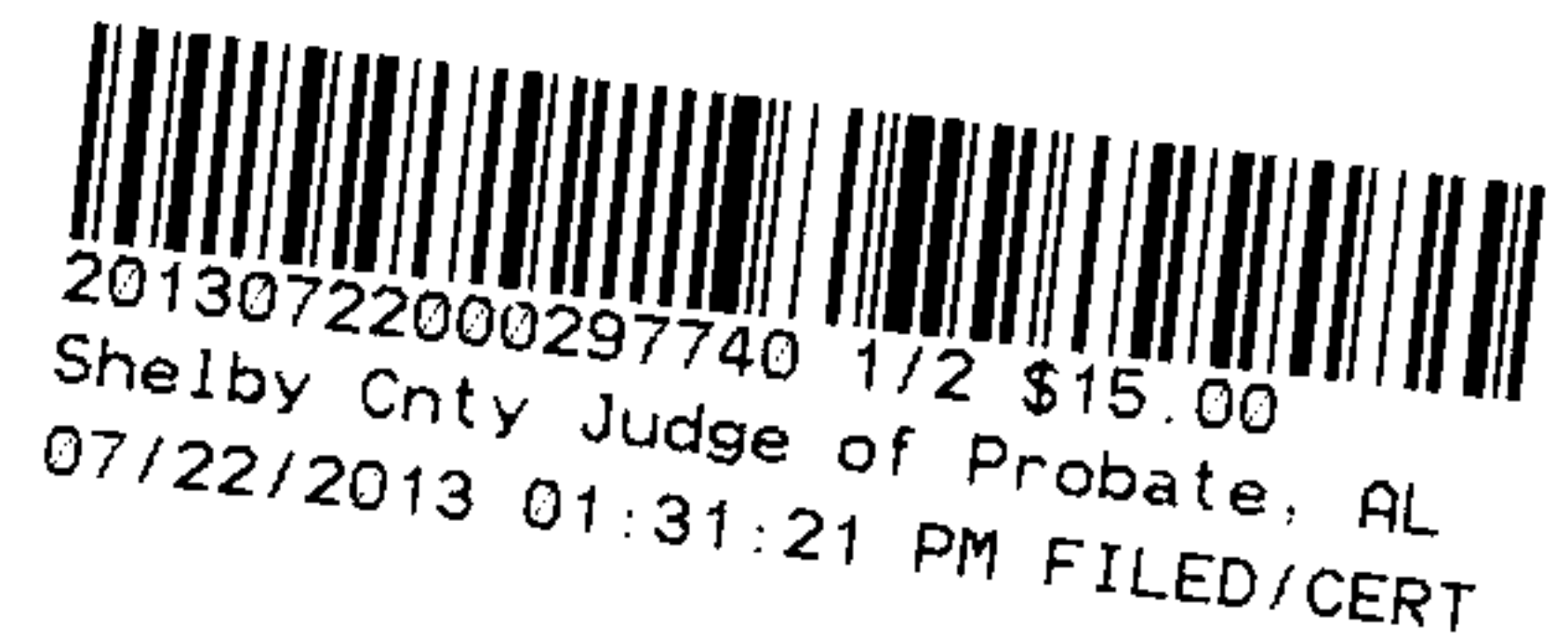

VERIFIED STATEMENT OF LIEN


