ARTICLES OF INCORPORATION OF

Chelsea Business Alliance

The undersigned, acting as Incorporator of a not-for-profit corporation under §§ 10-3A-1, et seq., *Code of Alabama* (1975), adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION AND DURATION

The name of the corporation shall be Chelsea Business Alliance and the period of its duration shall be perpetual.

ARTICLE II - PURPOSE

This corporation is organized and shall be operated exclusively as a business league, within the meaning of section 501(c)(6) of the Internal Revenue Code, or the corresponding section of any future federal tax code; and within such limits, to administer, and expend funds for promotion of commerce and integrity of commerce in the City of Chelsea, Alabama. The purpose includes the transaction of any lawful business for which nonprofit corporations may be incorporated in Alabama under Title 10A, Chapter 3, of the *Code of Alabama*.

ARTICLE III- MEMBERS

The corporation shall have members. Members shall have the right to vote as set forth in the Bylaws.

ARTICLE IV- INUREMENT OF BENEFITS AND DISTRIBUTION EARNINGS

No part of the assets or net earnings of the corporation shall inure to the benefit of,

or be distributable to its directors, officers, or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for services

rendered and to make payments and distributions in furtherance of the purposes set forth in

Article II hereof.

ARTICLE V - DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon dissolution of the corporation, all of its assets and property of every nature

and description remaining after the payment of all liabilities and obligations of the

corporation (but not including assets held by the corporation upon condition requiring return,

transfer, or conveyance, which condition occurs by reason of the dissolution) shall be paid

over and transferred to the City of Chelsea, Alabama, or to and among such one or more

organizations as are then exempt from federal income taxes under Section 501(a) or the

corresponding provision of any subsequent federal tax law.

ARTICLE VI- LIMITATIONS

Notwithstanding any other provision of these Articles, the corporation shall not

conduct or carry on any activities not permitted to be conducted or carried on by an

organization exempt under Section 501(c)(6) of the Internal Revenue Code, or corresponding

provision of any subsequent federal tax laws.

ARTICLE IX - BYLAWS




