The effective date of the formation of the limited liability company shall be July 10, 2013.

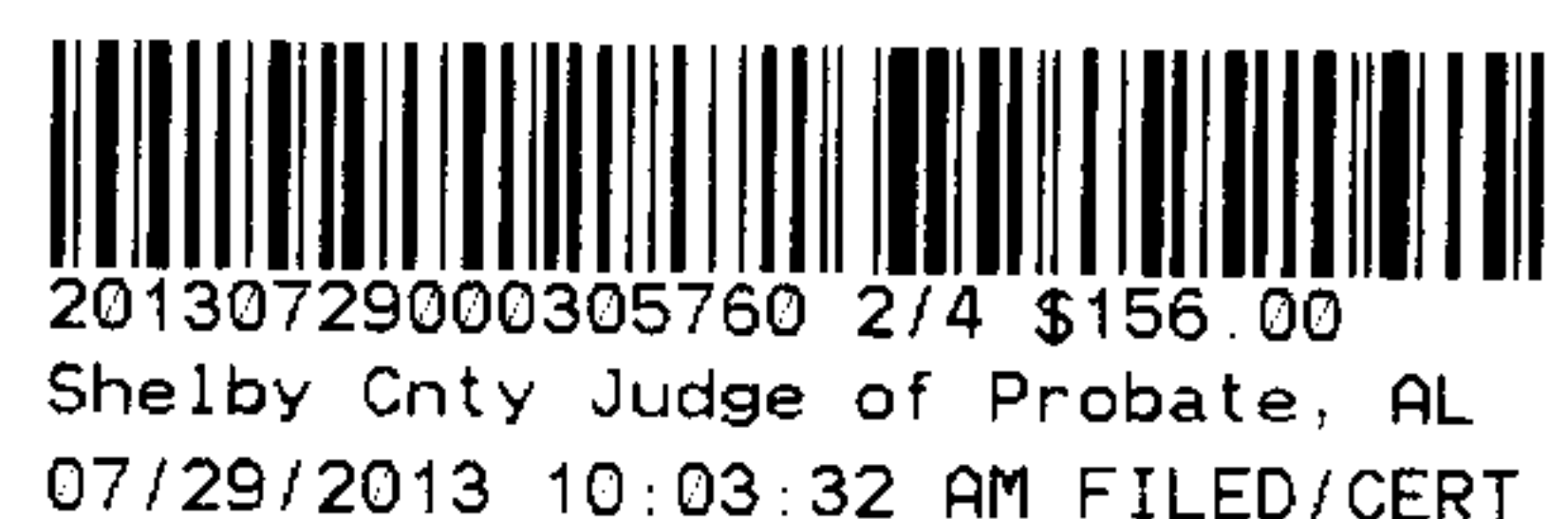


