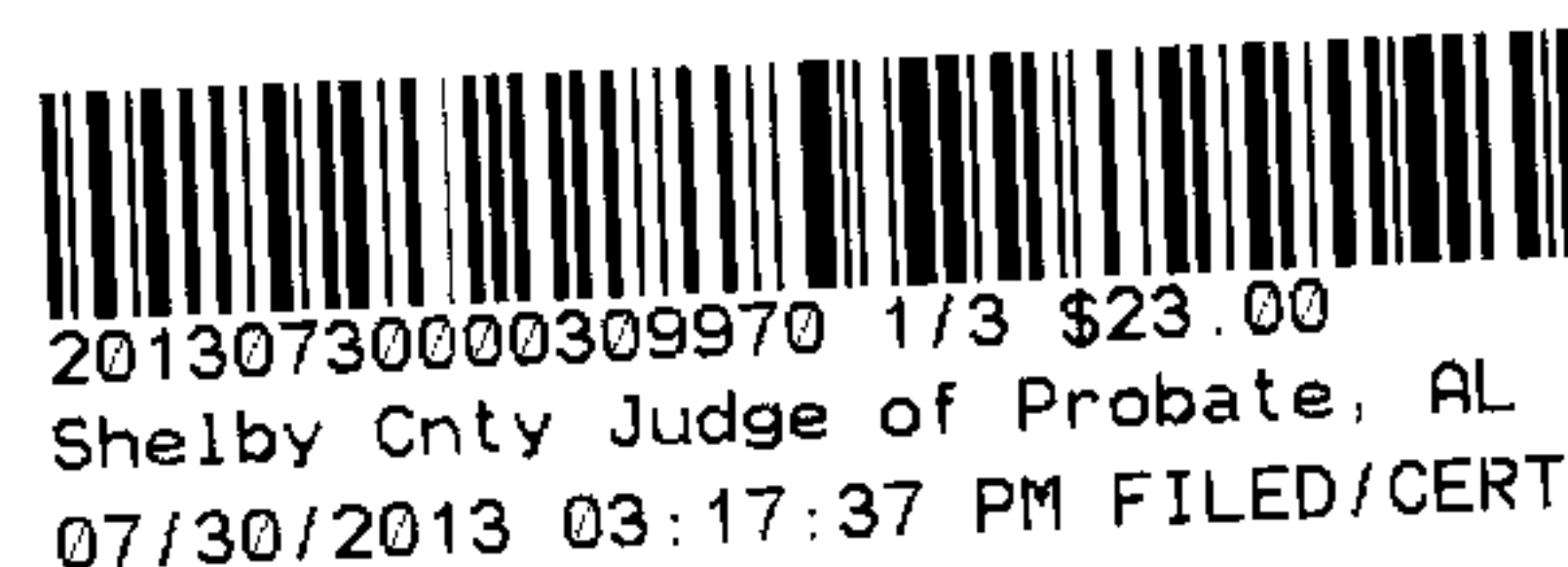


AUCTIONEER'S DEED

WHEREAS, Rhunetta Crumel, an unmarried woman executed a mortgage to Mortgage Electronic Registration Systems, Inc., (MERS) acting solely as nominee for Lender, The Mortgage Company, LLC, an Alabama LLC, and Lender's Successors and Assigns dated January 14, 2009, and Recorded in Instrument No. 20090122000020430 and modified in Instrument No. 20120319000094020 of the records in the Office of the Judge of Probate, Shelby County, Alabama; which said mortgage was subsequently assigned to Flagstar Bank, FSB by instrument recorded in Instrument Number 20121019000403280 of said Probate Court Records; and

WHEREAS, in said mortgage the mortgagee was vested with full power and authority, upon the happening of a default in the payment of the principal note described in and secured by said mortgage or any installment of interest thereon, to sell said property hereinafter described at public outcry before the Courthouse door in the City of Columbiana, County of Shelby, Alabama, for cash to the highest bidder, after giving notice of the time, place and terms of sale by an advertisement published once a week for three successive weeks in a newspaper published in the City of Columbiana, Alabama; and

WHEREAS, a sale has been made of the said real property hereinafter described during the legal hours of sale on the 24th day of June, 2013, at the front door of the Courthouse of Shelby County, Alabama, in strict conformity with the powers of sale contained in the said mortgage, at which sale **Flagstar Bank, FSB** was the highest and best bidder and did become the purchaser of the real property hereinafter described for a credit bid of **\$90,880.00**. 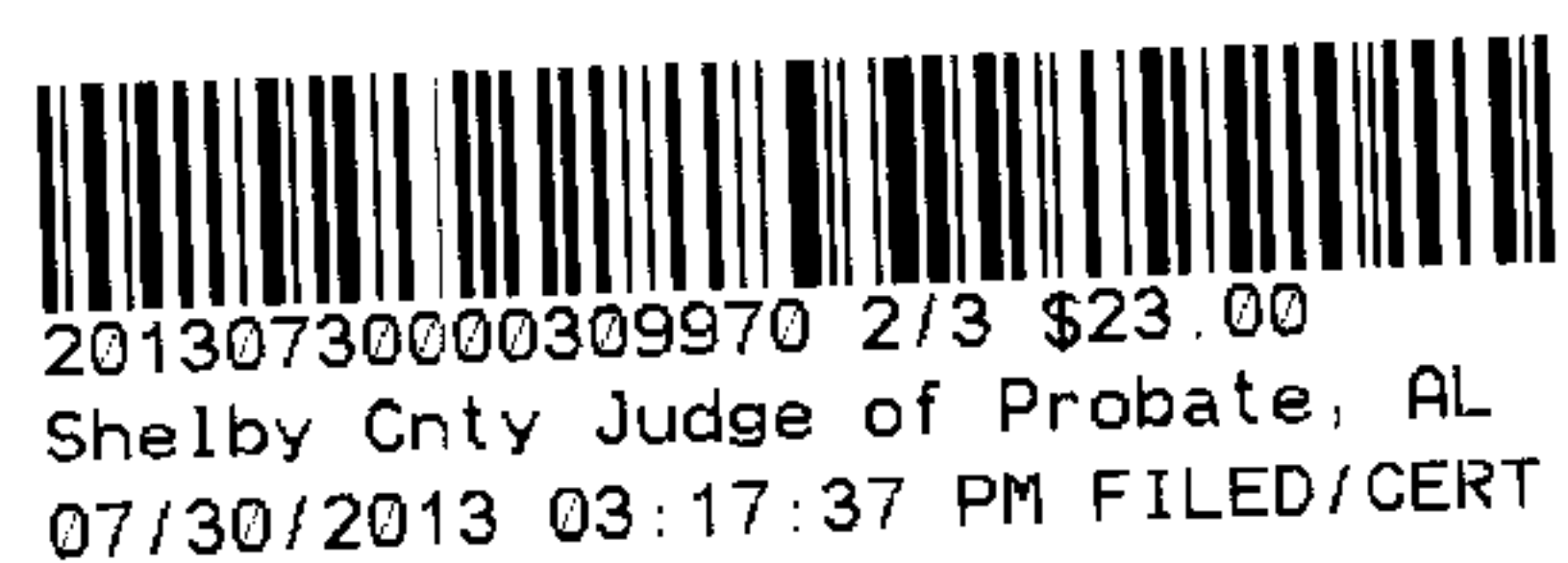
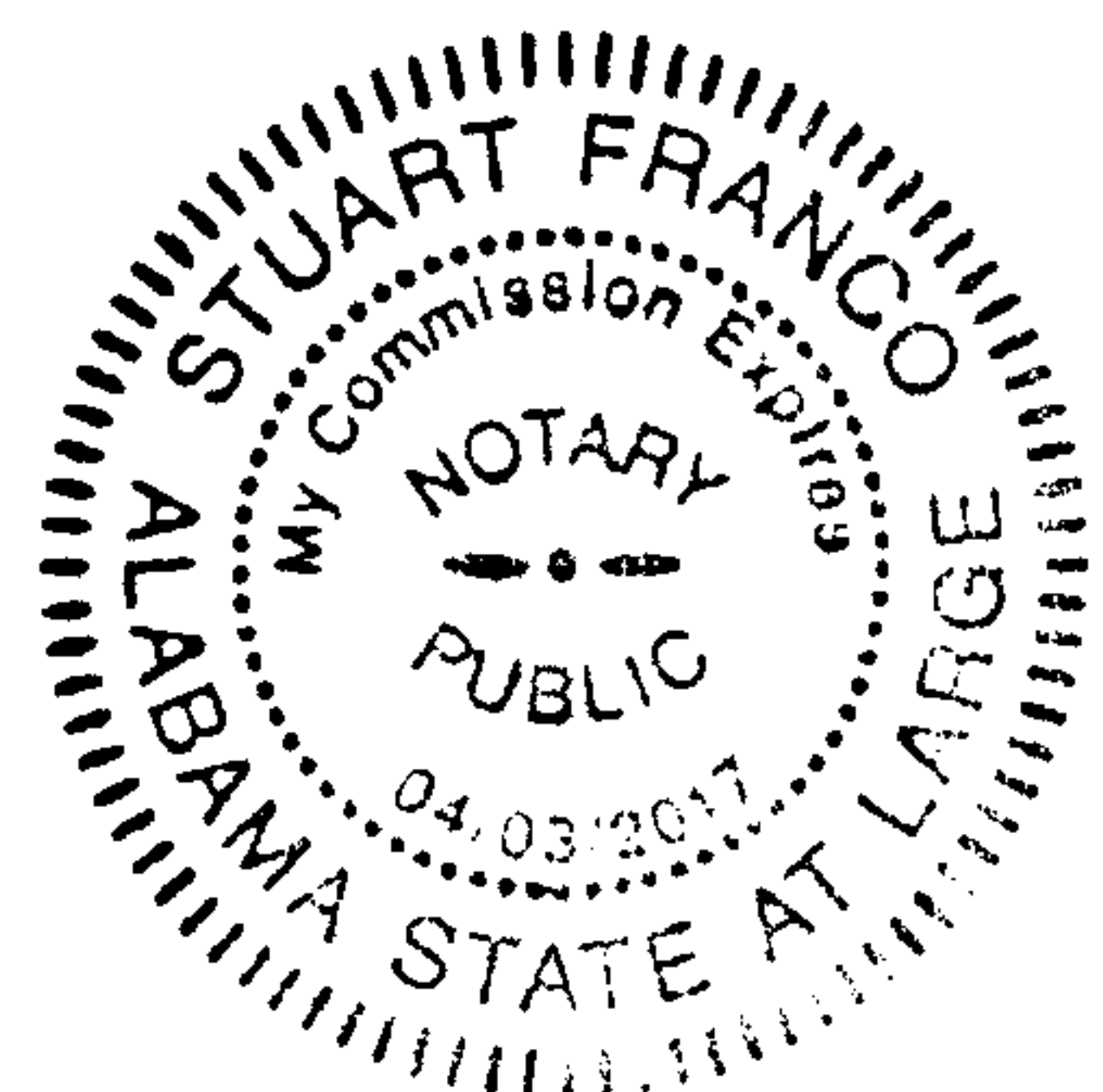
