KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Four Hundred Twenty-Nine Thousand and 00/100 (\$429,000.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Barry Vernon O'Brien, and wife, Lori Jo O'Brien**, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Lloyd Mikeland Currier, Jr. and Janelle Smith Currier**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 2843, according to the Map of Highland Lakes, 28th Sector, an Eddleman Community, as recorded in Map Book 34, Page 30, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
