

Subject to all rights of way, easements, covenants and restrictions of record.

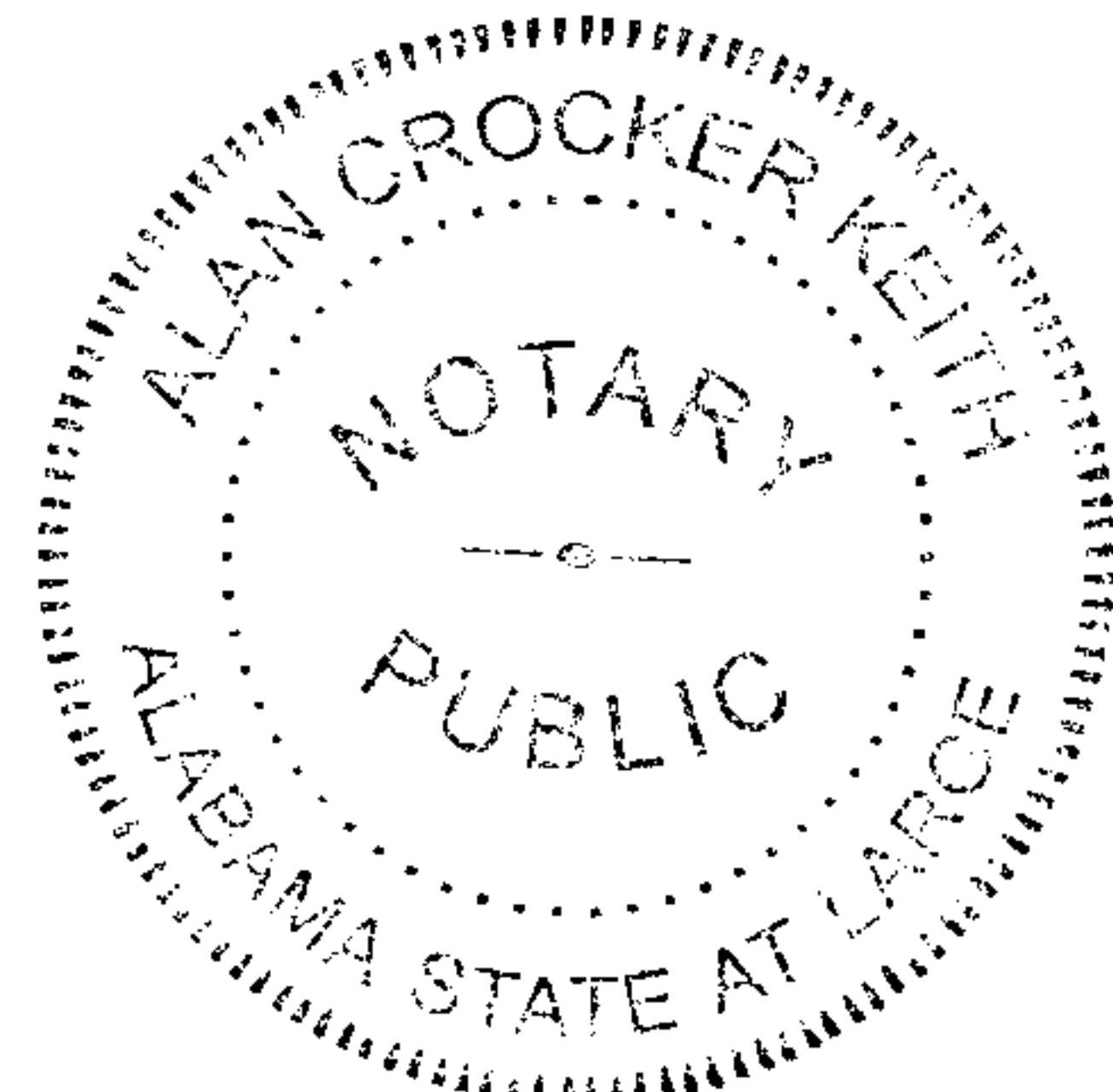
