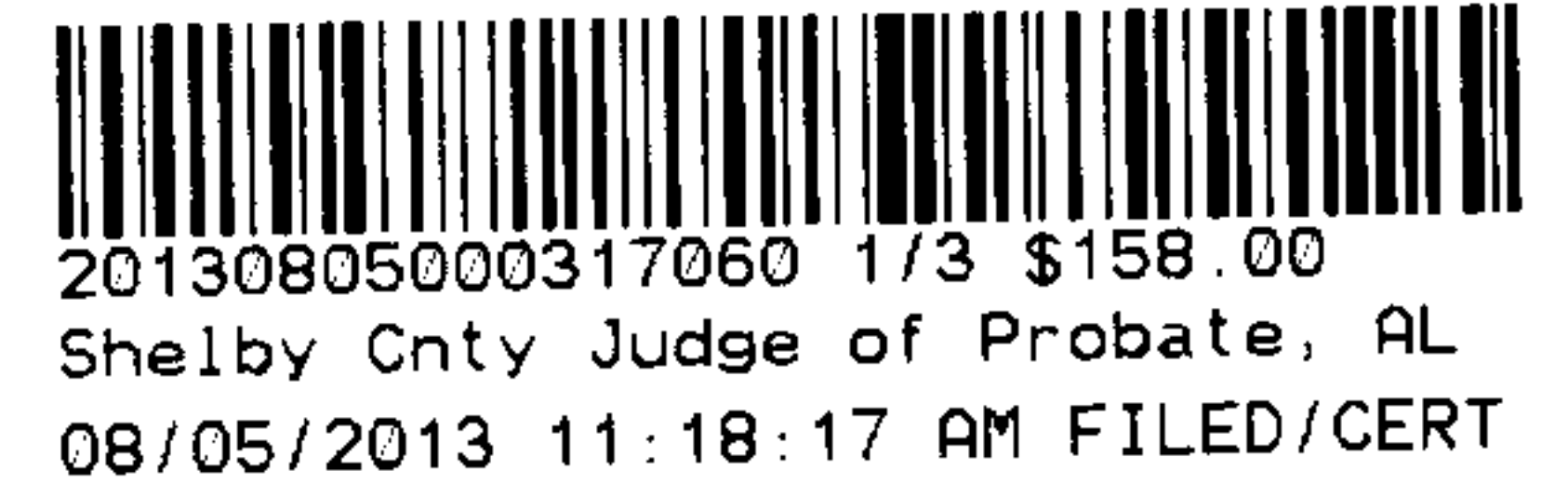


**CERTIFICATE OF FORMATION
OF
THE CNG WAREHOUSE, LLC**



1. The name of the limited liability company is The CNG Warehouse, LLC hereinafter referred to in this Certificate of Formation as the "Company".

2. The period of its duration is perpetual.

3. The purpose for which the Company is organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Law, including, without limitation, engaging in the business of selling, marketing and distributing compressed natural gas products and all activities incidental thereto.

4. 6. The members shall have the right to admit additional members to the Company in accordance with the terms and conditions of the applicable provisions of the Operating Agreement of the Company.

7. Except as specifically required by any non-waivable provisions of the Alabama Limited Liability Company Law or any provisions of the Operating Agreement of the Company, the cessation of membership in the limited liability company by any member shall not result in the dissolution of the limited liability company.

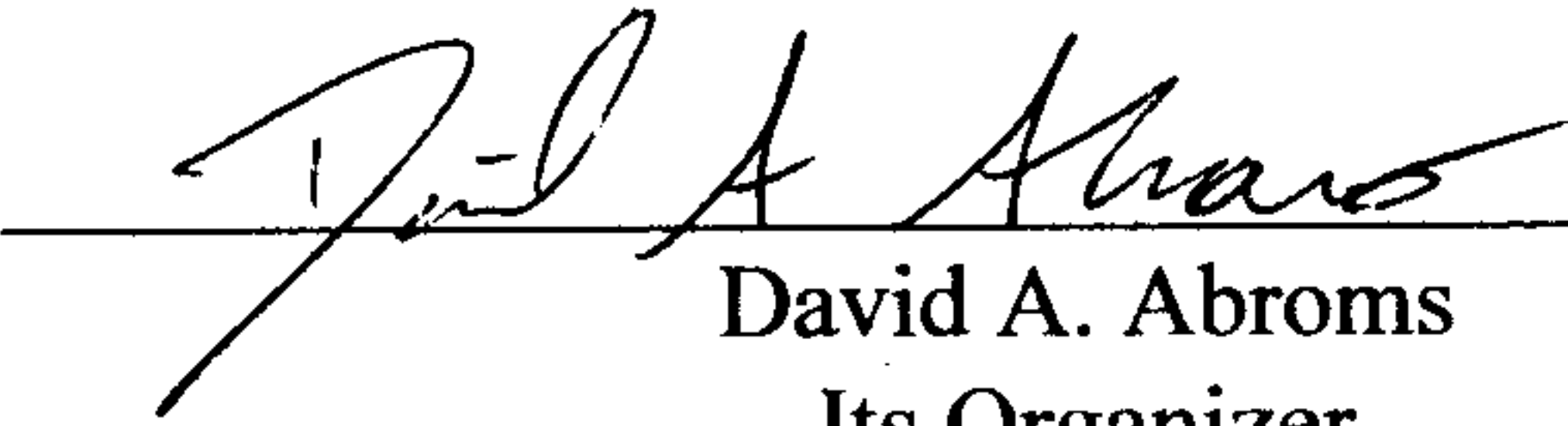

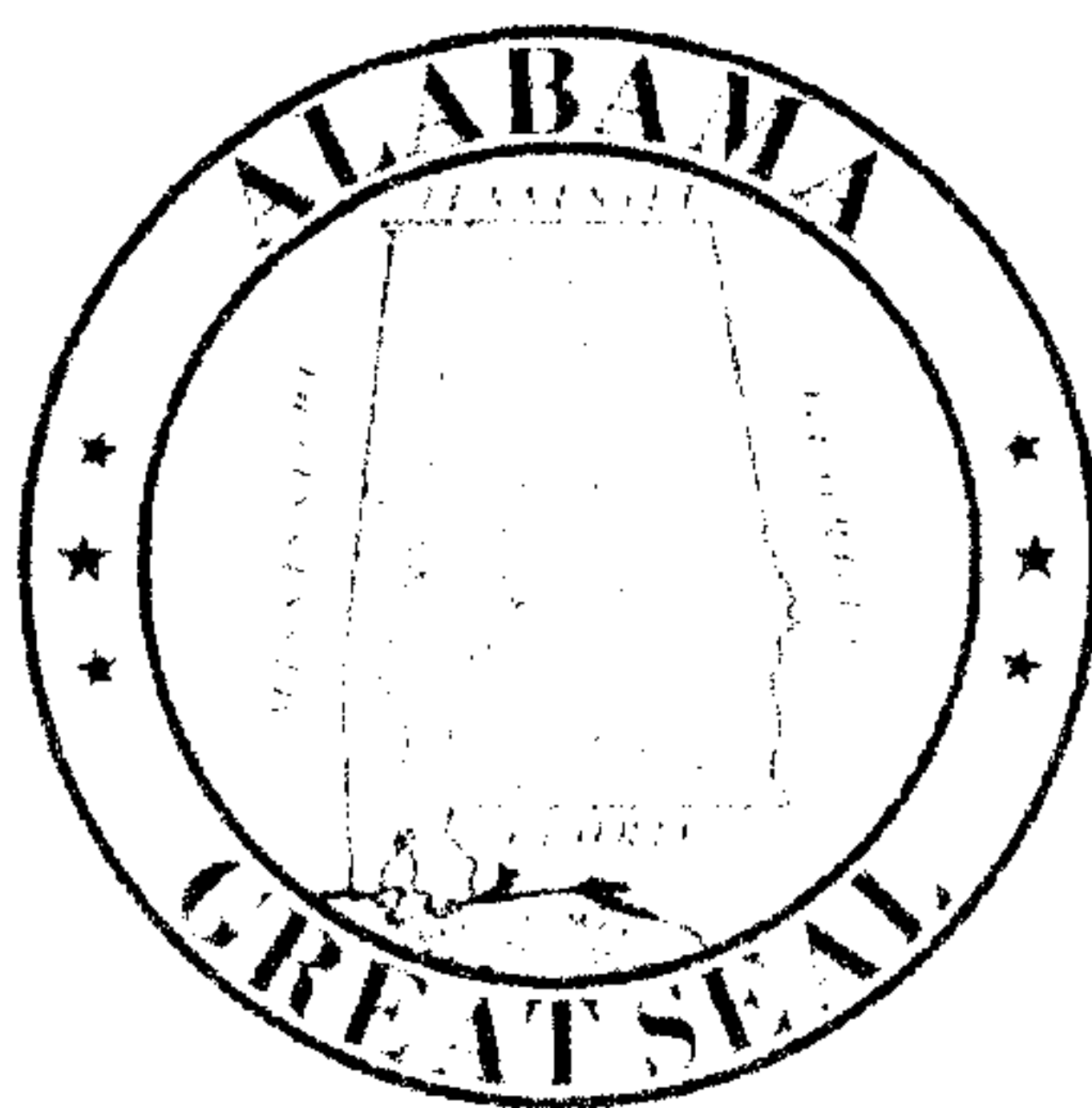
