

MODIFICATION OF MORTGAGE

Mortgagee allows mortgagor to increase the original Mortgage Agreement, as modified and amended, from Three Hundred Two Thousand Nine Hundred Fifty and 00/100 Dollars (\$302,950.00) to Three Hundred Forty Seven Thousand Eight Hundred and 00/100 Dollars (\$347,800.00)

Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
