ARTICLE I

Registered Office; Registered Agent

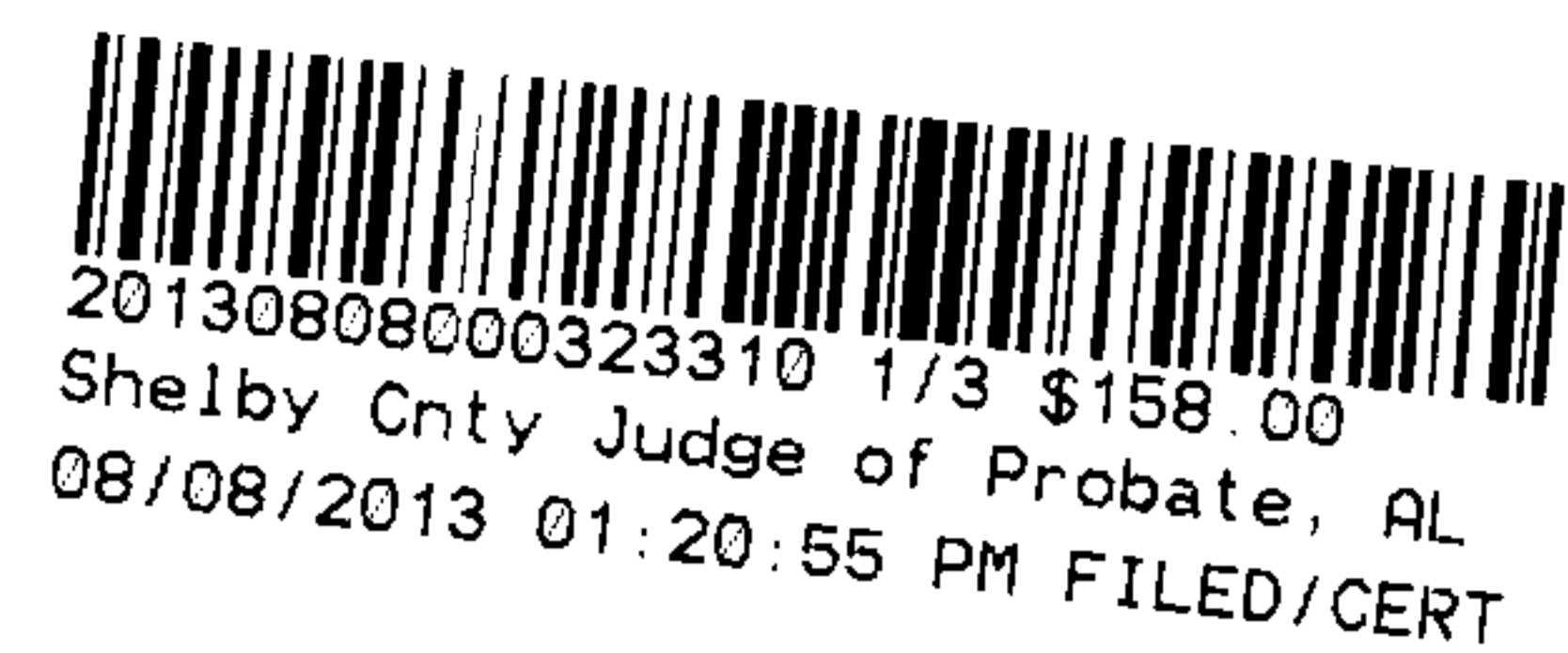
