WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Three Hundred Sixty-Four Thousand and 00/100 Dollars (\$364,000)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

David C. King and his wife Dana H. King

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Casey Blythe and Kristi Blythe

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 22A, according to the Survey of Final Plat, Grand Oaks, as recorded in Map Book 31, Page 68, in the Probate Office of Shelby County, Alabama.

\$291,200 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2013 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantors; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

TO HAVE AND TO HOLD unto Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.
