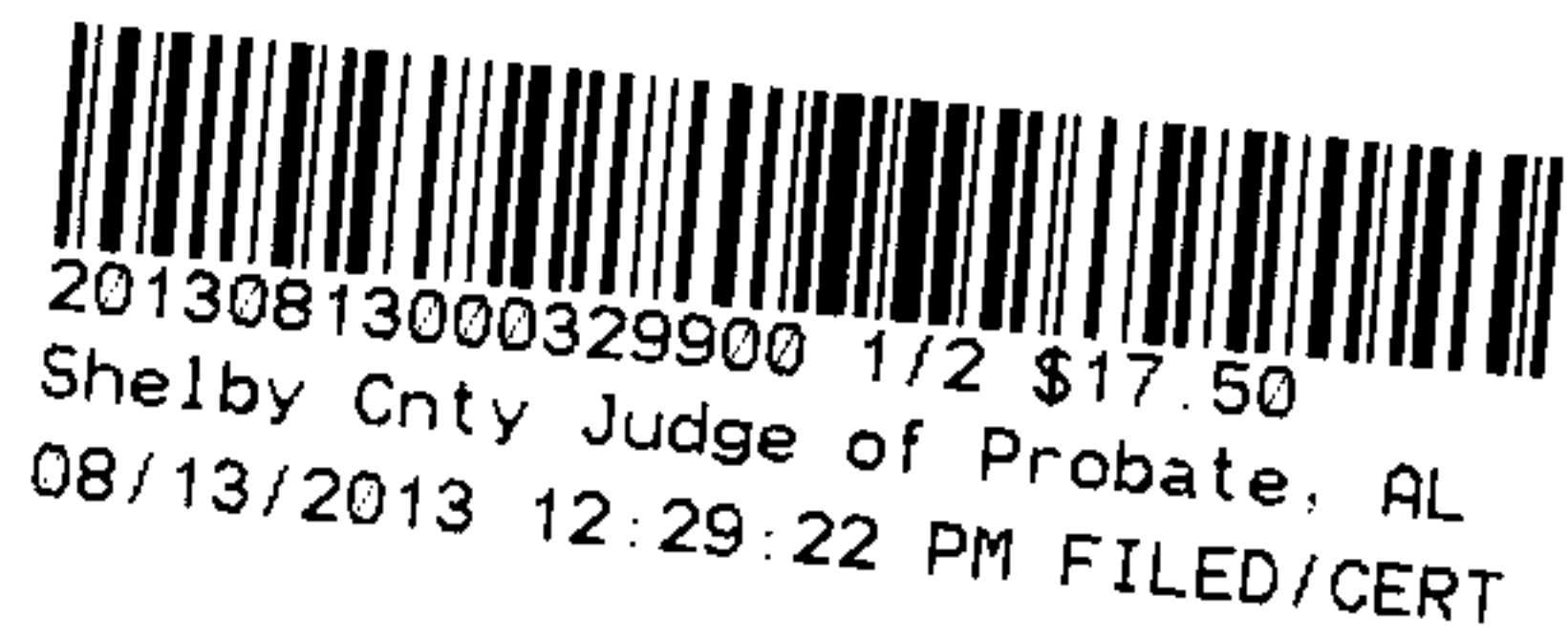

**WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of the sum of Fifty Thousand And No/100 Dollars (\$50,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Charles E. Bates, a married man (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Penny Young and George Young (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 1, according to the Final Plat of Bates Estates, as recorded in Map Book 43, Page 99, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.


\$49,500.00 of the consideration recited herein is from the proceeds of a purchase money mortgage of even date herewith.



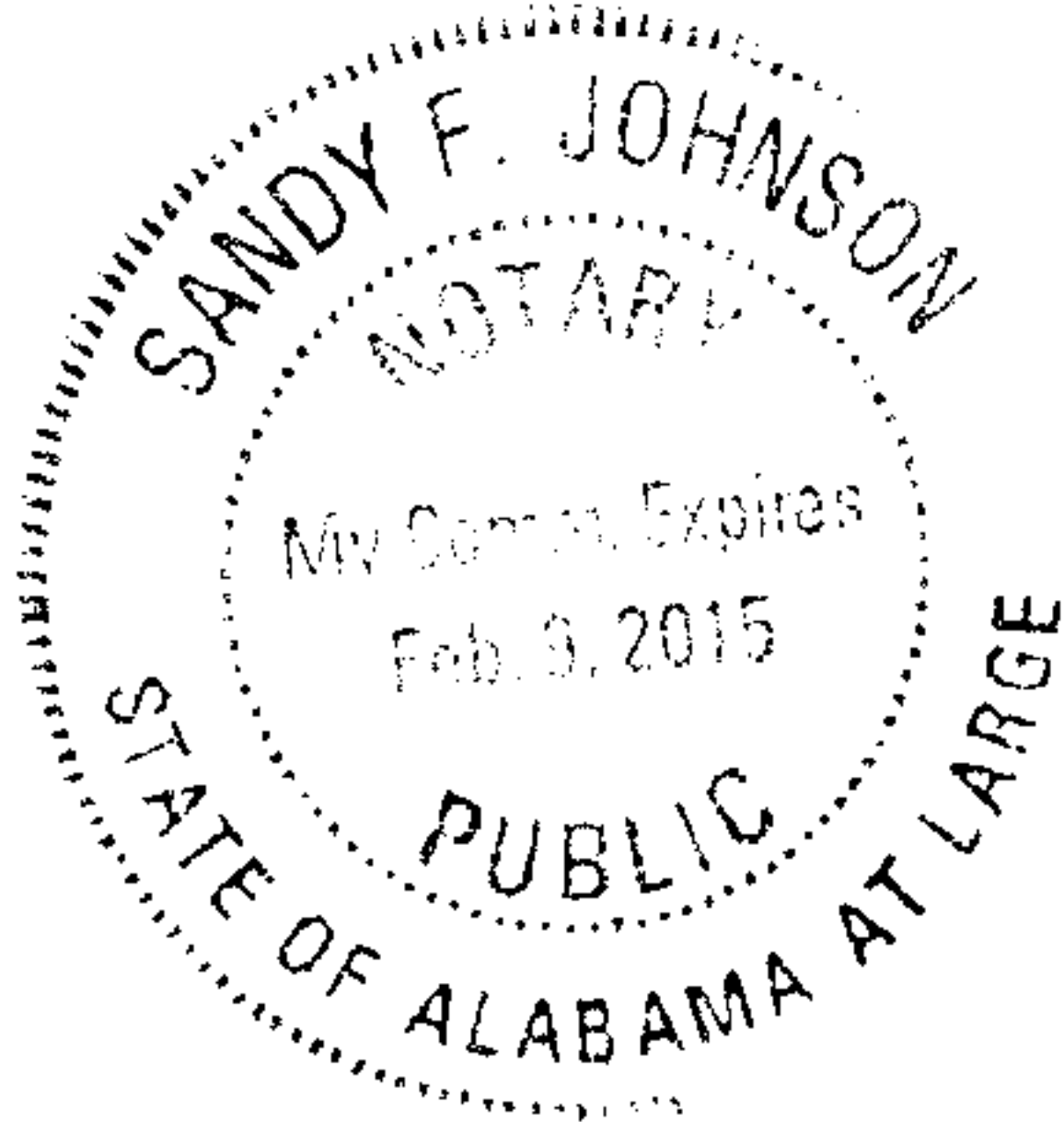
