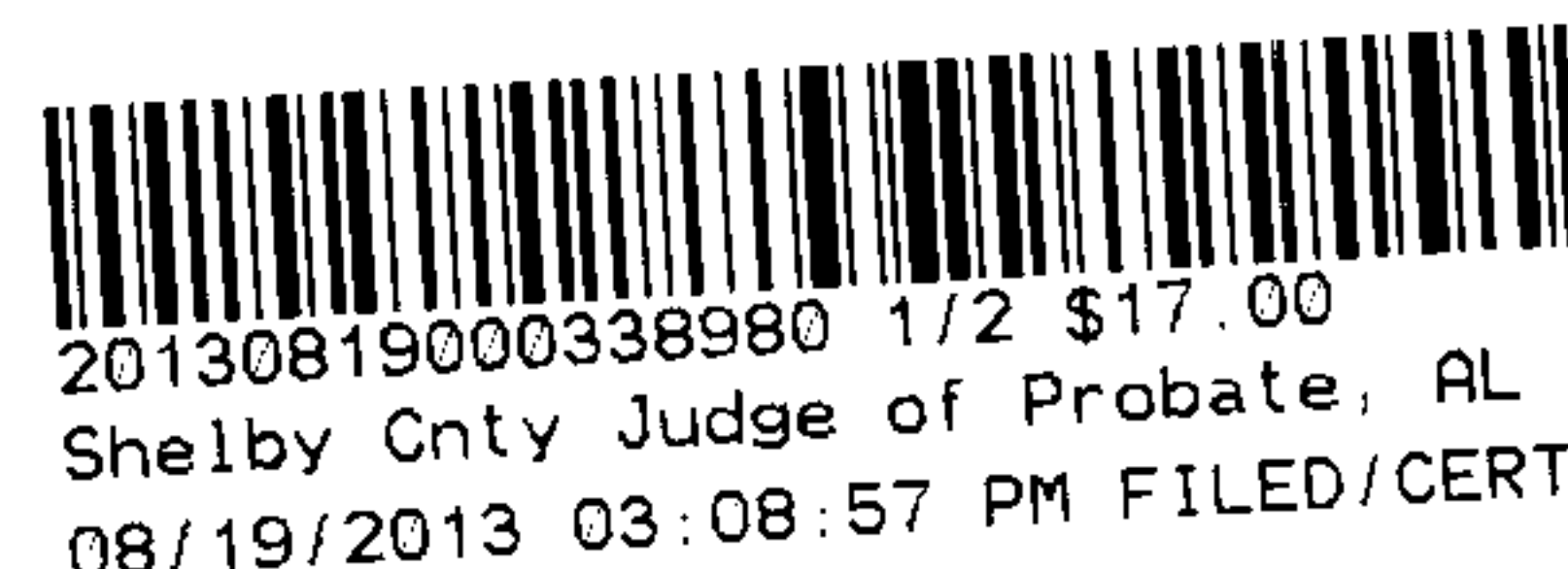

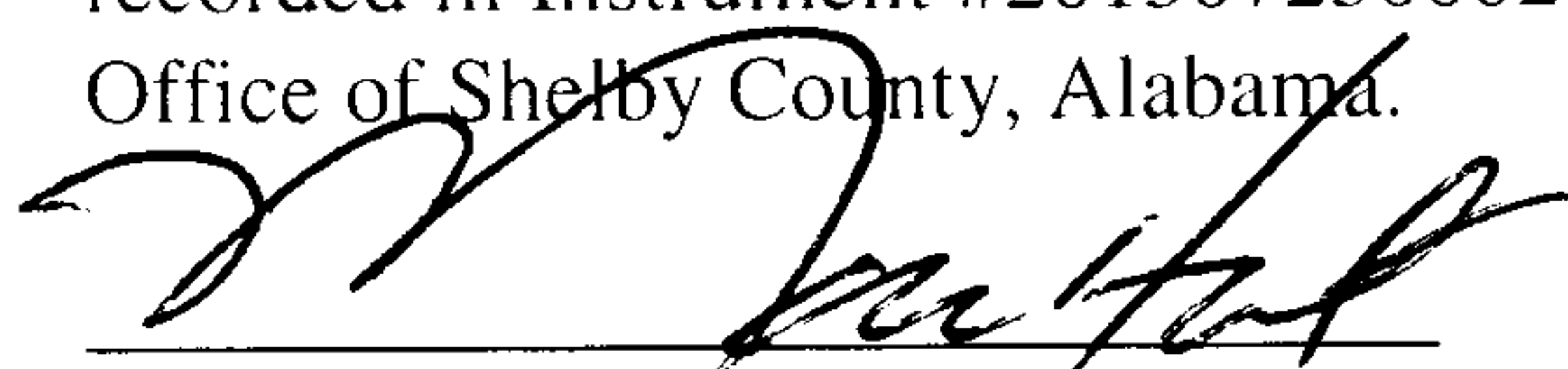
SCRIVENERS AFFIDAVIT

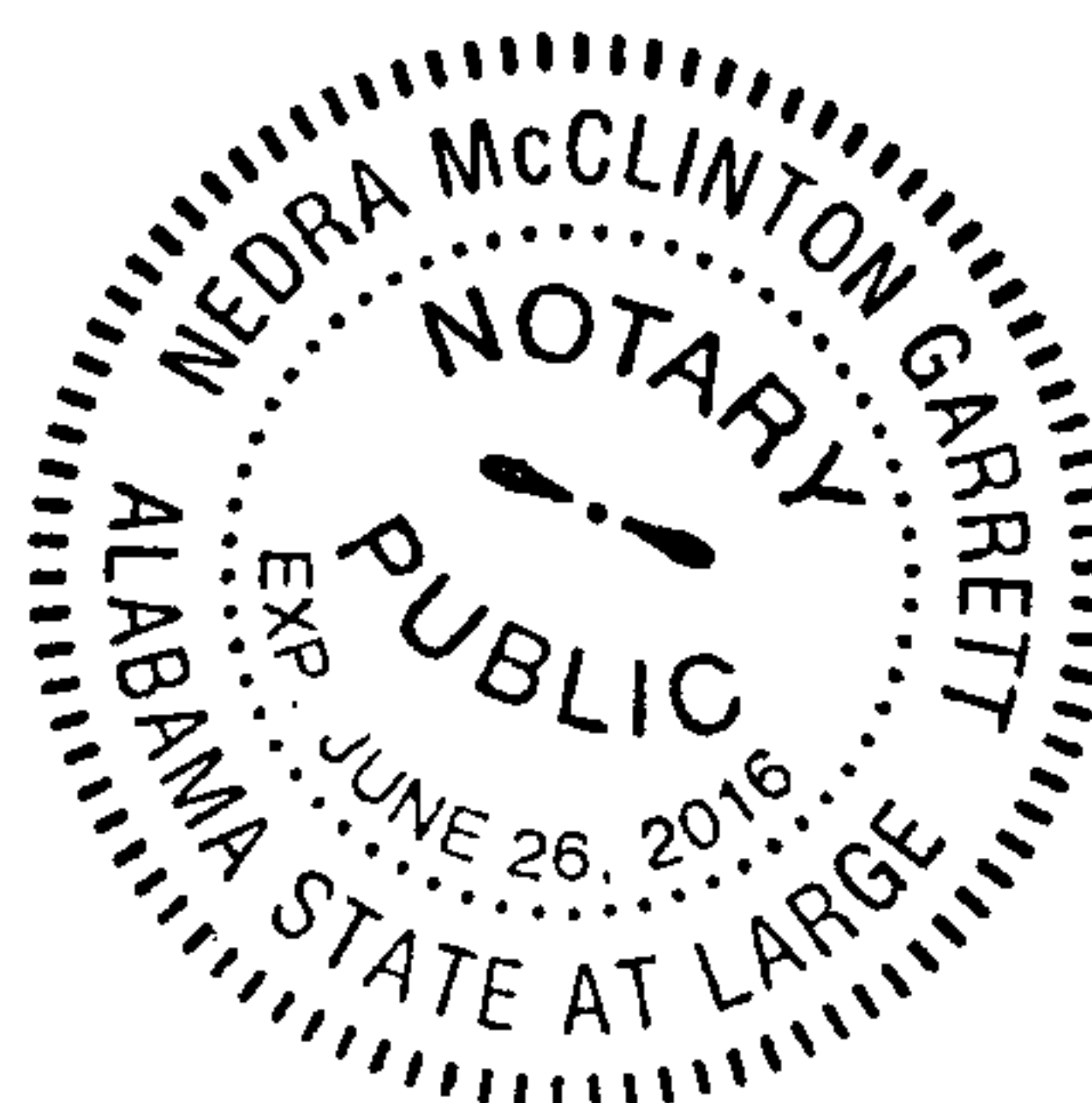

Parcel I:

A parcel of land in the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 27, Township 20 South, Range 4 West, Shelby County, Alabama, as follows:

Commence at the southwest corner of said $\frac{1}{4}$ $\frac{1}{4}$ section, thence run North 89 degrees 34 minutes 19 seconds East along the South $\frac{1}{4}$ $\frac{1}{4}$ line a distance of 663.35 feet to the point of beginning: thence continue last described course 221.07 feet, thence North 00 degrees 00 minutes 51 seconds East a distance of 642.13 feet to the centerline of Shelby County Highway #277, thence run North 88 degrees 40 minutes 36 minutes West a distance of 86.96 feet along said centerline to the point of a clockwise curve having a delta angle of 41 degrees 04 minutes 53 seconds and a radius of 137.23 feet, thence run along the arc of said curve 98.39 feet, thence run North 47 degrees 35 minutes 42 seconds West and tangent to said curve along the centerline of said road 61.61 feet, thence run South 00 degrees 02 minutes 45 seconds East 723.20 feet to the point of beginning.
