**FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 27th day of February, 2009, Dawn E Forman, a single person, executed that certain mortgage on real property hereinafter described to ELITE HOME MORTGAGE, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument Number 20090302000074580, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, NA ("Transferee"), by instrument executed on July 16, 2009 and recorded on October 1, 2009 as Instrument Number 20091001000373970, in the aforesaid Probate Office; and


