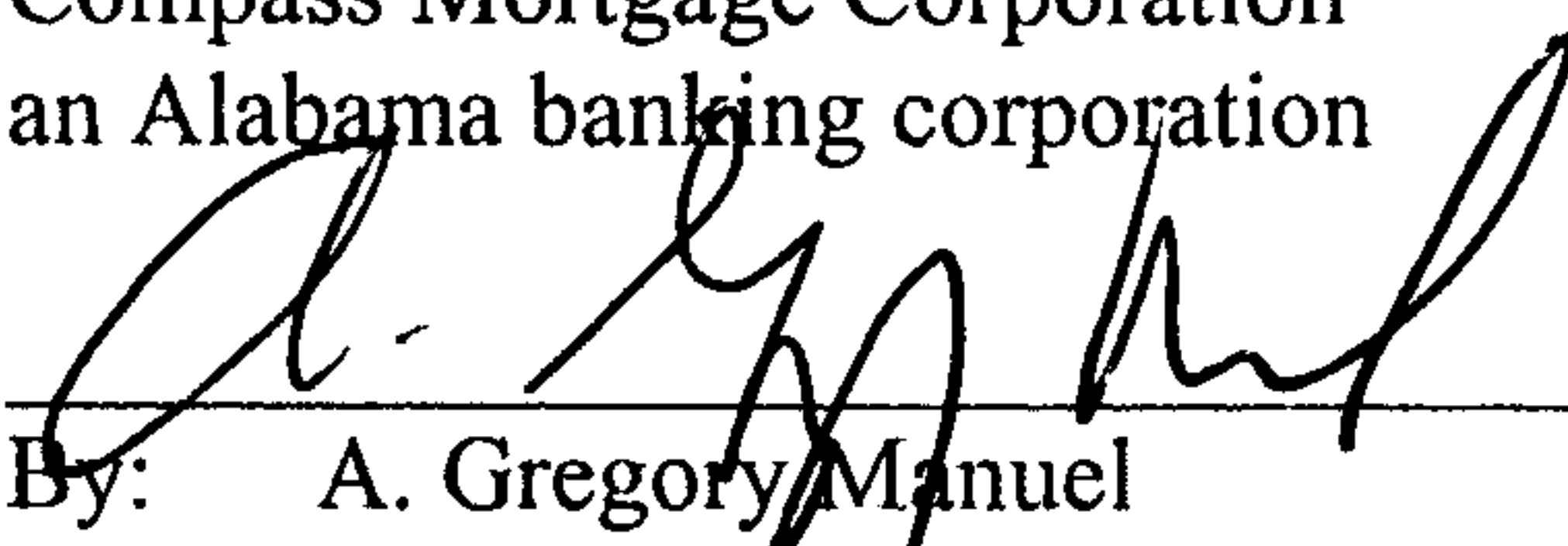
EXHIBIT A
