KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of February, 2006, Patrica H. Lewis, unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Freeland, Flinders, and Assoc., LLC., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060303000100490, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, National Association, by instrument recorded in Instrument Number 20120221000061570, in the aforesaid Probate Office ("Transferee"); and

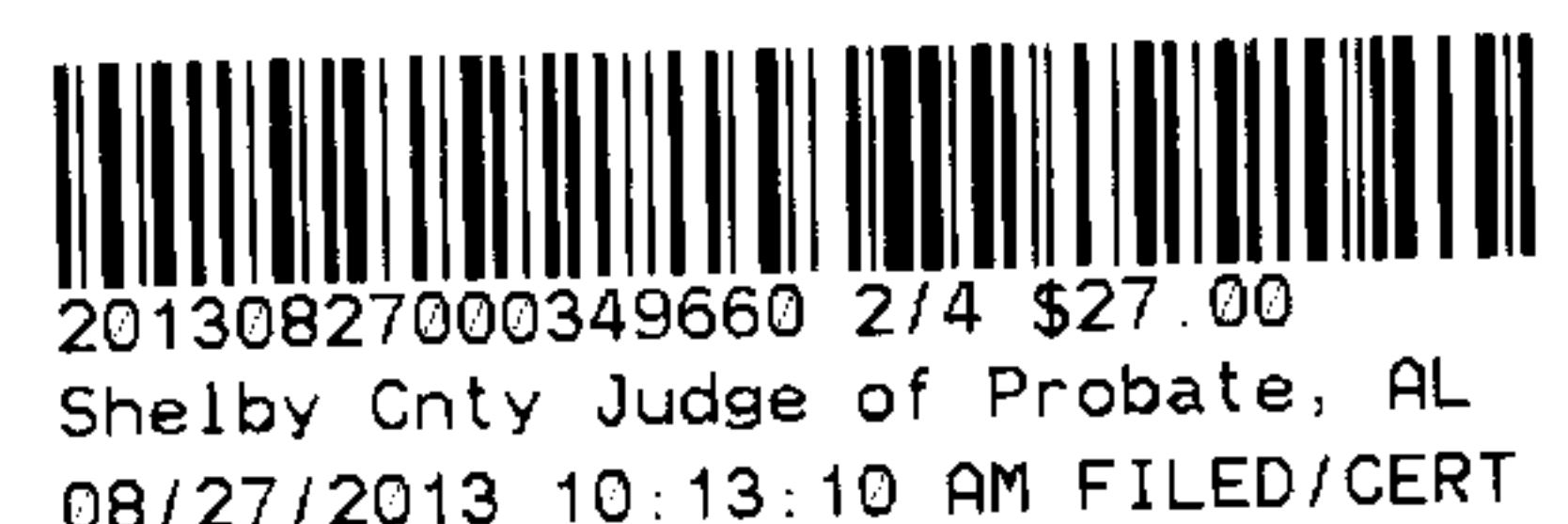

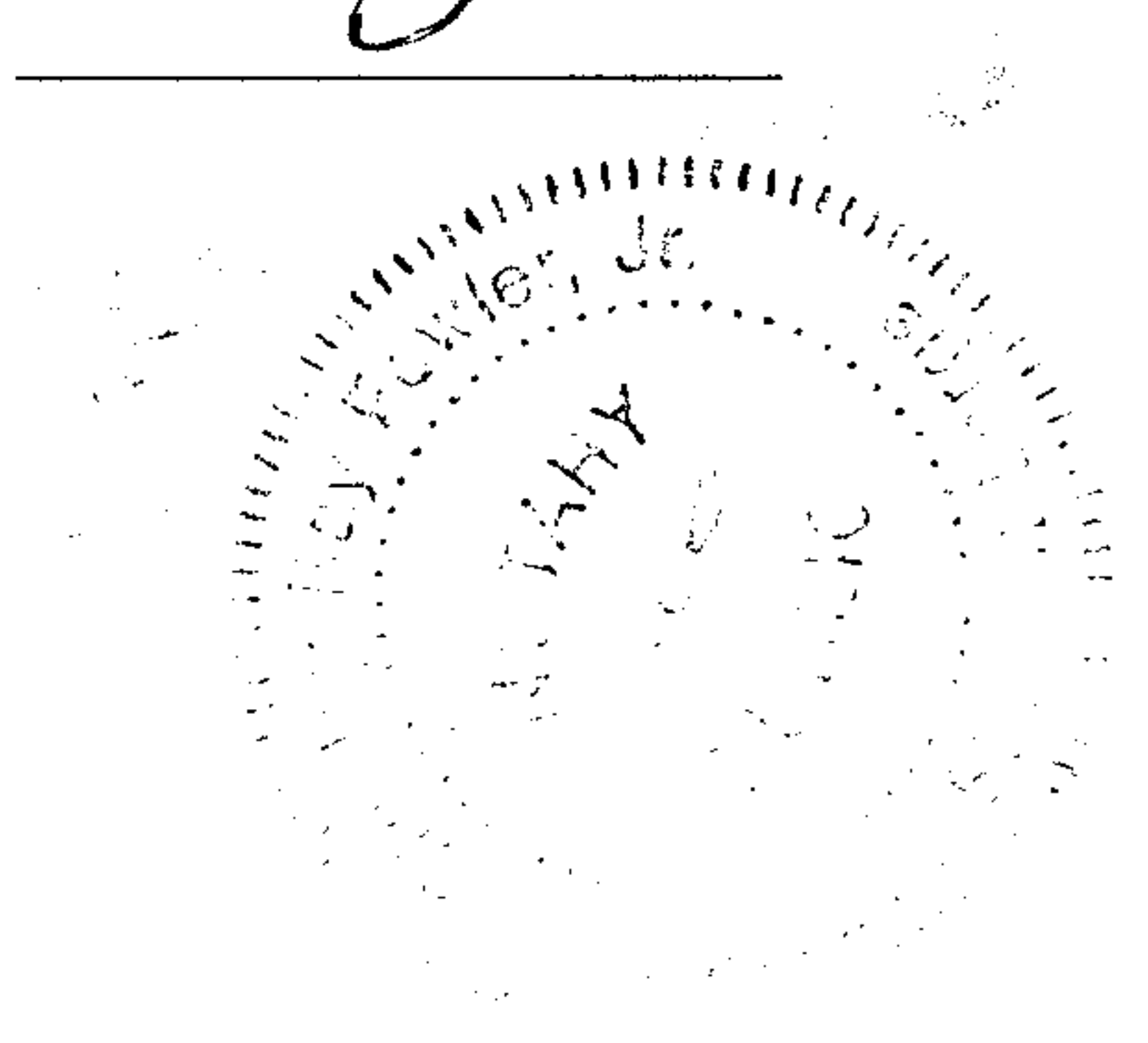
