KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of May, 2008, Stacey Bailey, a married person and Chris Bailey, a married person, executed that certain mortgage on real property hereinafter described to Homeservices Lending, LLC Series A DBA Mortgage South, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080609000232060, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 20080609000232070, in the aforesaid Probate Office ("Transferee"); and

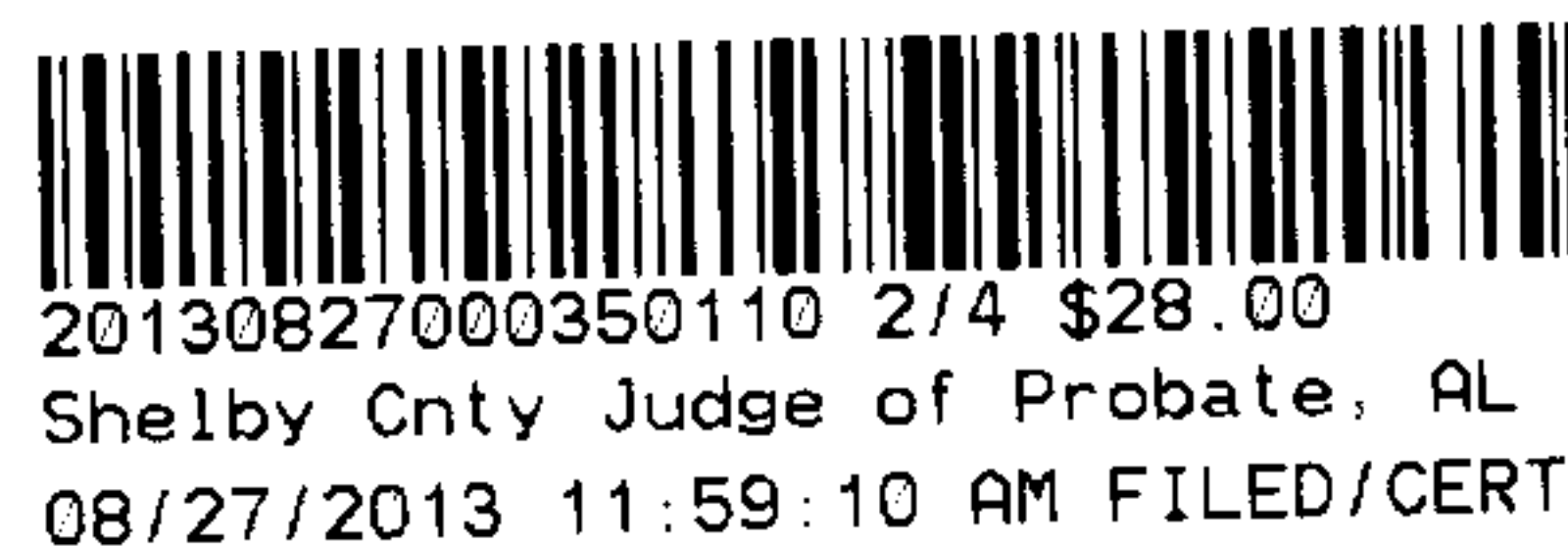
