WHEREAS, heretofore, on, to-wit: the 28th day of October, 2005, Alice L. Lyons, and husband Robert L. 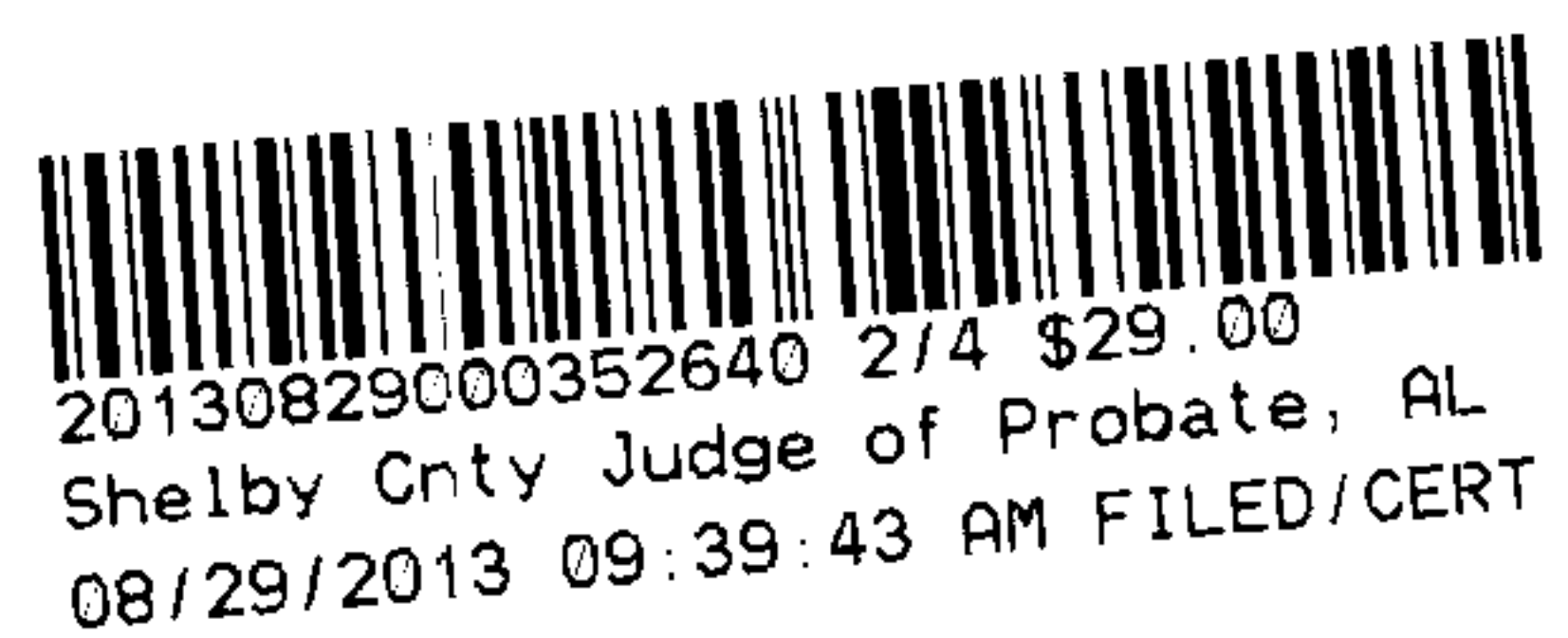
