Roberts and Joe K. Roberts, wife and husband** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEE, **Dale Ward Whatley, a single individual**, (hereinafter referred to as GRANTEE), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 415, according to the Survey of Weatherly Belvedere, Sector 23, as recorded in Map Book 21, Page 16 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama. Mineral and mining rights excepted.


Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.



\$55,000.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.
