WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,

On this September 4, 2013, That for and in consideration of ONE HUNDRED THIRTY ONE THOUSAND AND NO/100 (\$131,000.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS ROBERT A. MCELROY and CATHERINE B. MCELROY, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEE, SYLVIA SHEFFIELD, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantors' interest in the following-described Real Estate situated in, SHELBY COUNTY, ALABAMA, to wit:

Subject to:
