Cates, and wife, Debby Cates**, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Jeffrey E. Devine and Rebecca G. Devine**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 248, Sector 2, according to the Survey of The Woodlands, Sector 2, 4, and 5, as recorded in Map Book 29, Page 99, in the Probate Office of Shelby County, Alabama.

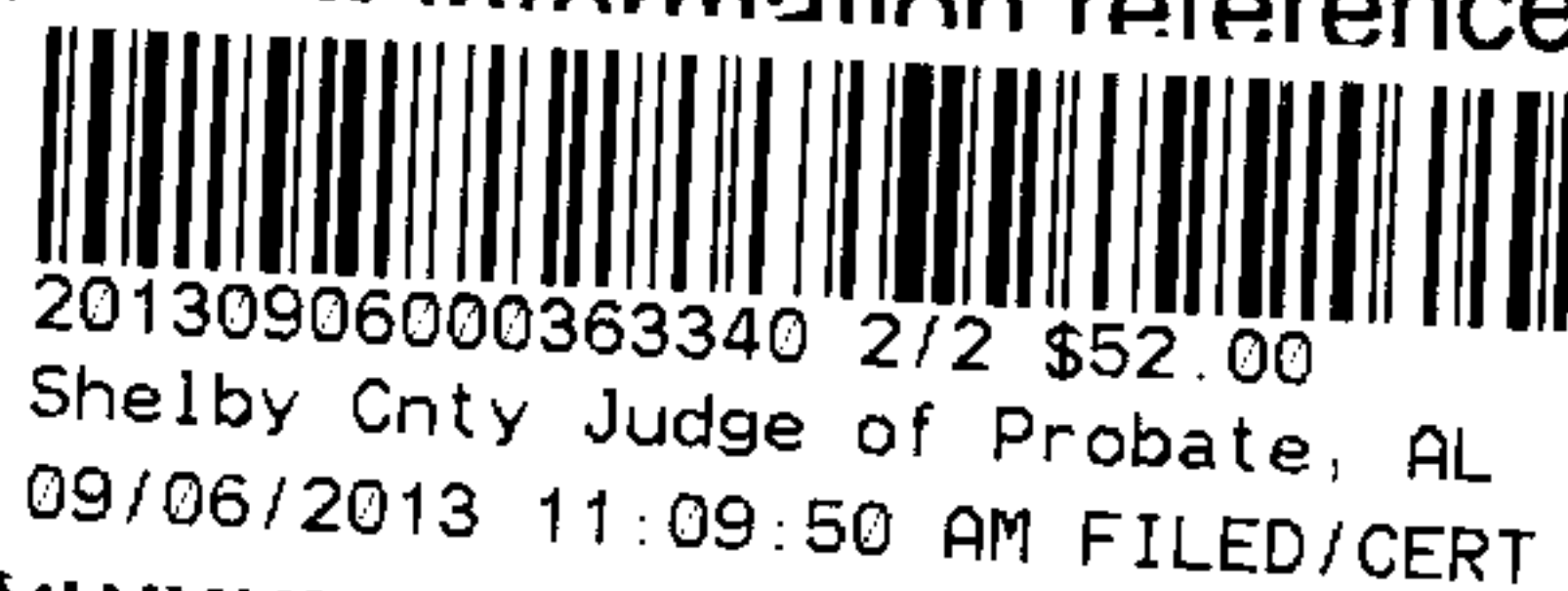
