

DOMESTIC NONPROFIT CORPORATION AMENDMENT TO FORMATION/ARTICLES

PURPOSE: In order to amend a Nonprofit Corporation's Certificate of Formation/Articles of Incorporation under Section 10A-3-4.02 and 10A-1-3.13 of the <u>Code of Alabama 1975</u> this Amendment and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the corporation was initially formed/incorporated.

INSTRUCTIONS: Mail one (1) signed original and two (2) copies of this completed form and the appropriate filing fees to the Office of the Judge of Probate in the county where the corporation's Certificate of Formation was recorded. Contact the Judge of Probate's Office to determine the county filing fees. Make a separate check or money

order payable to the Secretary of State for the state filing fee of \$50.00 for standard processing or \$150.00 if expedited processing within 3 business days of receipt by the Office of the Secretary of State is requested (10A-1-4.31) and the Judge of Probate's Office will transmit the fee along with a certified copy of the Amendment to the Office of the Secretary of State within 10 days after the filing is recorded. Once the Secretary of State's Office has indexed the filing, the information will appear at www.sos.alabama.gov under the Government Records tab and the Business Entity Records link – you may search by entity name or number. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment (see attached). Your Amendment will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.



- The updated website was launched in December 2011. Appreciation goes to Cliff McArdle, Chase McLain and Flex Digital for this improved information and recruiting tool.
- The Gannett-Estes Library was chosen by the International Society for Science and Religion to receive of a 224 volume science and spirituality collection.

Advancement report was presented as part of the President's report:

- Cliff McArdle resigned January 2012 to accept a position at Bellhaven University.
- On Cliff's recommendation, we contracted with Mr. Jack Eyer, CEO of Giving Ventures, to assist the College in development. We were already working with Jack to provide estate design consulting for donors of the College.
- Jack Eyer prepared 49 foundation grant applications that have been submitted.
- A listing of Foundations and their officers was distributed. If you know any of these officers, please let Dr. Hawkins know. Personal contacts help significantly when requesting funds from a foundation.

Trustee Board Business

The Board reviewed the minutes from the previous board meeting of December 8, 2011 ACTION: The Board voted to approve the minutes of the Board meeting December 8, 2011

Doctrinal Statement (attachment #4): Dr. Hawkins discussed the recommended change to the Doctrinal Statement that would add a clarifying statement on human sexuality, the sanctity of marriage and the sanctity of human life. It is believed that this wording would add a level of protection should legal action be brought against the College over any of these issues.

- A question was asked, is there a difference between a policy statement and a statement of faith? Being as the statement of faith is in the incorporation documents, it is felt that this would provide a greater level of protection vs. being just a policy statement.
- Concern was voiced over the second part of the statement that followed "Therefore".

ACTION: The Board voted and the motion to change the doctrinal statement failed (lacking sufficient votes to approve)

A follow-up motion was made to include only the first portion of the suggested change in the doctrinal statement and that a committee be formed to review whether or not the balance of the statement should be added, changed or continue to be left out.

ACTION: The Board voted to approve the follow-up motion with one person voting against it.

The following is the portion approved to be added to the Doctrinal Statement. To be added after #12. It reads as follows:

"That Scripture provides God's design and instruction regarding the sanctity of human life, human sexuality and marital relationships; and as such, all human life is sacred and valuable from conception to natural death; and that sexual intimacy is to be reserved for marriage between one man and one woman; and that upon conception one's gender is sovereignly determined by God to be an inherent personal attribute." (Gen. 1:27,28; 2:18-25; Psalm 139:13-16; Eph. 5:22-33)

DOCTRINAL STATEMENT

We believe:

- (1) That the Bible, consisting of the sixty-six books of the Old and New Testaments, in the original manuscripts, is the inerrant and complete Word of God, the final authority in all matters of faith and practice (II Timothy. 3:16-17; II Peter 1:20-21).
- (2) That there is one God, eternally existing in three persons: The Father, Son, and Holy Spirit (Deuteronomy 6:4; Matthew 28:19; Luke 3:21-22).
- (3) That the Lord Jesus Christ is the only begotten Son of God, conceived by the Holy Spirit, born of the Virgin Mary, and is true God and true man (Luke 1:30-35; John 1:18; 3:16; Philippians 2:5-11).
- (4) That man was created in the image of God; that he sinned and, thereby, incurred not only physical death, but also spiritual death which is separation from God and that, as a consequence, all men are declared by God to be totally depraved, having inherited a sinful nature and having become sinners in thought, word, and deed (Genesis 1:26-27; 2:16-17; 3:6-19; Romans 3:10-13; 6:3; 7:18; 11:32; Galatians 3:22).
- (5) That the Lord Jesus Christ died as a substitutionary and complete sacrifice for the sins of the whole world and that only those who trust in His redemptive work are saved on the ground of His shed blood (Romans 3:24-28; 5:8-10; I Timothy 2:5-6; I John 2:1-2).
- (6) That the Lord Jesus Christ arose from the dead in the same body, though glorified, in which He was crucified; that He ascended into Heaven, and He is now exalted at the right hand of the Father as Head of the Church (John 20:1-29; Acts 1:9-11; Ephesians 1:20-23; Hebrews 1:3).
- (7) That the Lord Jesus Christ will come again personally and bodily; that first He will come in the air prior to the seven year Tribulation, hence at any moment, to receive the Church, His body, unto Himself in heaven; and that following the literal fulfillment of the Great Tribulation spoken of by the prophets, He will return visibly to the earth with His saints to inaugurate His millennial kingdom of universal peace and righteousness (Acts 1:11; I Thessalonians 4:13-18; I Corinthians 15:51-58; II Peter 3:1-13; Revelation 19:11-16; 20:16).
- (8) That both the believer and the unbeliever will be resurrected bodily in their own order; the saved unto everlasting bliss; the lost unto everlasting and conscious punishment

- (I Corinthians 15:1-20; I Thessalonians 4:13-18; Revelation 20:11-15; 21:22).
- (9) That on the sole condition of personal faith in the Lord Jesus Christ, men are born again by the Holy Spirit; that at regeneration, all believers in this age are also indwelt by the Holy Spirit, baptized by the Holy Spirit into the Body of Christ, and sealed by the Holy Spirit unto the day of redemption (Romans 3:24-28 8:9-11; I Corinthians 12:13; Ephesians 4:30).
- (10) That sanctification, which is separation unto God, is threefold: positionally, the believer was sanctified at his conversion by virtue of his union with Christ; progressively, he is continually being sanctified through the Word as he walks in the Spirit, thereby overcoming lusts of the flesh and producing the fruit of the Spirit; and, ultimately, he will be completely conformed to the image of Christ when he sees his Savior face to face (John 17:17; Ephesians 5:26; Colossians 3:14; Hebrews 10:14; I John 3:13).
- (11) That the Church is the Body of Christ composed of all who are born again during this church age, that began at Pentecost and will be terminated at the rapture of the church; that this church universal is to gather together as local churches or assemblies after the pattern of New Testament doctrine and practice, including the observance of the ordinances of water baptism and the Lord's supper; and that God performs the ministry of His church through its members to whom He has given gifts for the purpose of edifying the body of Christ (Acts 2:1-47; Romans 12:18; I Corinthians 11:23-24; I Corinthians 12:1-31; Ephesians 1:22-23).
- (12) That the Great Commission was given to the Church and that the task of world evangelism is the mission of the Church today (Matthew 28:18-20; Romans 10:9-17; Ephesians 4:7-16).
- (13) That Scripture provides God's design and instruction regarding the sanctity of human life, human sexuality and marital relationships; and as such, all human life is sacred and valuable from conception to natural death; and that sexual intimacy is to be reserved for marriage between one man and one woman; and that upon conception one's gender is sovereignly determined by God to be an inherent personal attribute. (Gen. 1:27, 28; 2:18-25; Psalm 139:13-16; Eph. 5:22-33)
