KNOW ALL MEN BY THESE PRESENTS, That in consideration **SEVENTY SIX THOUSAND AND NO/00 DOLLARS (\$76,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, ***Thomas R. Carlisle and wife, Maxine Yuille Carlisle*** (herein referred to as ***Grantor***) grant, bargain, sell and convey ***Thomas R. Carlisle and Maxine Yuille Carlisle*** (herein referred to as ***Grantees***), the following described real estate, situated in: **SHELBY County, Alabama, to-wit:**

Lot 70, according to the Survey of Emerald Ridge, Sector II, as recorded in Map Book 38, Page 112, in the Office of the Judge of Probate of Shelby County, Alabama.

SUBJECT TO:
