KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 2nd day of June, 2005, Susan Barr, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050608000280010, said mortgage having subsequently been transferred and assigned to Green Tree Servicing, LLC, by instrument recorded in Instrument Number 20130711000283120, in the aforesaid Probate Office ("Transferee"); and

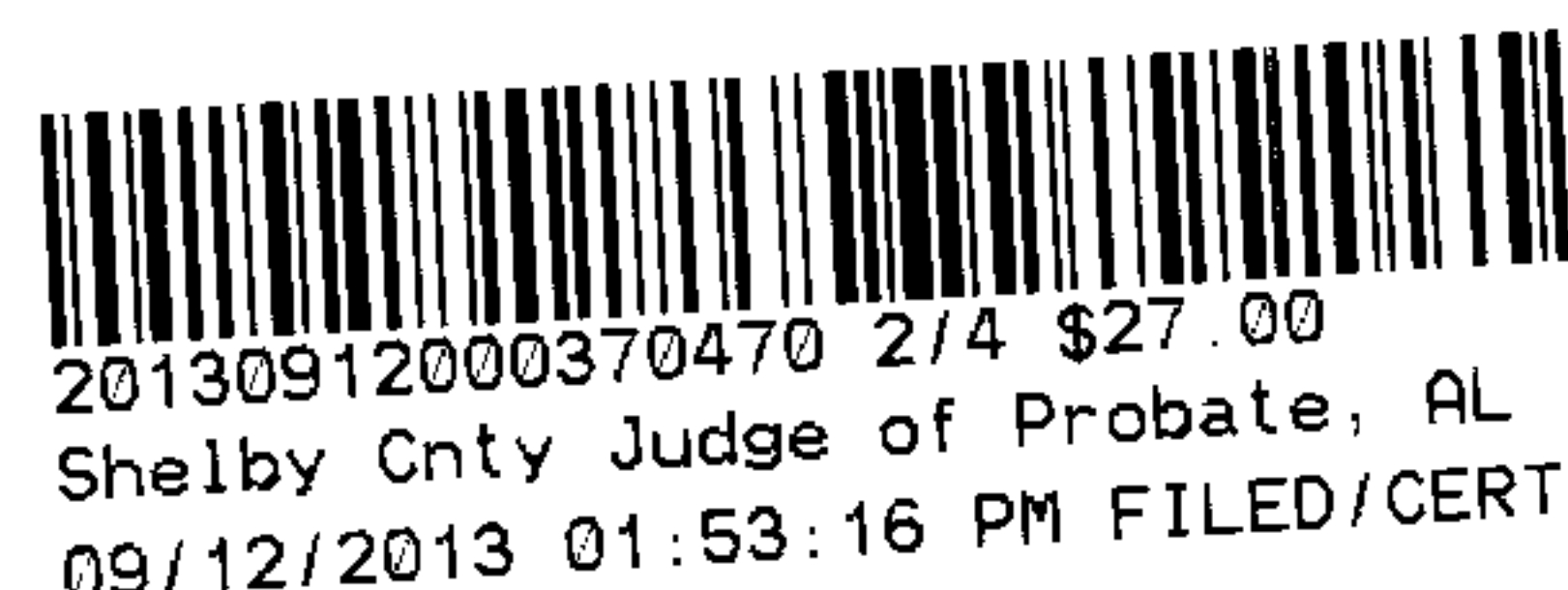

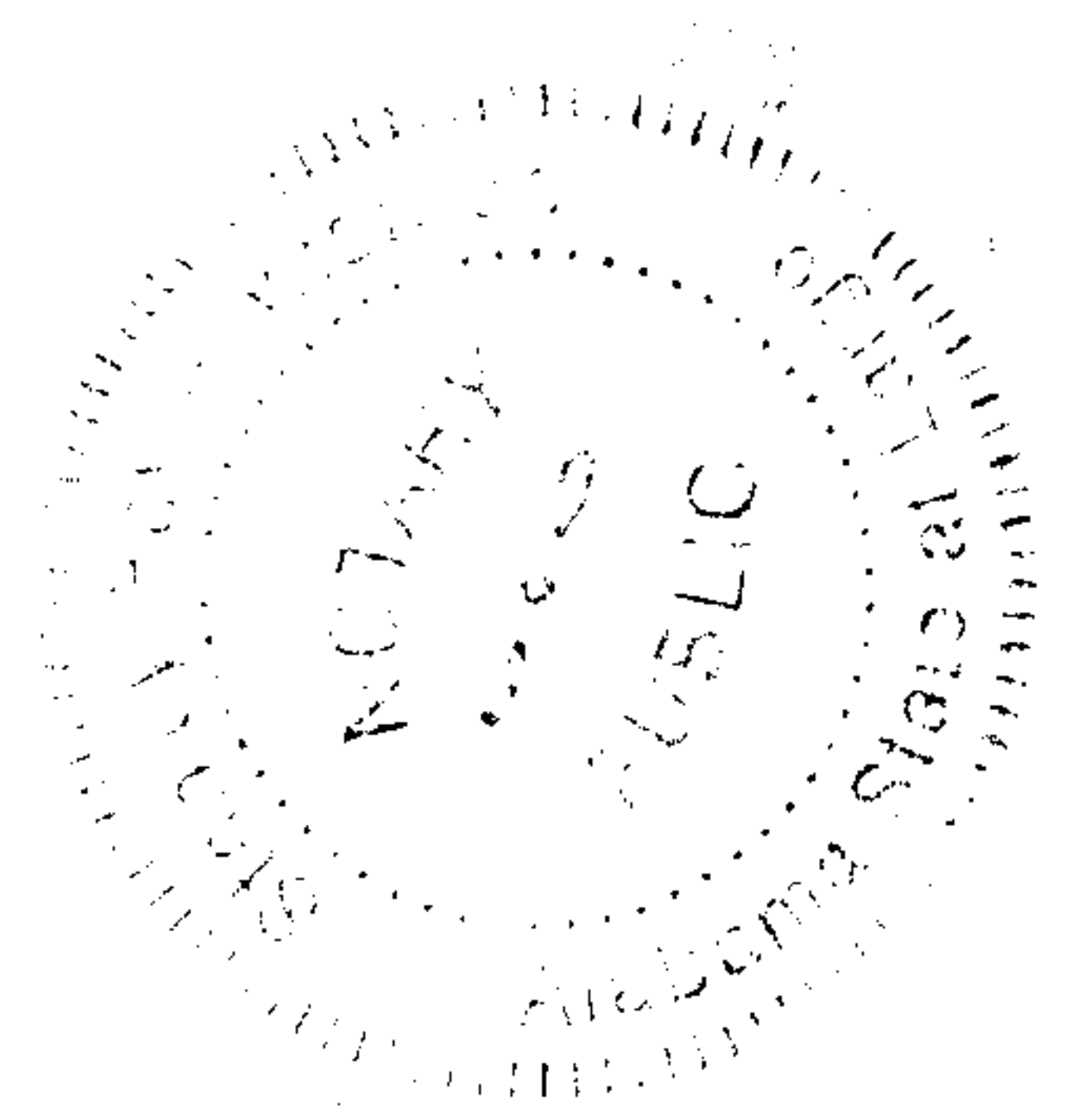
