KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 25th day of July, 2005, Kelly J. Grantham, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument Number 20050802000390410, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, NA ("Transferee"), by instrument executed on May 10, 2011 and recorded on May 13, 2011 as Instrument Number 20110513000144210, in the aforesaid Probate Office; and

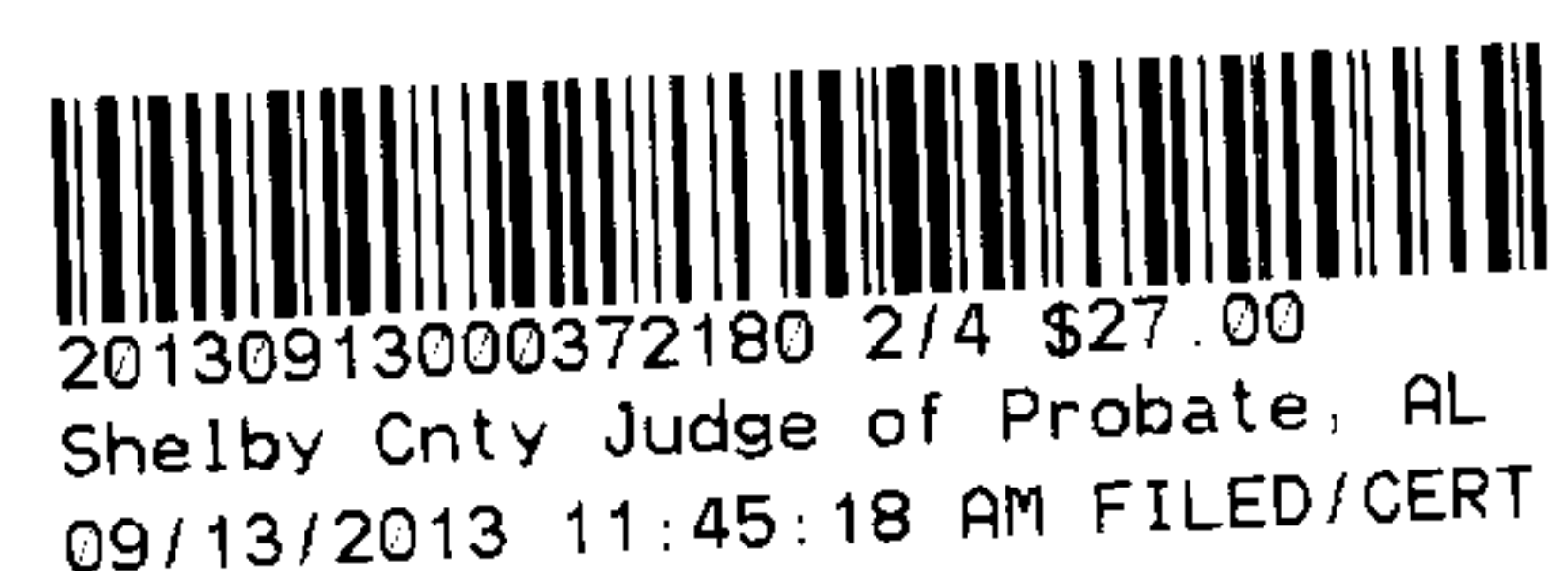
WHEREAS, Tarryn Troutman Jordaan was the auctioneer and the person conducting the sale for said Wells Fargo Bank, NA; and


