

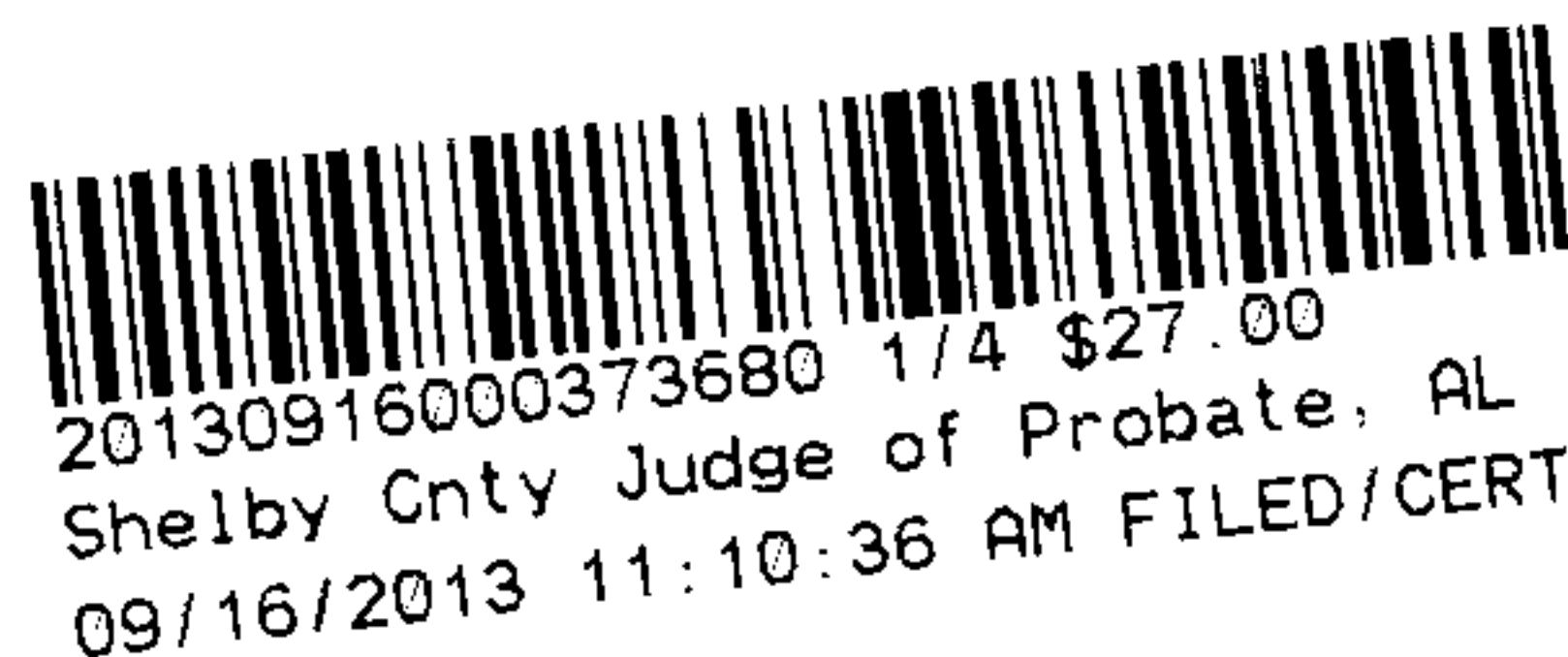

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of July, 2007, Angie Anderson, a single person, executed that certain mortgage on real property hereinafter described to Homeservices Lending, LLC Series A d/b/a Mortgage South, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070810000376480, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 20070810000376490, in the aforesaid Probate Office ("Transferee"); and

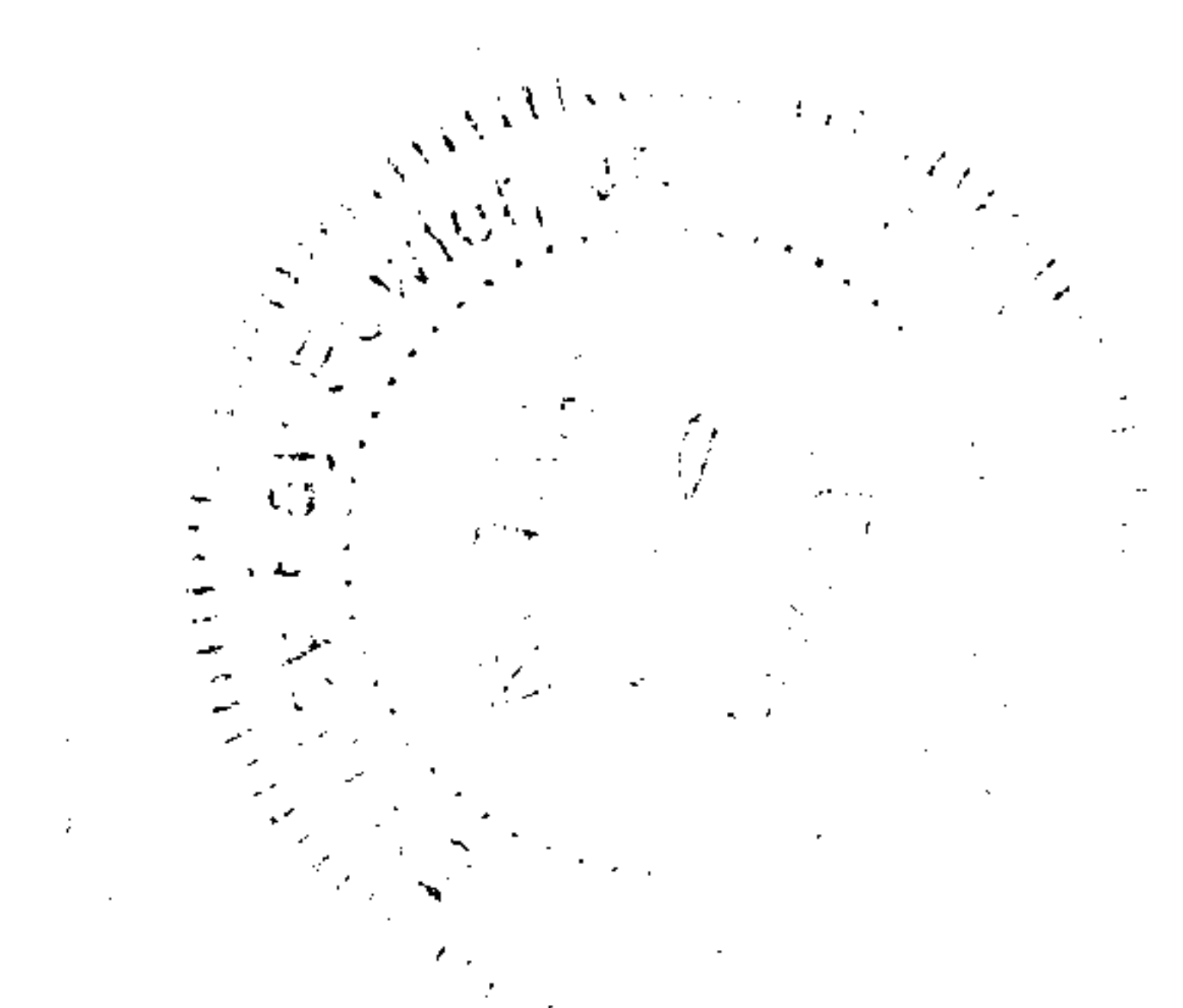
