} KNOW ALL MEN BY THESE PRESENTS,

SHELBY COUNTY

That in consideration of Twenty Eight Thousand dollars and Zero cents (\$28,000.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Howard Baer, a single man (herein referred to as grantors) do grant, bargain, sell and convey unto Sam N. Meredith and Eleanor D. Meredith (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Begin at the NW corner of Block 261, Dunstan’s Map of Calera; thence run South along the East ROW of 16th Street for 123.43 feet; thence run South 86 degrees 46 minutes 33 seconds East for 70.00 feet; thence run North 0 degrees 8 minutes 55 seconds West for 125.55 feet to a point on the South ROW of 20th Ave. (Smith Street); thence run West 70.00 feet to the point of beginning. Being part of Block 261, Dunstan’s Map of the Town of Calera, Alabama. Situated in Shelby County, Alabama.

Subject to taxes for 2013 and subsequent years, easements, restrictions, rights of way, and permits of record.

TO HAVE AND TO HOLD, Unto the said GRANTEES as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.

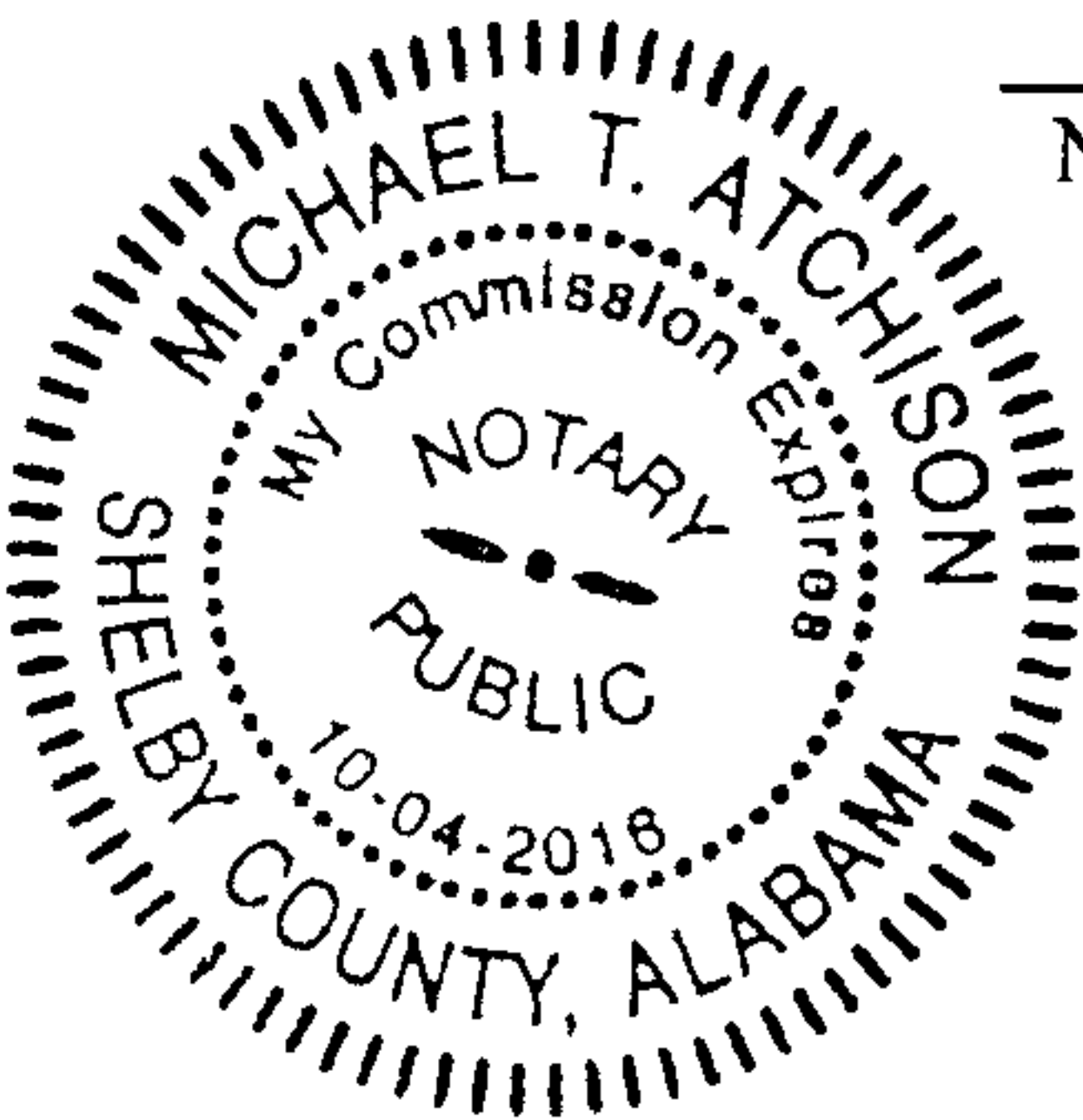

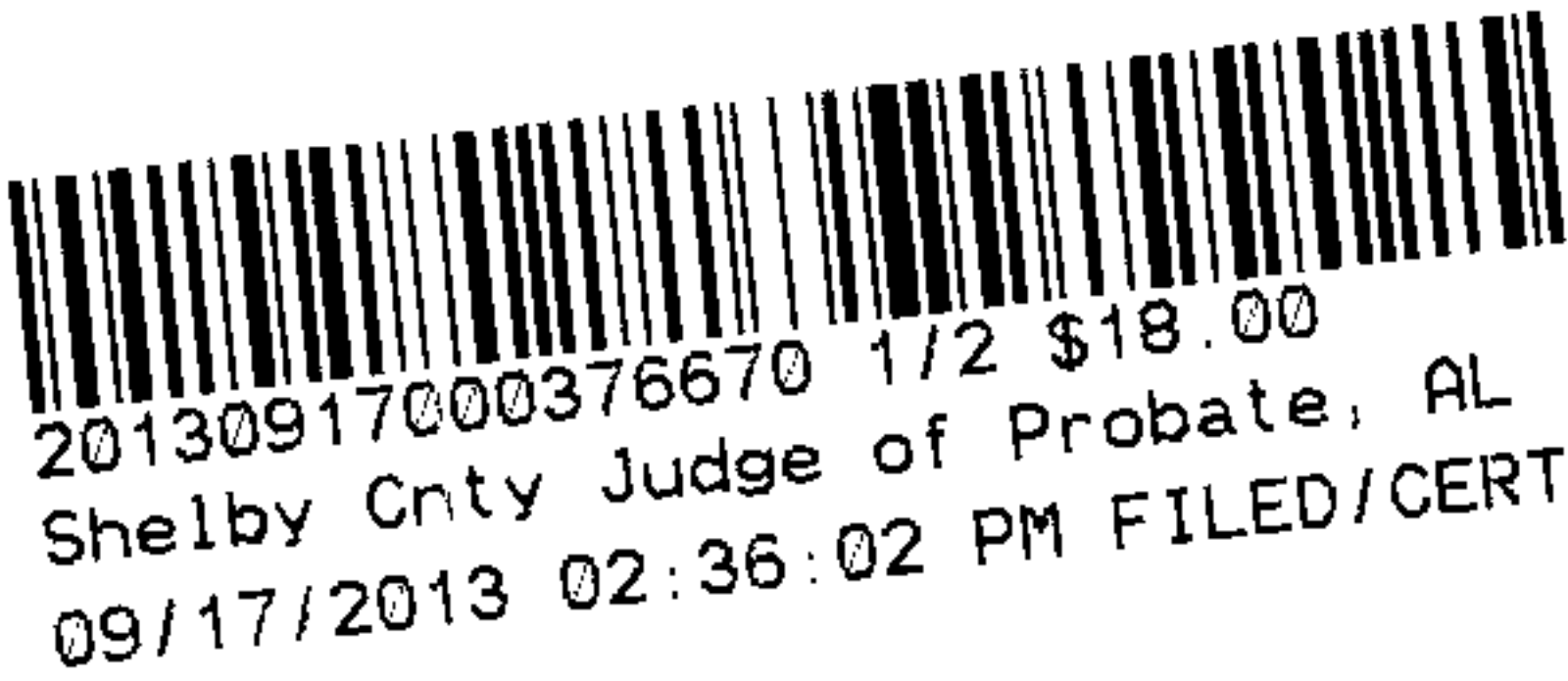
