Johnson and wife, Betty J. Johnson (herein referred to as grantors) do grant, bargain, sell and convey unto Gerald R. Cornelius, Jr. and Susan A. Cornelius (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

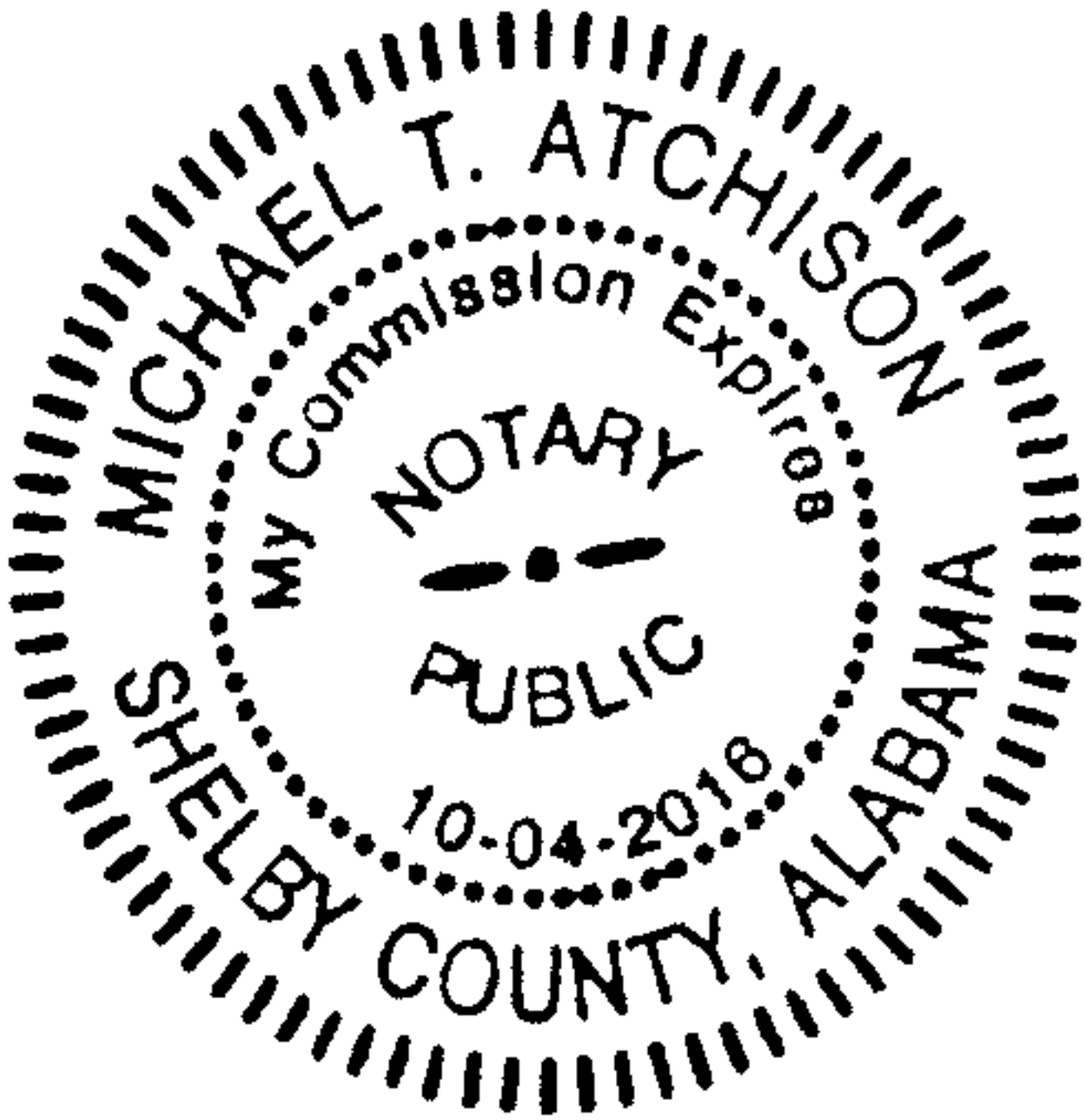
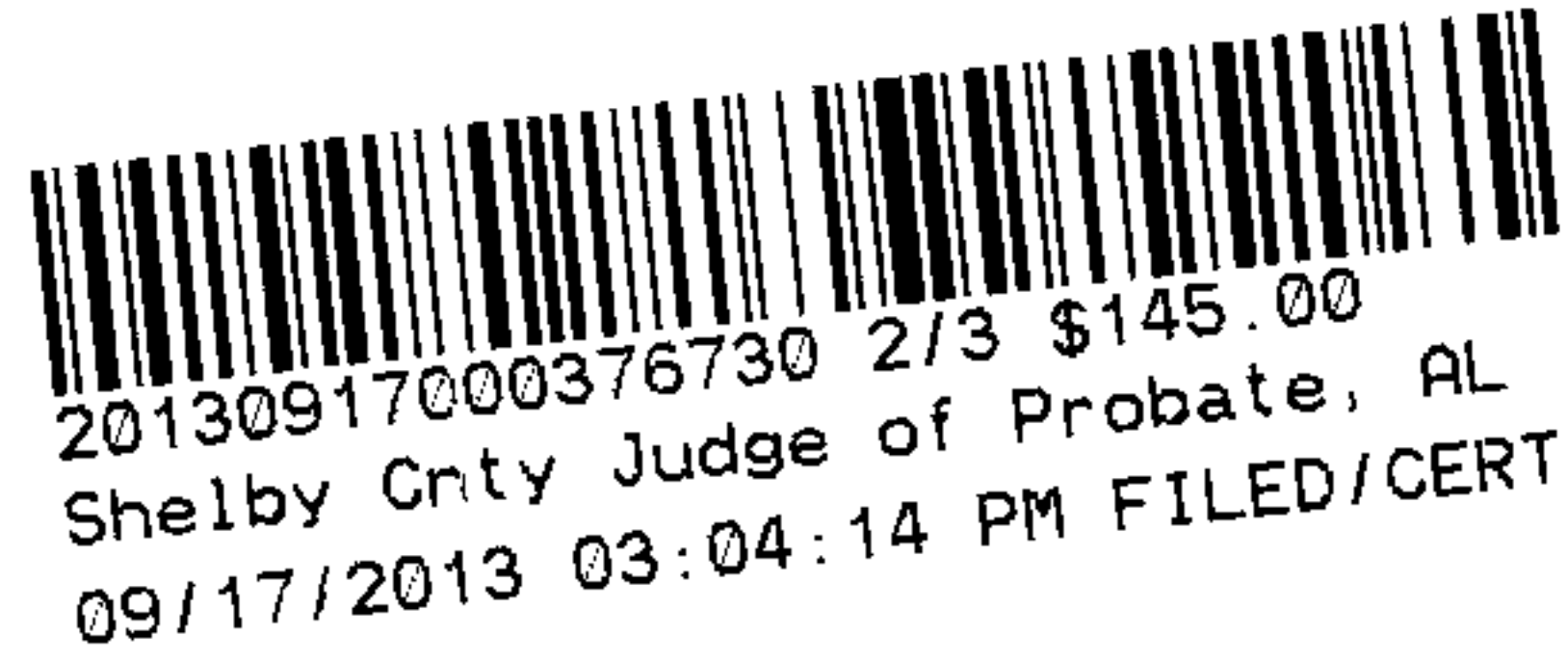


EXHIBIT A
