KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of September, 2010, Allison B. Elliott, a married man, executed that certain mortgage on real property hereinafter described to Signature Home Mortgage, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20101005000328640, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Inst. 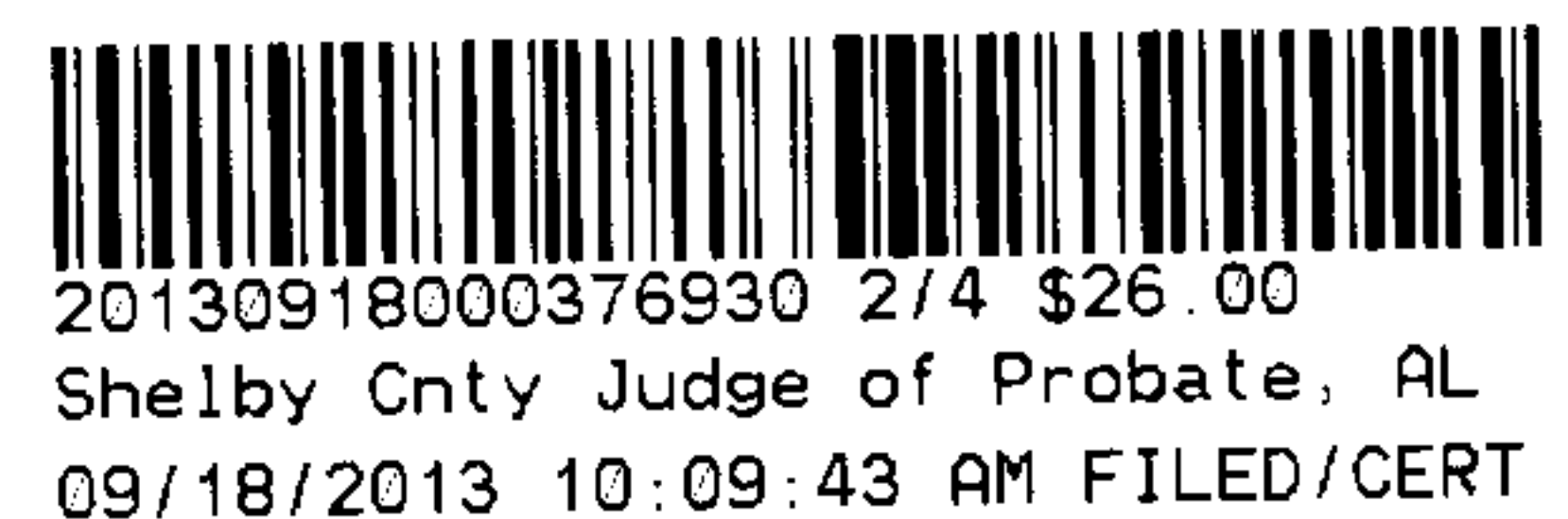

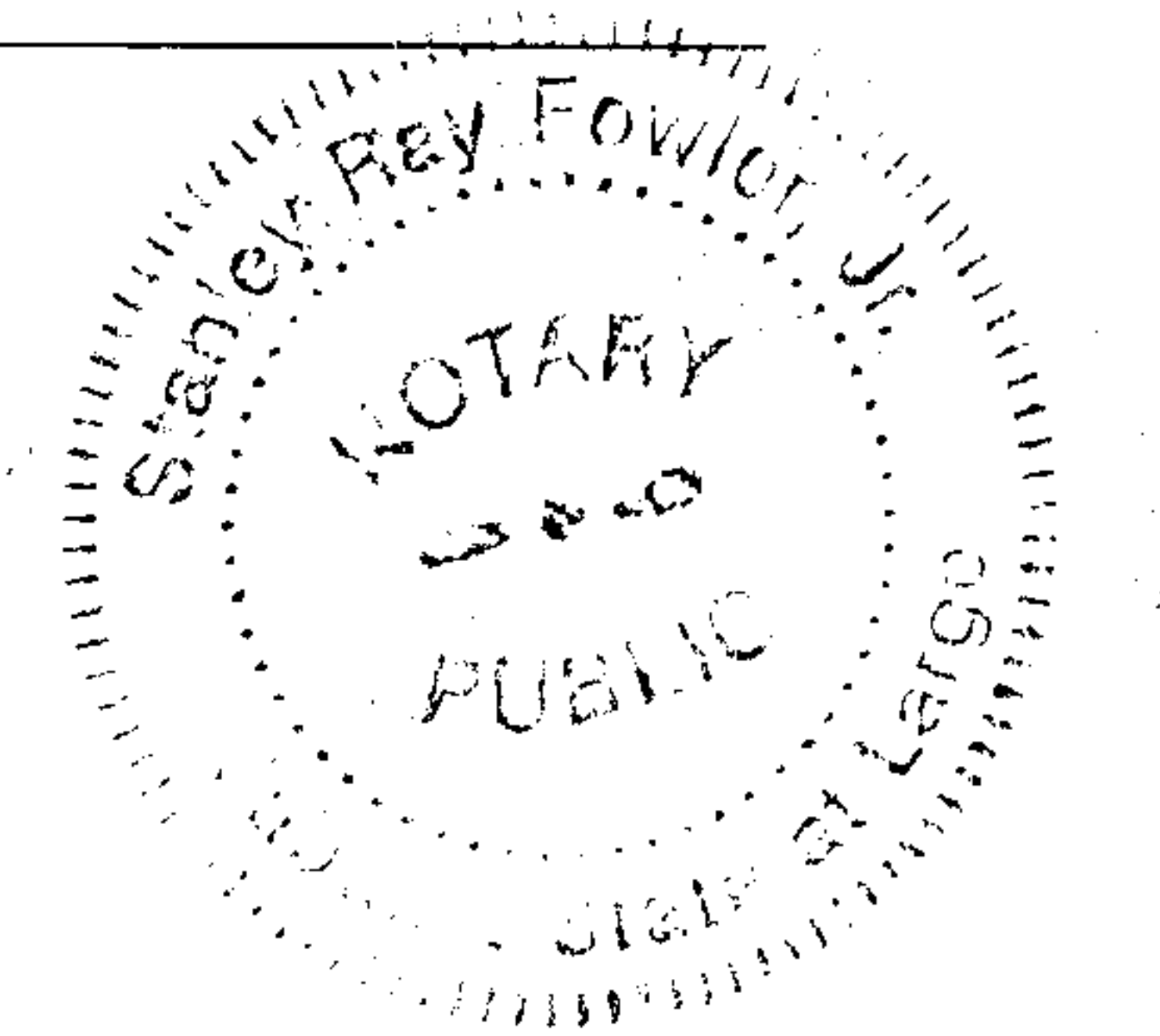
