**ARTICLES OF ORGANIZATION**

**OF**

**DLS TRUCKING, LLC**

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama (1975), as amended (the Alabama Limited Liability Company Act), hereby file the following Articles of Organization with the Probate Judge of the county in which the initial registered agent of the limited liability company will be located and affirm that the facts stated in the Articles of Organization are true and correct.

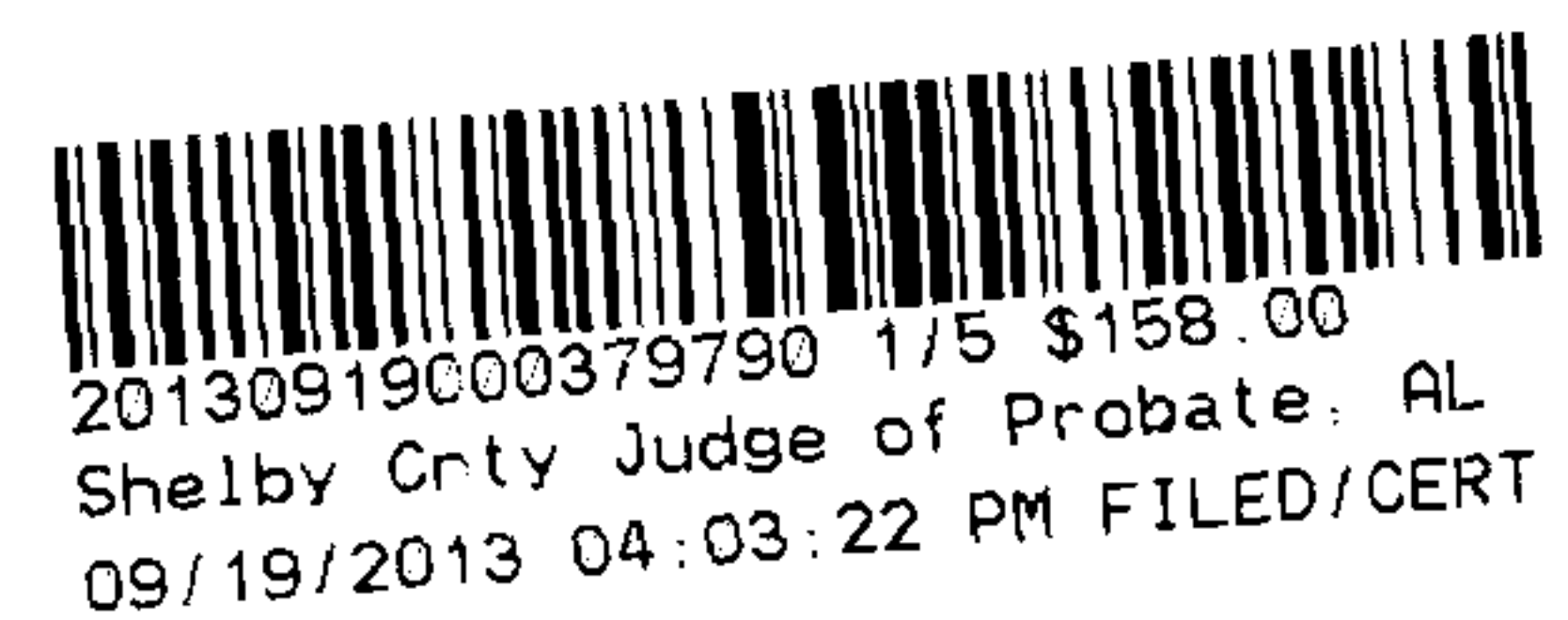
**ARTICLE I**  
**NAME**

The name of the limited liability company is DLS TRUCKING, LLC (hereinafter referred to as the "Company").

**ARTICLE II**  
**DURATION**

The period and duration of the Company shall be from the date of the filing of these Articles of Organization with the Office of the Probate Judge of Shelby County, Alabama until the first to occur of the following:

- (a) Dissolution of the Company pursuant to the laws of the State of Alabama or the operating agreement of the Company, as in effect from time to time; or
- (b) Upon the written unanimous consent of all members of the Company.



### **ARTICLE III**

#### **PURPOSE**

The purpose for which the corporation is organized are as follows:

(a) To carry freight for hire; to receive and load all varieties of freight on board highway motor vehicles; to transport such freight to various destinations throughout the United States of America; to buy, sell and otherwise in and with tractors and trailers suitable for commercial trucking, and to maintain and repair same; and to contract and otherwise perform residential, governmental and commercial industrial projects.

(b) To buy, sell, lease, and rent any real property whether developed or undeveloped.

(c) To do any and all things herein set out and such other things as are incidental or conducive to the attainment of the objects and purposes of this corporation, to the same extent as natural persons might or could do and in any part of the world, as principle, factor, agent, contractor, or otherwise either alone or in conduction with any person, firm, association, corporation or any entity of whatsoever kind, and to do any and all such acts and things and to exercise any and all such powers and engage in the transactions of any and all lawfully business to full extent authorized or permitted to a corporation under any laws that may be now or hereafter applicable or available to this corporation under the Alabama Business Corporation Act.

### **ARTICLE IV**

#### **REGISTERED OFFICE AND REGISTERED AGENT**

The location and mailing address of the initial registered office of the Company shall be 515 El Camino Real, Chelsea, Alabama 35043 and the name of the initial registered agent at such address shall be Betsy Strazewski.
