The business of the limited liability company shall be to engage in running a haunted house and any other lawful business, and other businesses and investments.

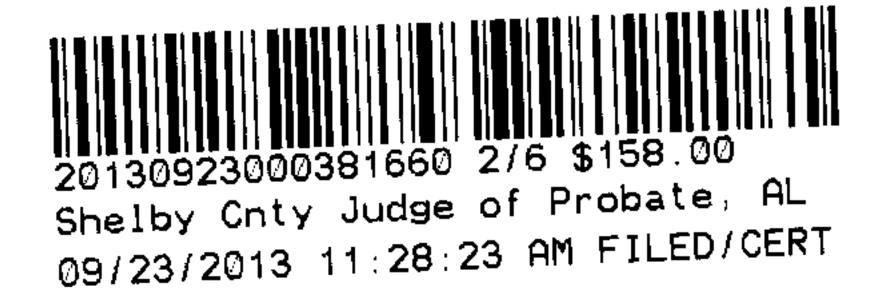

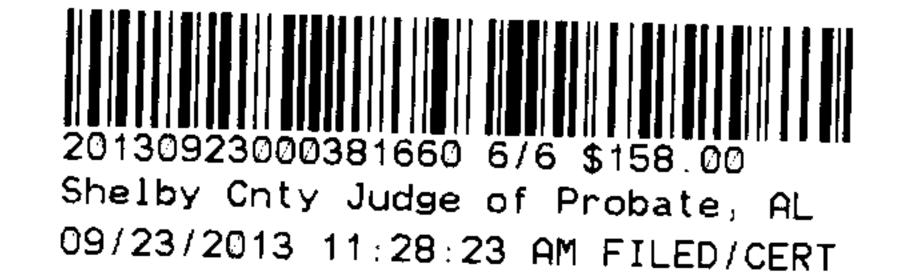
