Once the Secretary of State's Office has indexed the filing the information will appear at www.sos.alabama.gov under the Government Records tab and the Business Entity Records link – you may search by entity name. Your notification of filing was provided by the Probate Judge's Office via a stamped copy and the Secretary of State's Office does not send out a copy. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment (see attached). Your entity will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.





ARTICLES OF ORGANIZATION

OF



BLACKOUT ENTERTAINMENT, LLC

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A LIMITED LIABILITY COMPANY (hereinafter "Company") pursuant to the provisions of the Alabama Limited Liability Company Act (hereinafter "LLC Act"), do hereby adopt the following Articles of Organization:

ARTICLE I

The name of the Company is:

BLACKOUT ENTERTAINMENT, LLC

ARTICLE II

The existence of the Company shall commence on the date of the filing of these Articles or Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue until December 31, 2065; *provided*, *however*, that the Company shall be dissolved prior to such date upon the earlier to occur of (i) the written consent of all the members to dissolve the Company; (ii) as provided in the Operating Agreement; or (iii) as may be required under the LLC Act.

ARTICLE III

The purposes for which the Company is organized are:

- (a) marketing and entertainment production services; and
- (b) to engage in any lawful act or activity for which limited liability companies may be organized.

ARTICLE IV

The location of the Company is 385 Woodward Court, Birmingham, AL 35242, Shelby County and the mailing address of the initial registered office of the Company in the State of Alabama is PO Box 382434, Birmingham, AL 35238-2434 and the name of its initial registered agent at such address is E. Kirk Wood.

ARTICLE V

The names and mailing addresses of the initial members of the Company are as follows:

Edward K. Wood, III, 385 Woodward Court, Birmingham, AL 35242.

ARTICLE VI

The Company shall admit additional members only upon the terms and conditions set forth in the Operating Agreement.

ARTICLE VII

The Members of the Company shall have the right to continue its business after an event of dissociation terminates the continued membership of a member in the company if (i) there are at least two remaining members or at least one remaining member and a new member is admitted, and (ii) the legal existence and business of the Company is continued by the written consent of all the remaining members within 90 days after the occurrence of such event of dissociation.

ARTICLE VIII

The Company shall be managed by the members.
