

ARTICLES OF ORGANIZATION OF DONOHOO CHEVROLET, LLC

The undersigned, being the members of Donohoo Chevrolet, LLC, a limited liability company formed pursuant to Section 10-12-1 et. seq. of the Alabama Code, as amended, adopt the following Articles of Organization for such company:

ARTICLE I: The name of the Limited Liability Company is Donohoo Chevrolet, LLC.

ARTICLE II: The term of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall have a perpetual duration; provided, however, that the Limited Liability Company shall be dissolved: (a) upon the written consent of the holders of the portion of the ownership interest of the company specified in the Operating Agreement, as amended from time to time; (b) as provided in the Operating Agreement, as amended from time to time; or (c) as may be required by the Alabama Limited Liability Company Act, as amended from time to time.

ARTICLE III: The purposes for which the Limited Liability Company is organized are to: (i) own and manage an automobile sales and service dealership; and (ii) to transact such other business as may be permitted under the laws of the State of Alabama.

ARTICLE IV: The street address of the initial registered office of the Limited Liability Company is 8122 Helena Road, Pelham, Alabama 35124, and the name of its initial registered agent at such address is Peter Scott Donohoo.

ARTICLE V: The names and addresses of the initial members of the Limited Liability Company are as follows:

ARTICLE VI: The Limited Liability Company shall be managed by its members, whose addresses are shown above.

ARTICLE VII: The members of the Limited Liability Company shall have no right to admit additional members, except in accordance with the Operating Agreement, as amended from time to time.

ARTICLE VIII: The cessation of membership of a member will not result in the dissolution of the Company.

ARTICLE IX: The Limited Liability Company elects to be governed by the amendments to Chapter 12 of Title 10 of the Code of Alabama adopted by and set forth in Act No. 97-920, as permitted by Section 2 of said Act.
