KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of September, 2004, Rebecca Watts, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Alabama Home Mortgage Lending, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040927000532410, said mortgage having subsequently been transferred and assigned to Kondaur Capital Corporation, as Separate Trustee of Matawin Ventures Trust Series 2012-3, by instrument recorded in Instrument Number 20130717000290050, in the aforesaid Probate Office ("Transferee"); and

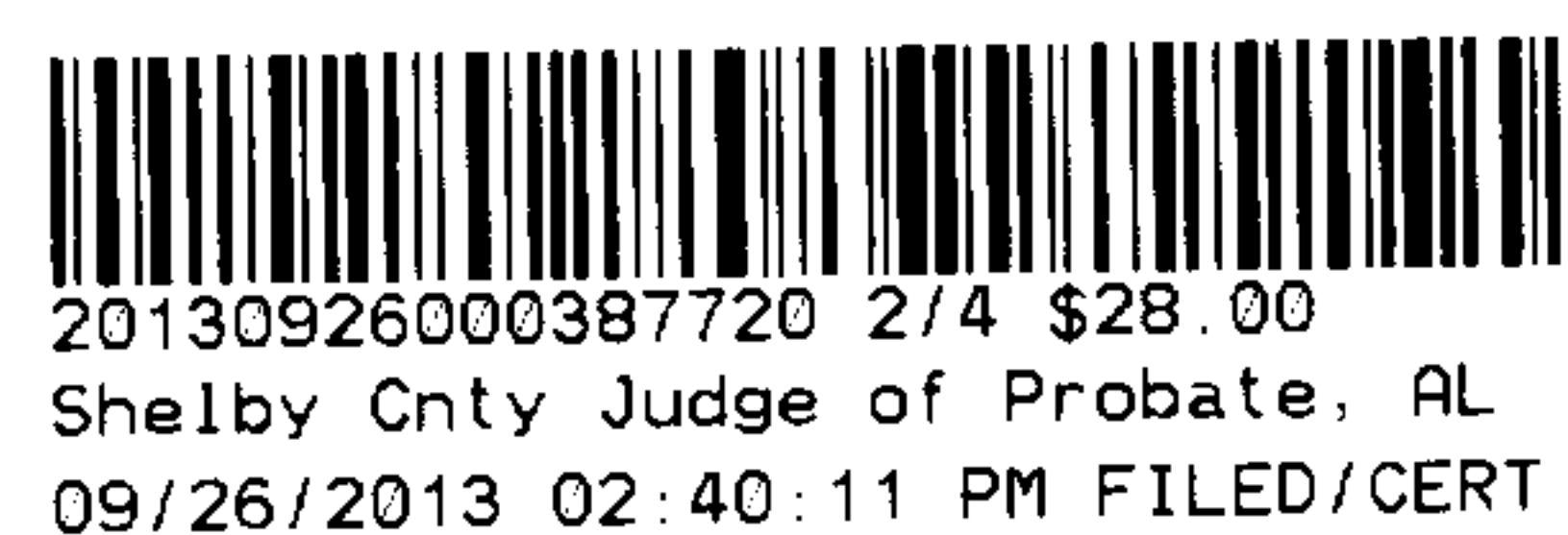
