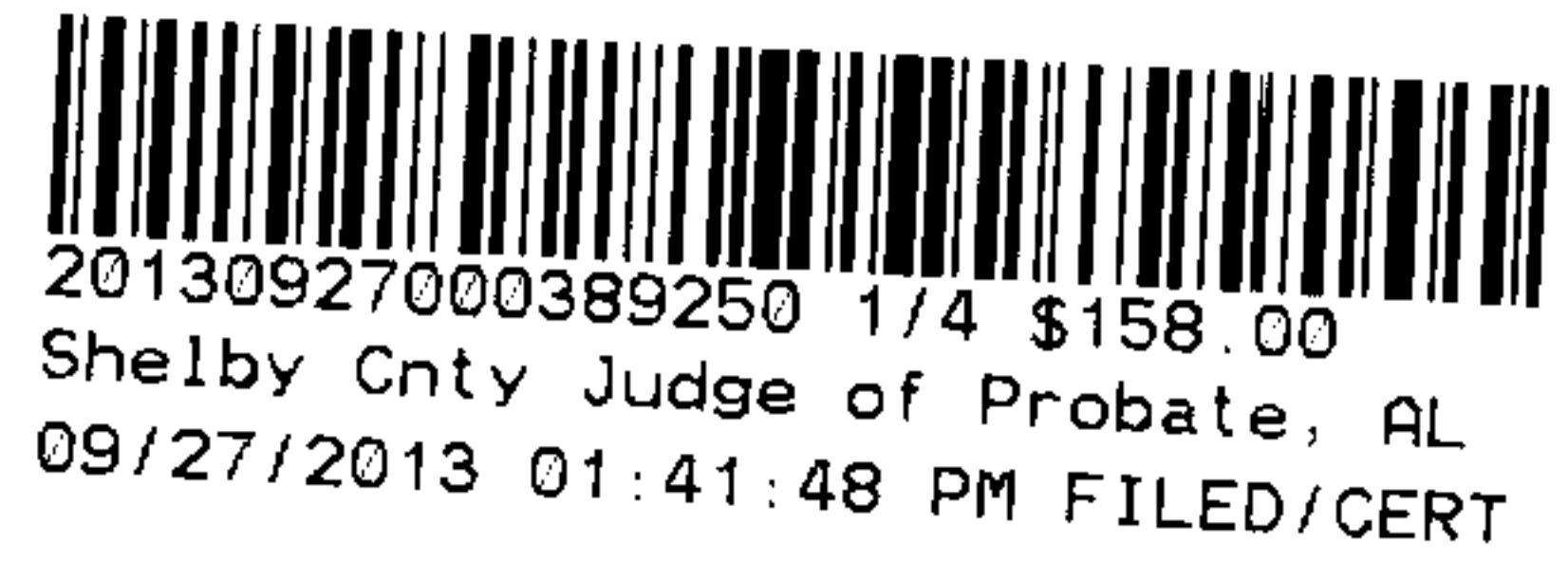

Articles of Incorporation
Of

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, Timothy E. Brown, acting as incorporator of a corporation under the Code of Alabama, hereby adopts the following Articles of Incorporation for the corporation:

ARTICLE I. NAME

The name of the corporation shall be **BrownSmith, Inc.**, and the corporation shall be authorized to operate under that name or use any other trade name not now being used by another person, firm or corporation.

ARTICLE II. PERIOD OF DURATION

The duration of the corporation is perpetual.

ARTICLE III. PURPOSE

The purpose for which the corporation is formed is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama, including the development, design, and sales of computer design.

ARTICLE IV. OFFICE AND AGENT

The location of the initial registered office of the corporation shall be 4700 Highway 280, Birmingham, Alabama, 35242, and the name of its initial registered agent at that address is **Timothy E. Brown.**

ARTICLE V. AUTHORIZED SHARES

The authorized capital stock of the corporation shall be one thousand (1,000) shares of common stock having a par value of One and No/100 (\$1.00) Dollar per Share.

ARTICLE VI. INCORPORATOR

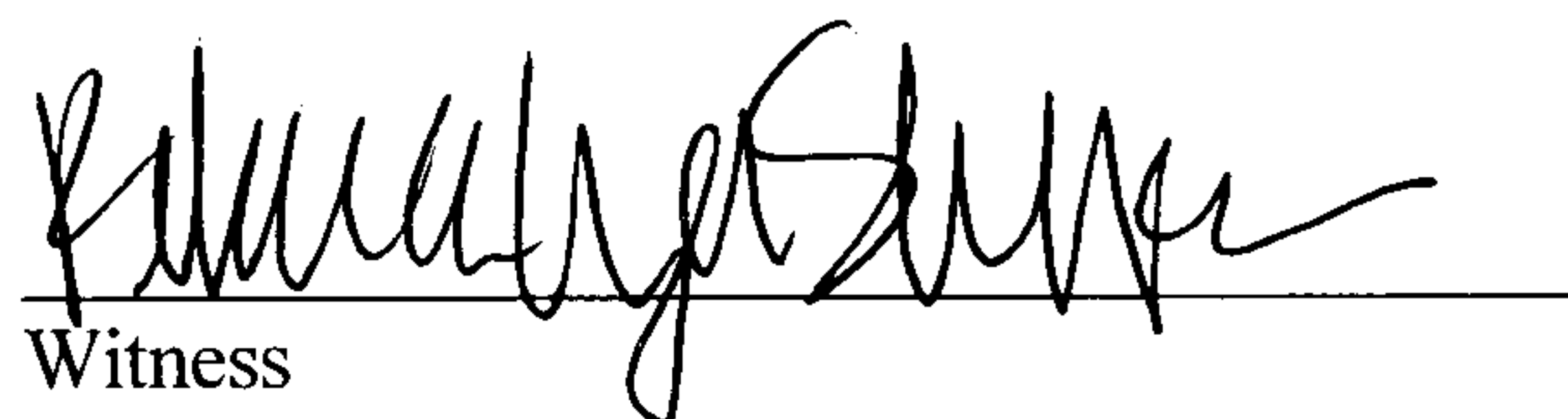

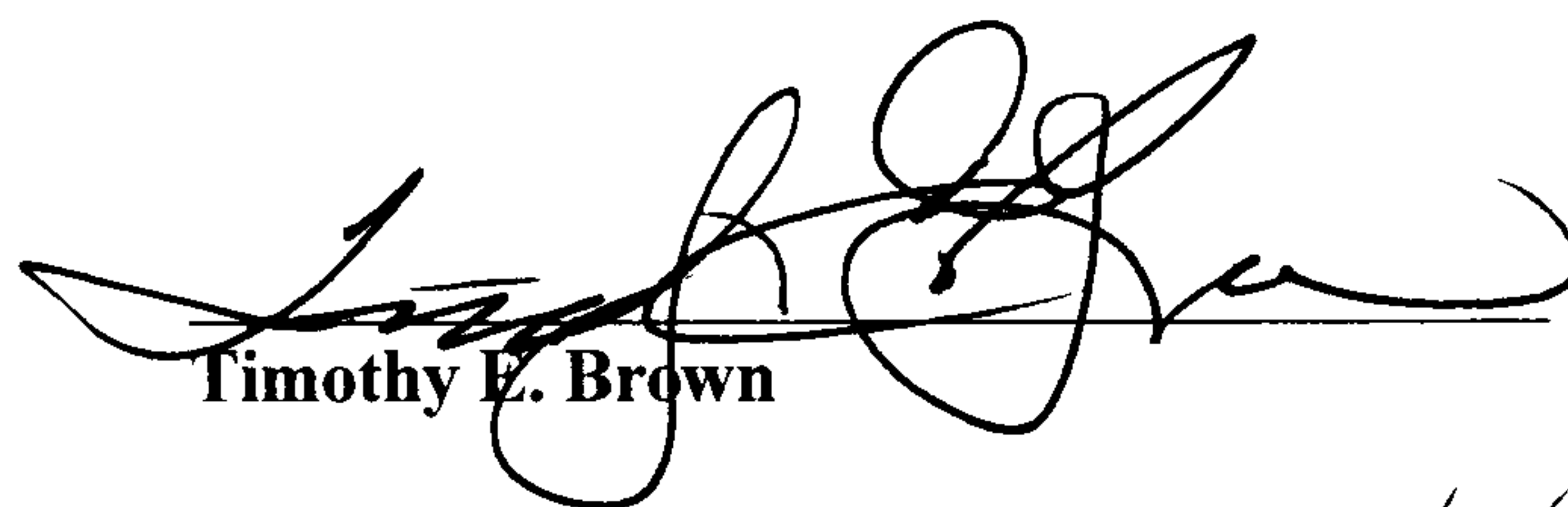

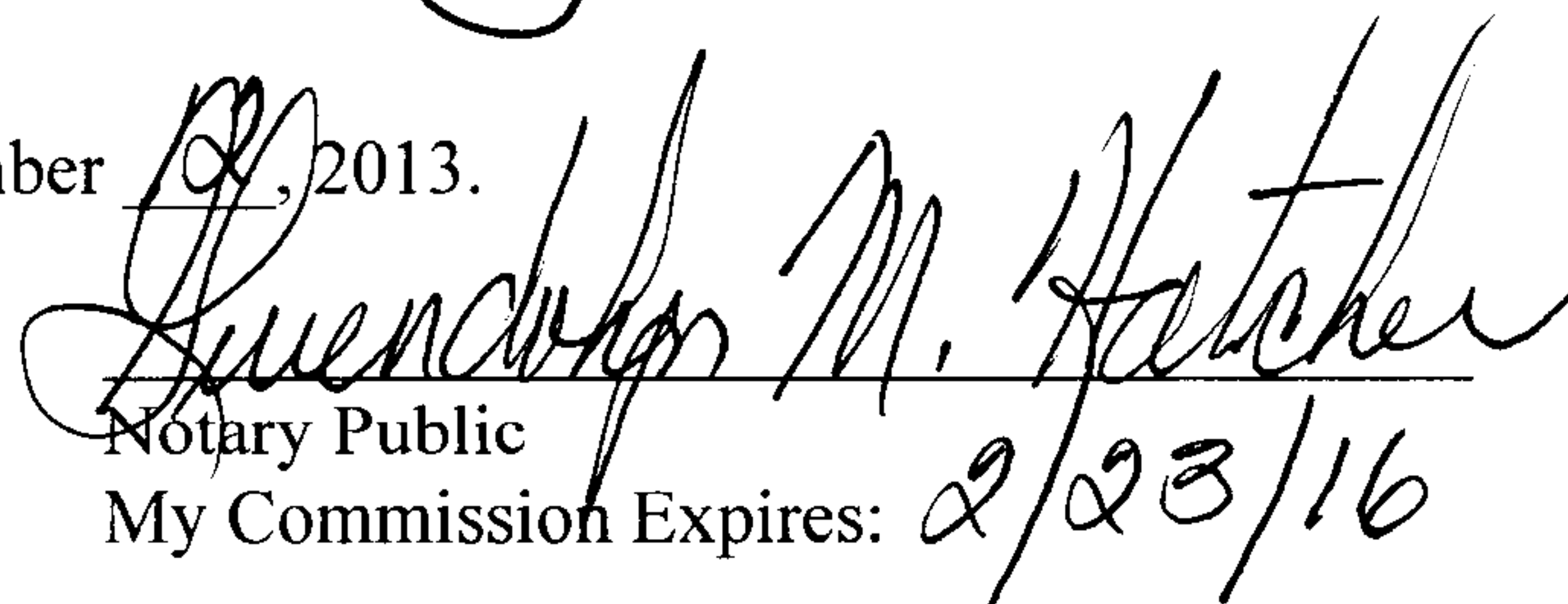
