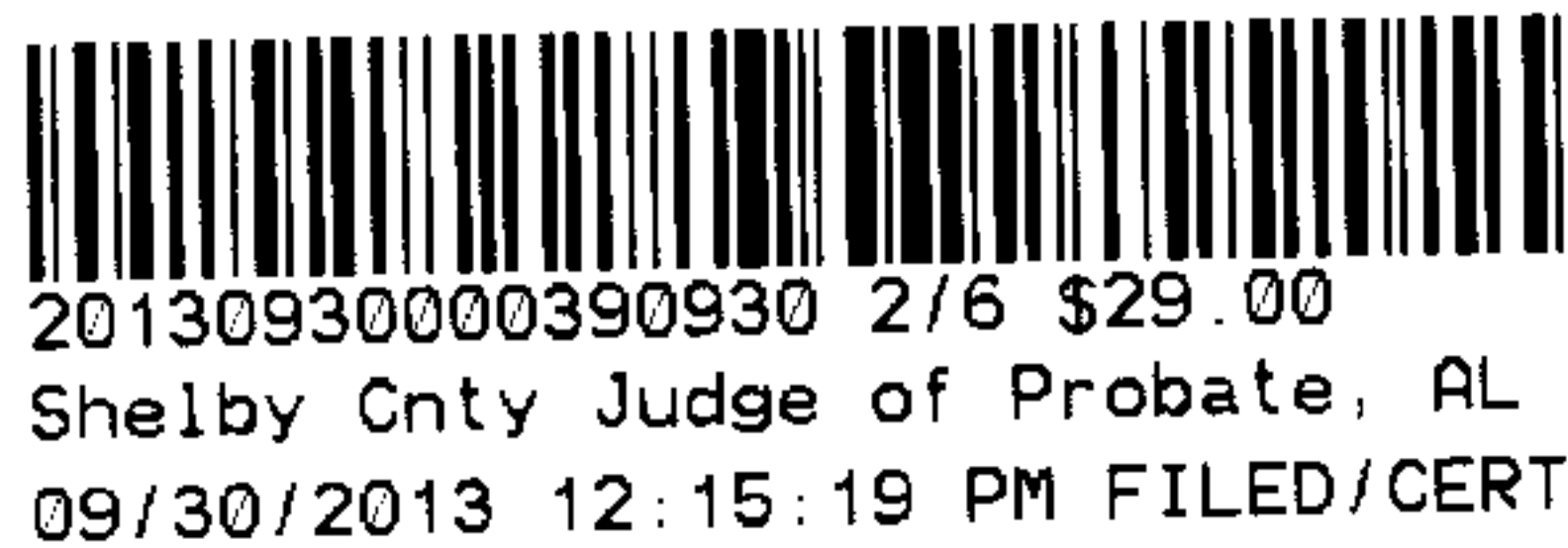

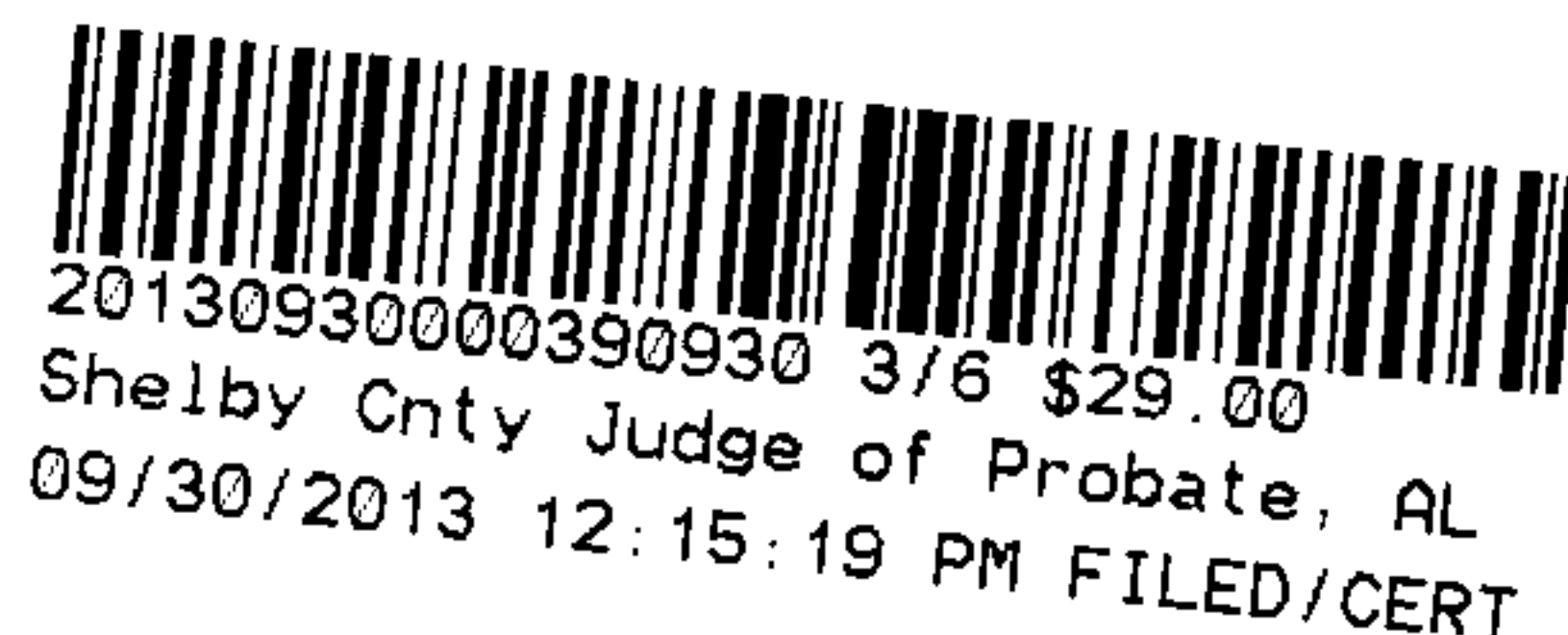

## IMPORTANT INFORMATION FOR AGENT
