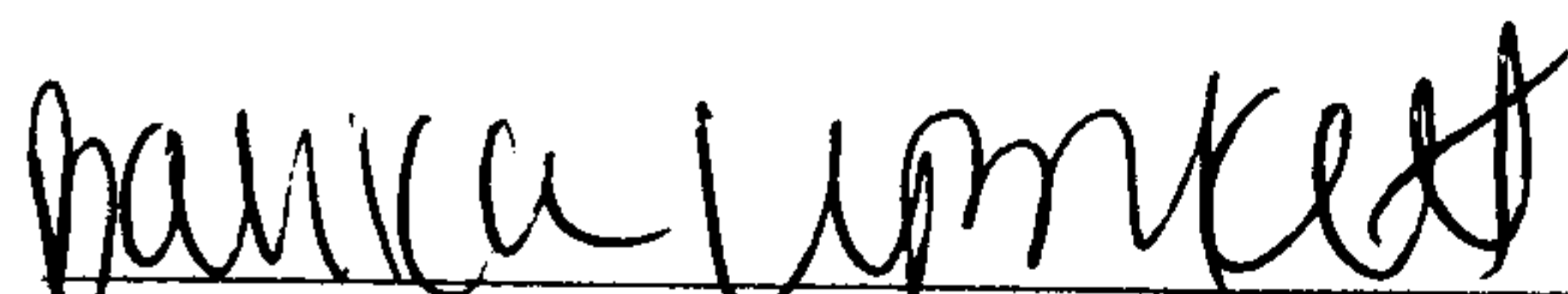

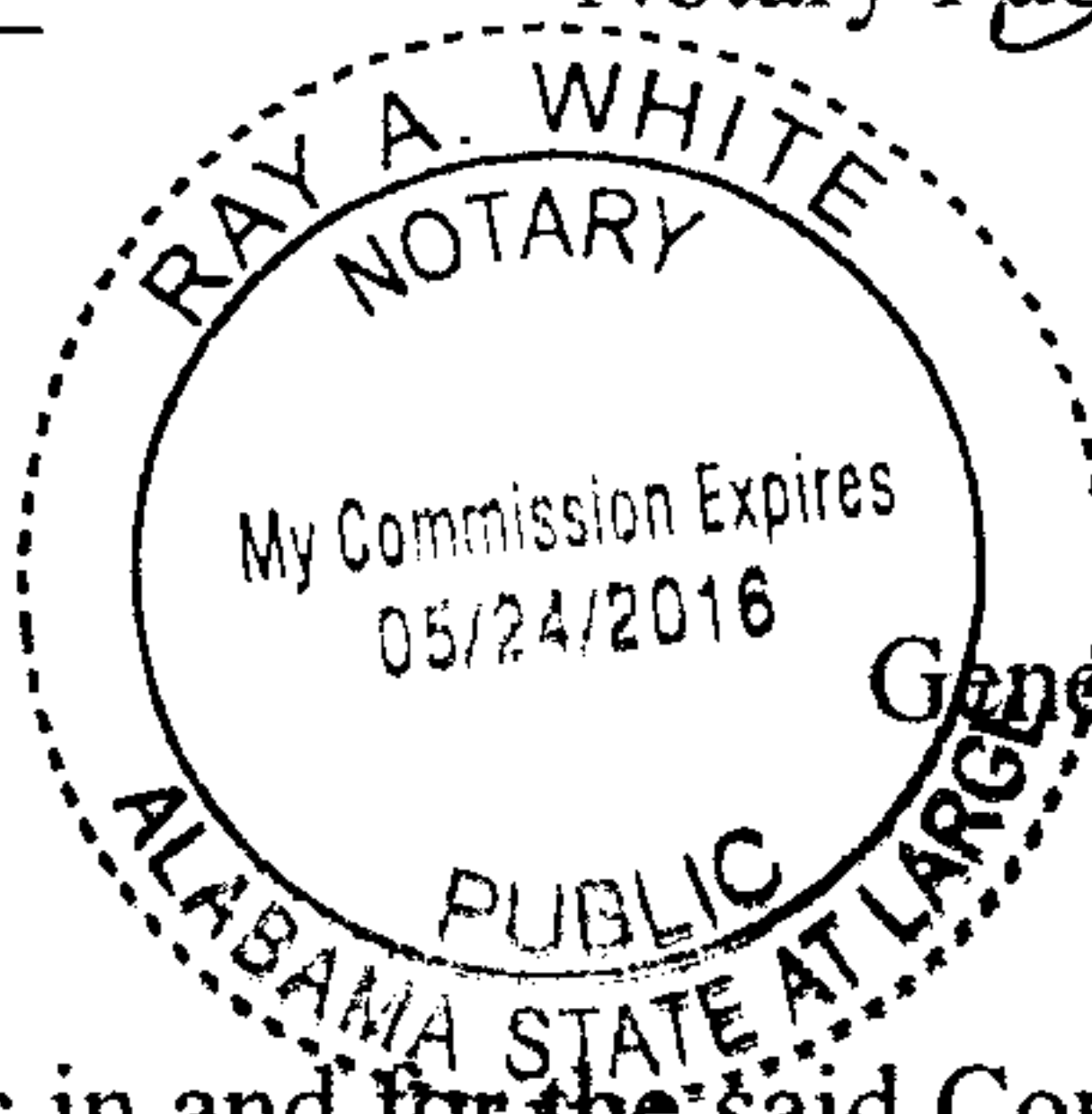

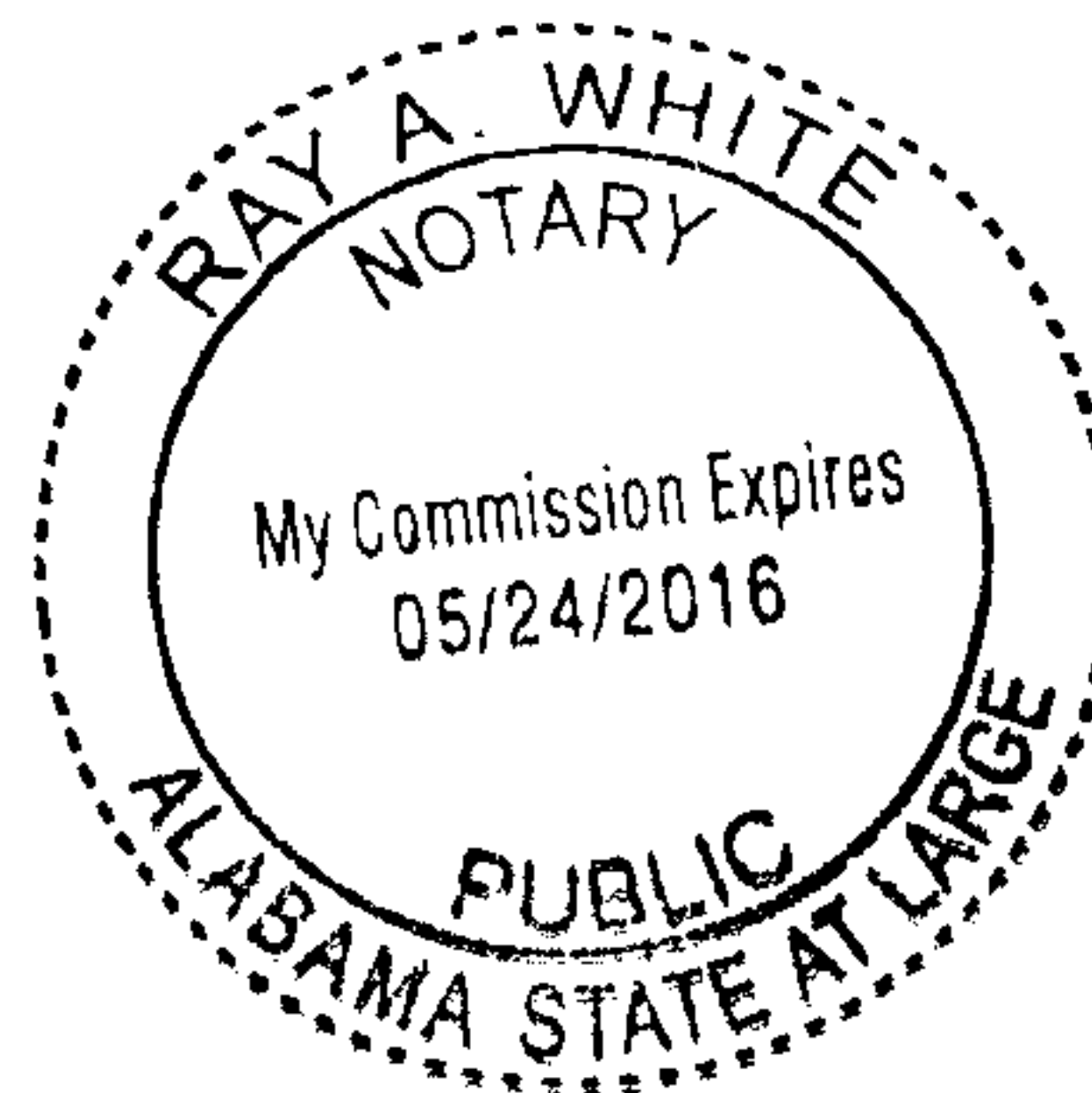


EXHIBIT "S"
