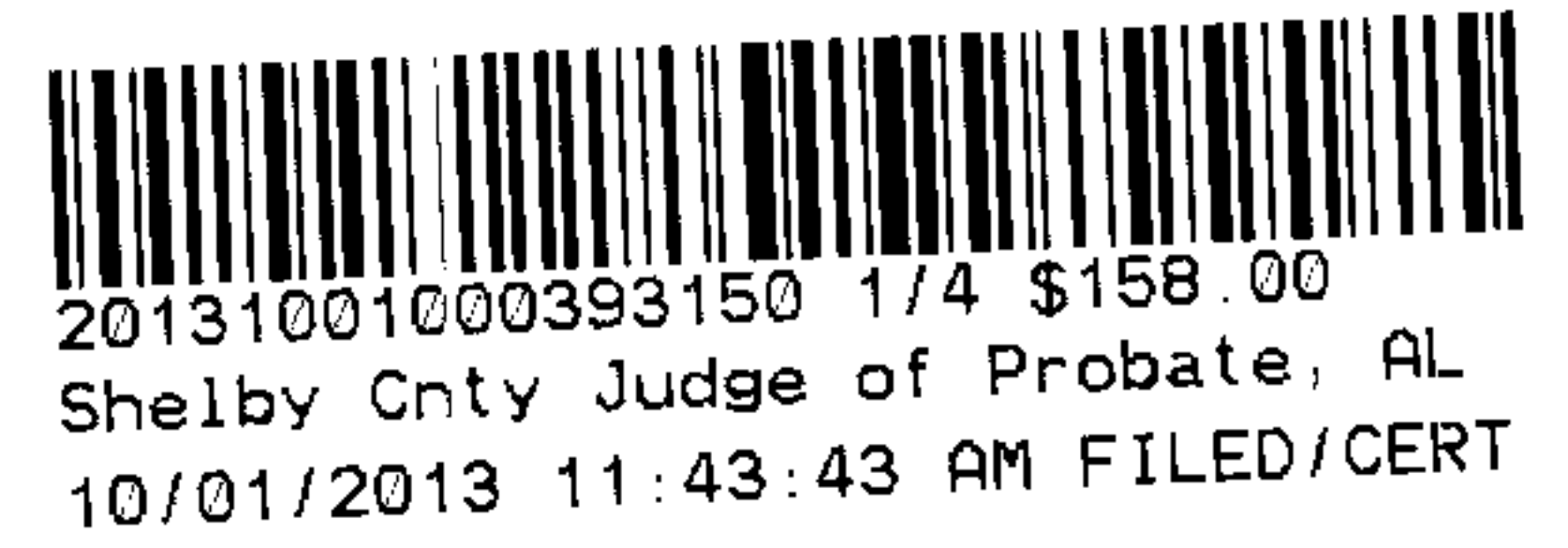




**CERTIFICATE OF FORMATION
OF
NOTTINGHAM BUILDING GROUP, INC.**

IN THE OFFICES OF THE JUDGE OF PROBATE
OF SHELBY COUNTY, ALABAMA

Pursuant to the Alabama Business Corporation Law as set forth in Chapter 1 and 2 of the Alabama business and Nonprofit Entity Code, the undersigned, acting as organizer of a corporation, hereby adopts the following Certificate of Formation:

- FIRST:** The name of the corporation is NOTTINGHAM BUILDING GROUP, Inc.
- SECOND:** the entity being formed is a domestic business corporation.
- THIRD:** The period of its duration is perpetual.
- FOURTH:** The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Laws of the State of Alabama, and to participate in all types of business which are allowed by the Laws of the State of Alabama.
- FIFTH:** The aggregate number of shares which the corporation shall have authority to issue are one thousand (1000) shares of common stock of par values of one dollar (\$1.00) per share. All of said stock shall be common and none shall be preferred stock or stock of a different class.
- SIXTH:** There are no provisions for the regulation of the internal affairs of the corporation.
- SEVENTH:** The address for the initial registered office of the corporation is: 100 Cheshire Lane, Pelham, AL 35124 and the name of its initial registered agent at such address is: Kevin Michael Weber

EIGHTH: the name and address of the organizer is: Kevin Michael Weber 100

NINTH: The number of directors constituting the initial board of directors of the
corporation is one, and the name and address of the person who is to serve
as director and officer until the first annual meeting of shareholders and
until their successors are elected and shall qualify is as follows:

Corporation Law; (D) an intentional violation of criminal law; or (E) a
breach of the director's duty of loyalty to the Corporation or its
shareholders.

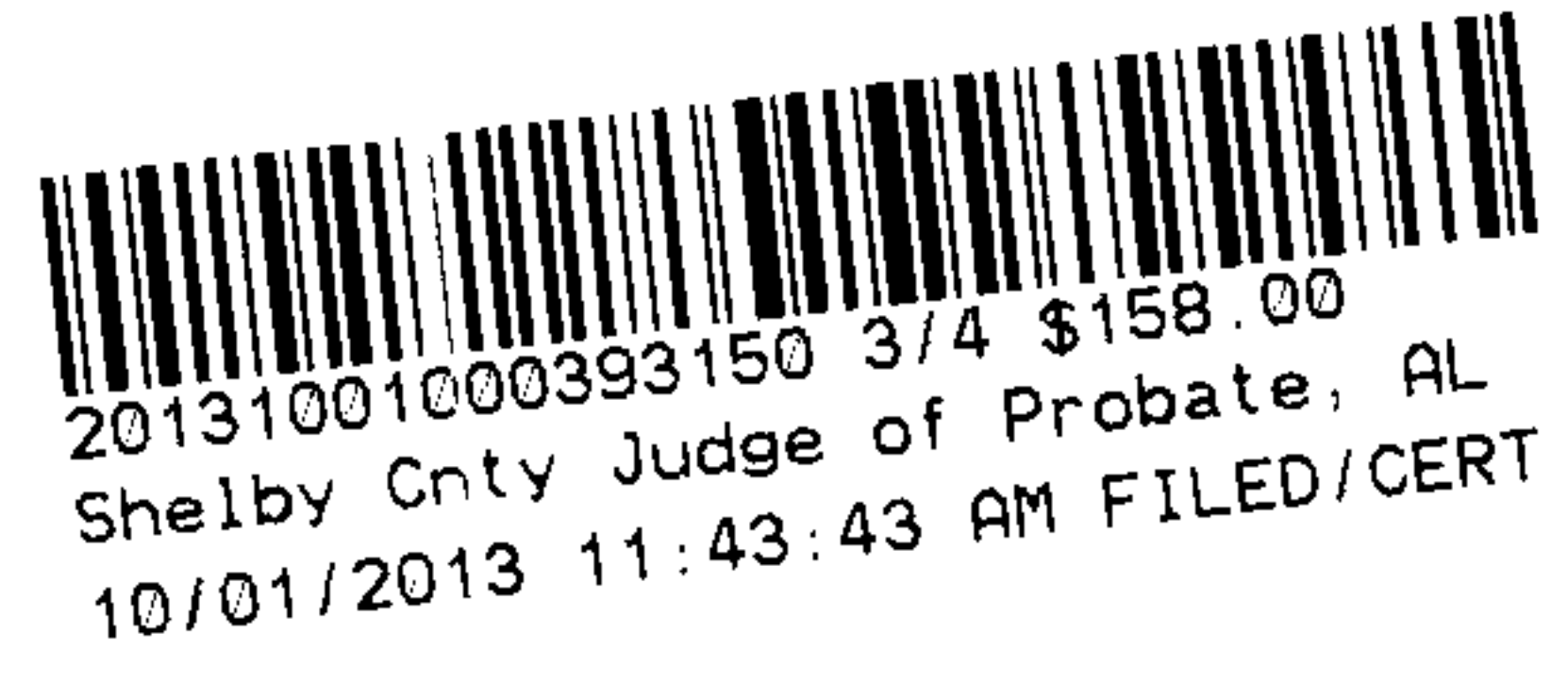

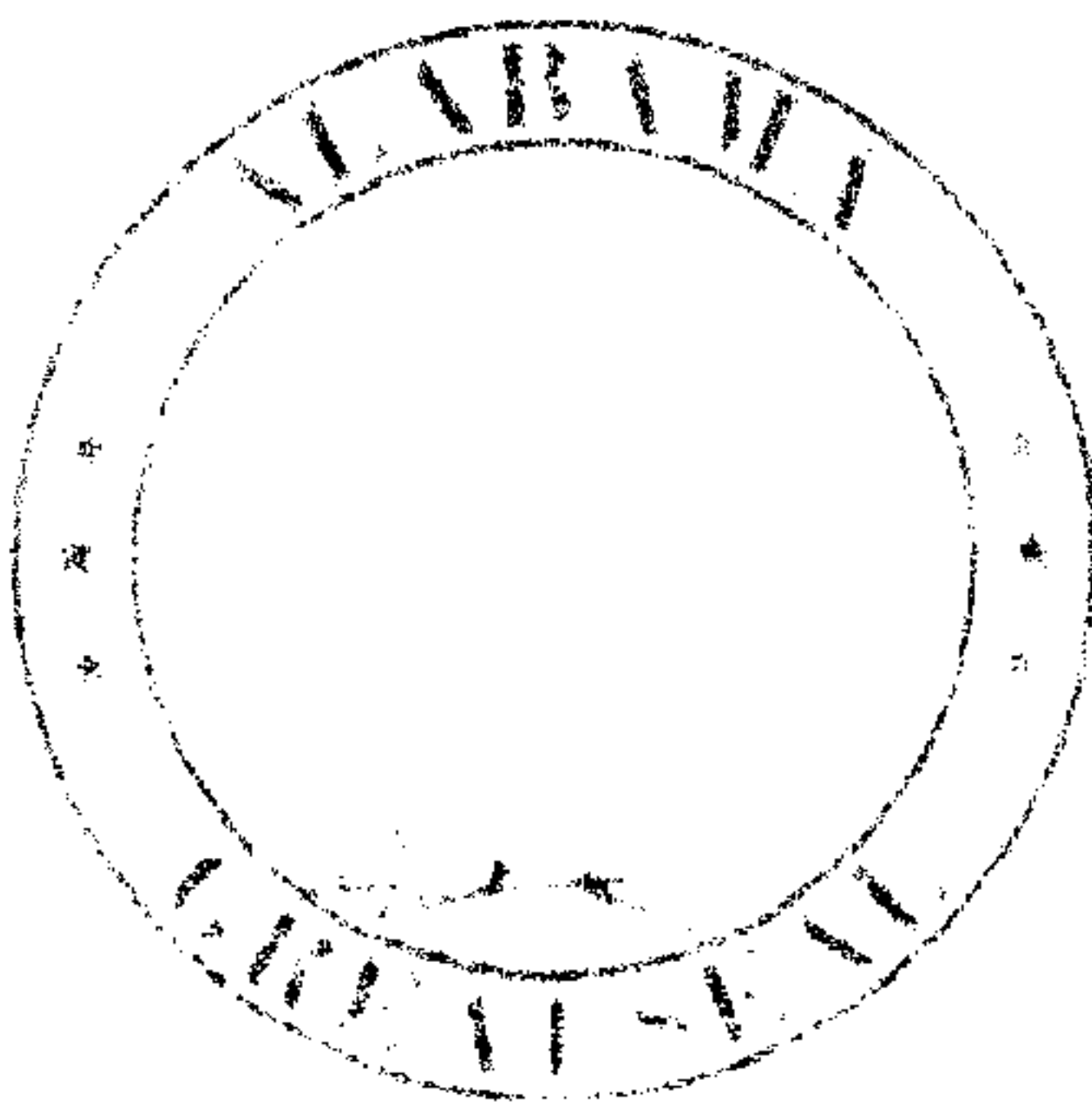
