## **AFFIDAVIT AS TO HEIRS**

To me personally known, who being be duly sworn, on oath did say that Affiant is familiar with the family history of Elmer Ingram and Josephine Ingram, husband and wife; and that the Affiant is the son of Elmer and Josephine Ingram; Affiant further states that Elmer Ingram and Josephine Ingram, husband and wife, were the owners of the following real property in the County of Shelby, State of Alabama.

**Commence at the Southwest corner of the Northeast one-fourth of the Northwest one-fourth of Section 9, Township 19 South, Range 2 East, Shelby County, Alabama, thence proceed North along the West boundary of said quarter-quarter section for a distance of 390.0 feet to the point of beginning. 
