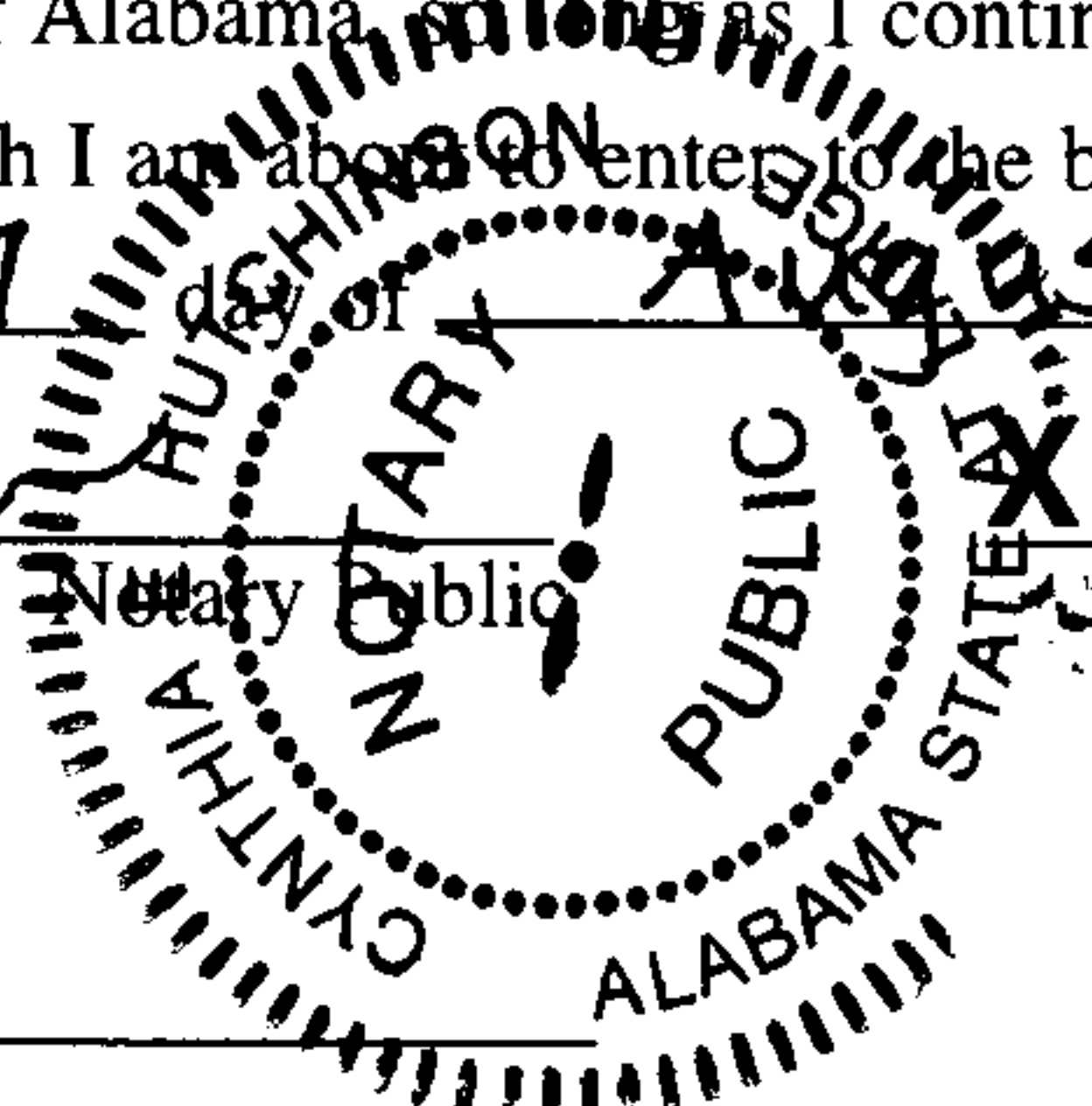
### Oath of Office

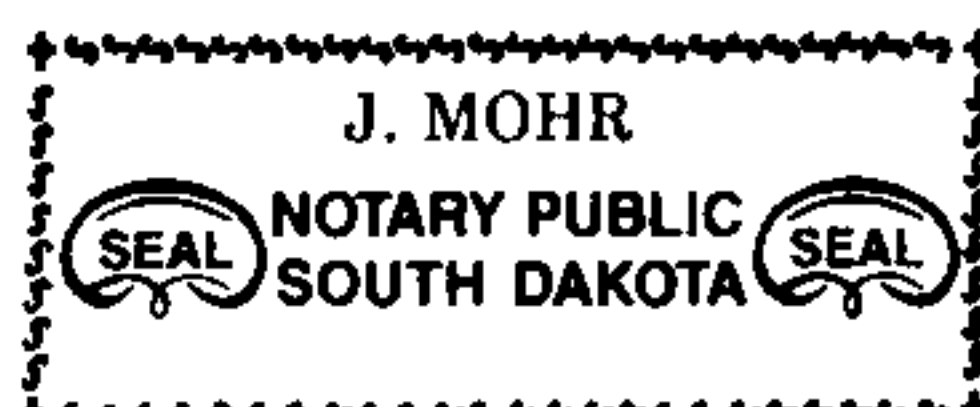
