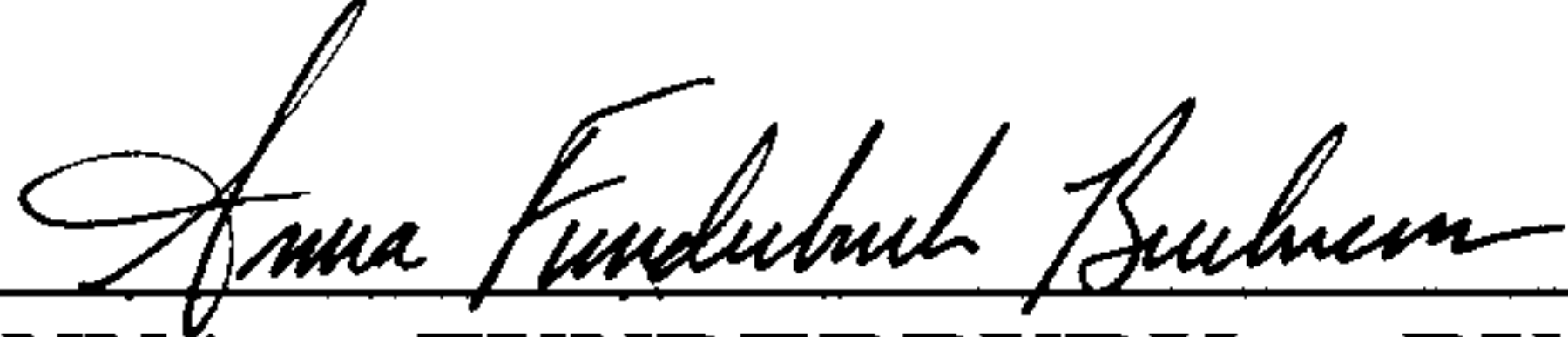
Certificate of Trust
