KNOW ALL MEN BY THESE PRESENTS, That in consideration of Three Hundred Ninety-Five Thousand and 00/100 Dollars (\$395,000.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **Joseph K. 
\$316,000.00 of the consideration recited above was paid from a purchase money first mortgage loan closed simultaneously herewith.


Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.


