KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Three Hundred Eighty-Nine Thousand Nine Hundred and 00/100 Dollars (\$389,900)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Thomas Andrew Brower and Janamarie B. Brower

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:

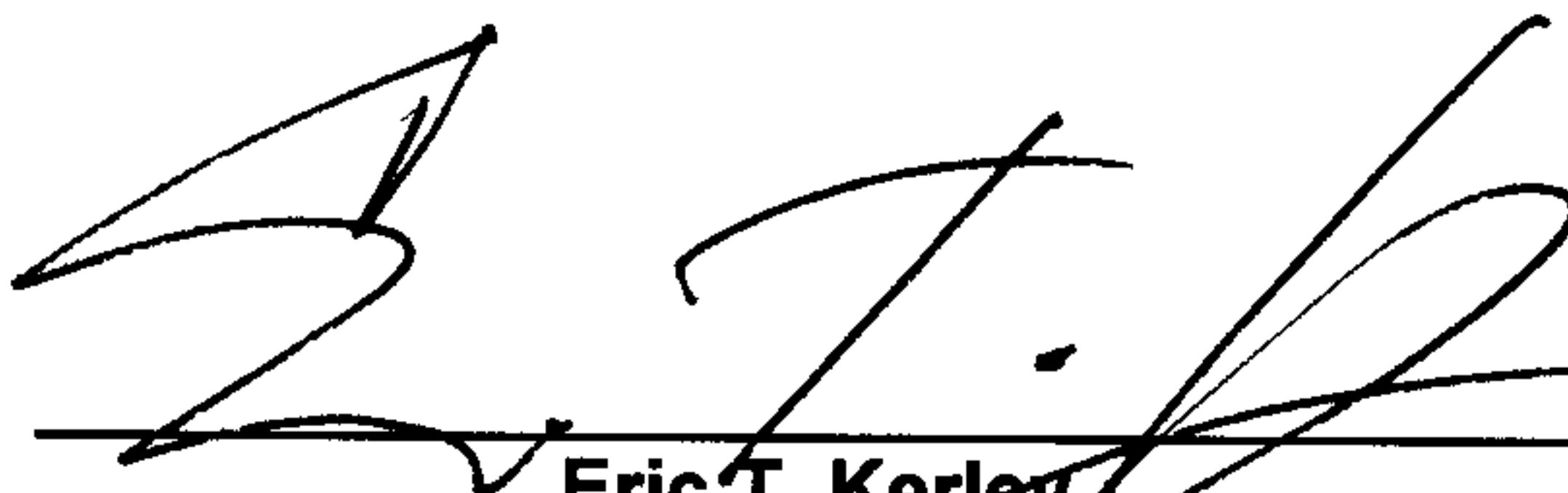
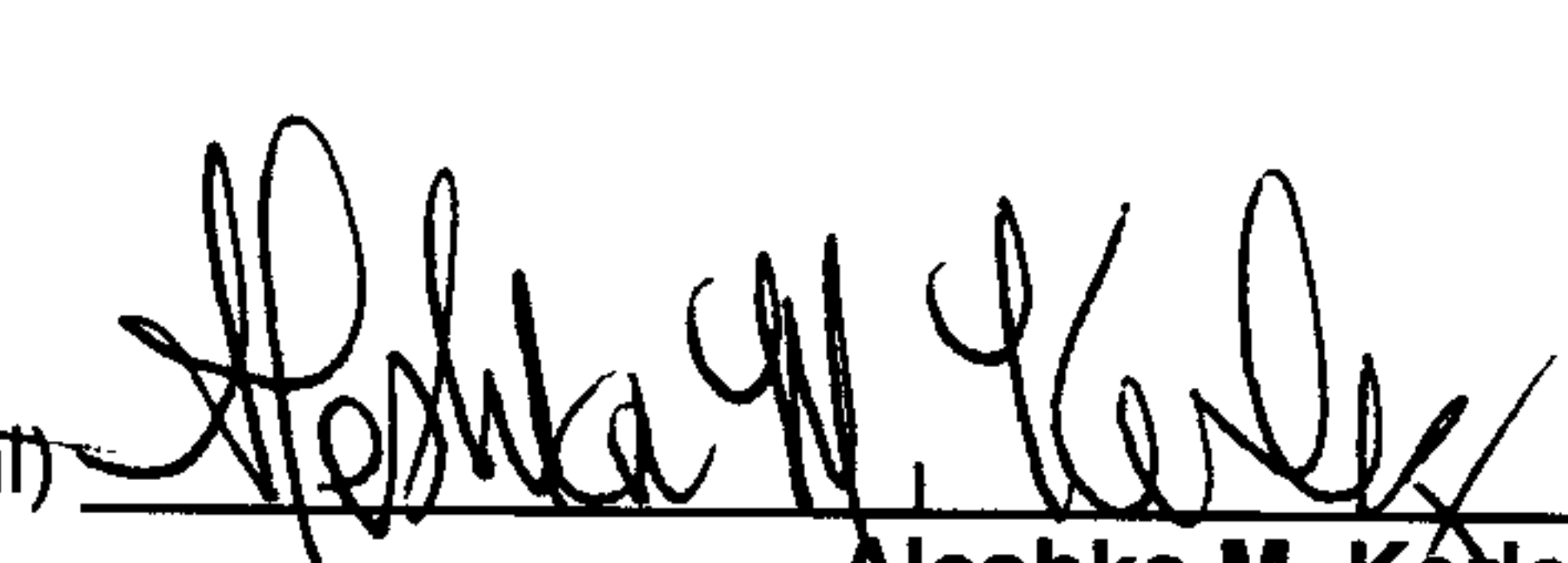
\$311,920 of the proceeds come from a mortgage recorded simultaneously herewith.
