WHEREAS, heretofore, on, to-wit: the 9th day of February, 2007, Ronald D. Goodwin and wife, Lori L. 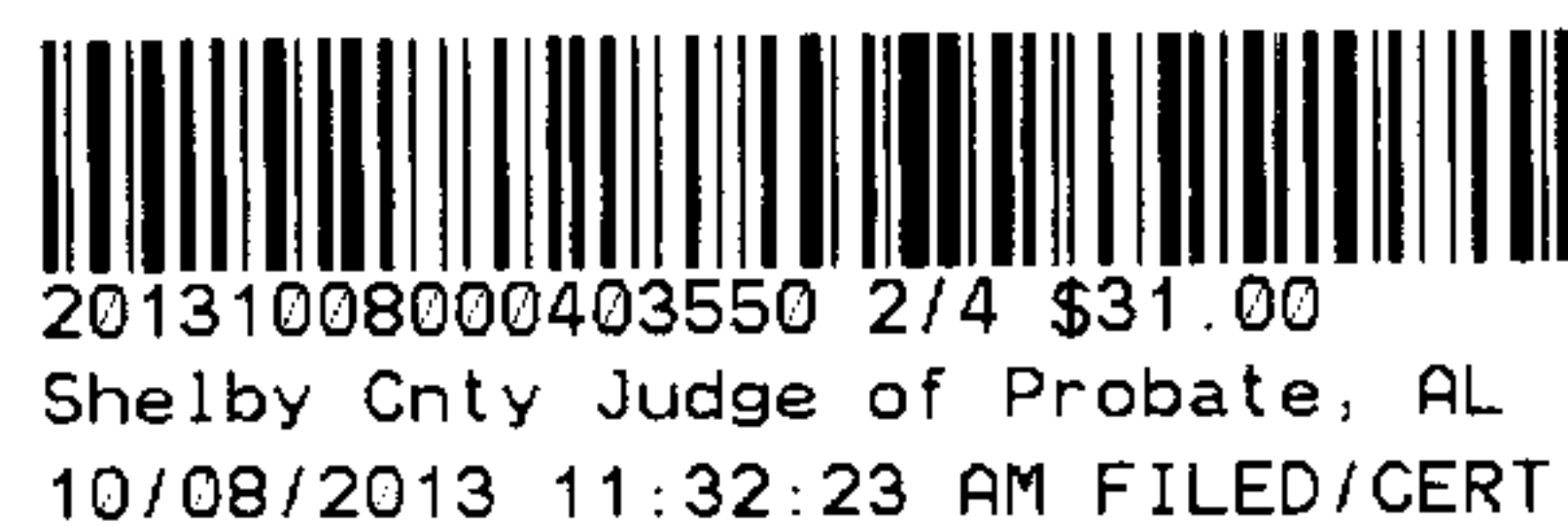

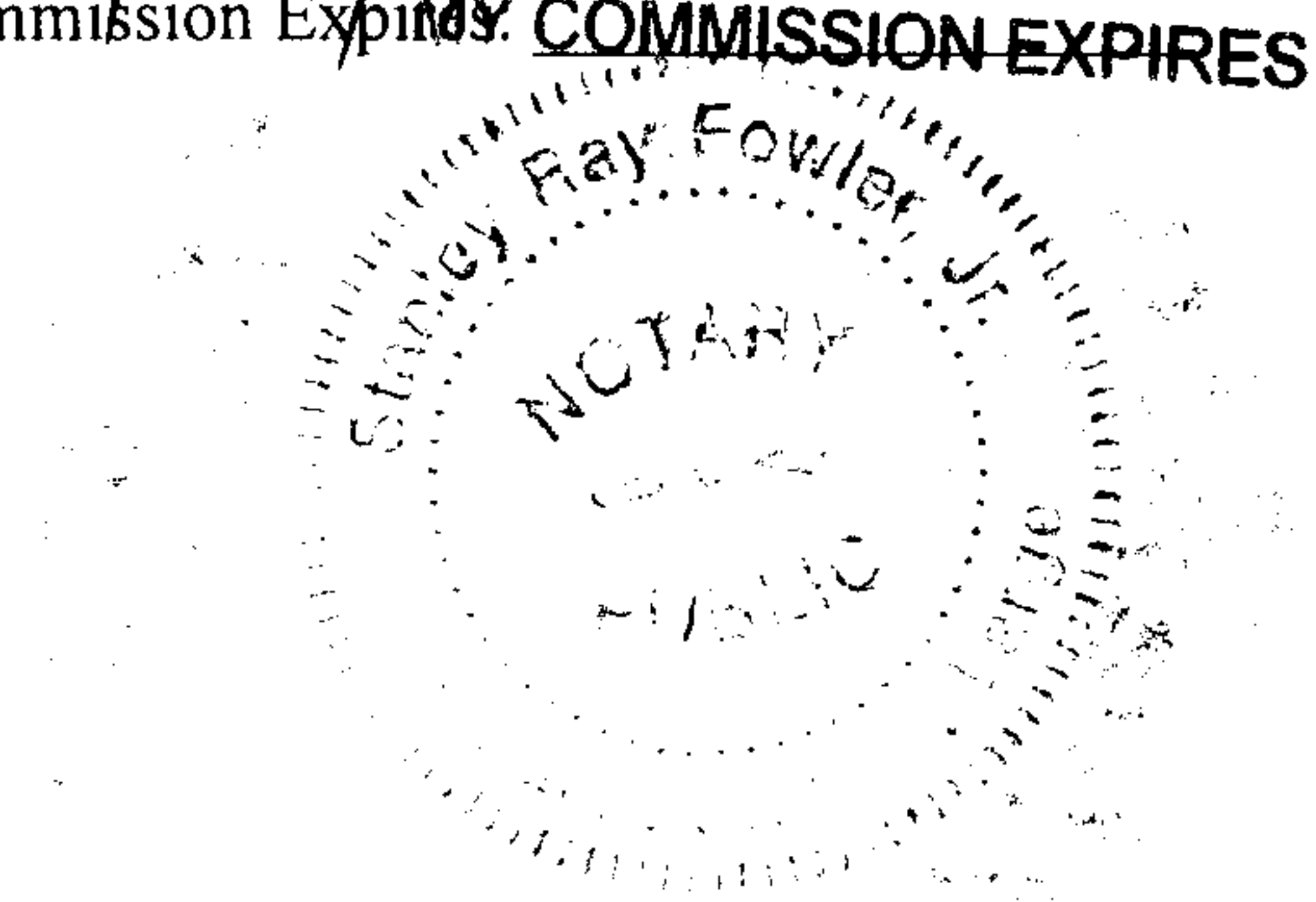
