KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of September, 1999, Timothy E. Gardner, and wife Rachael L. 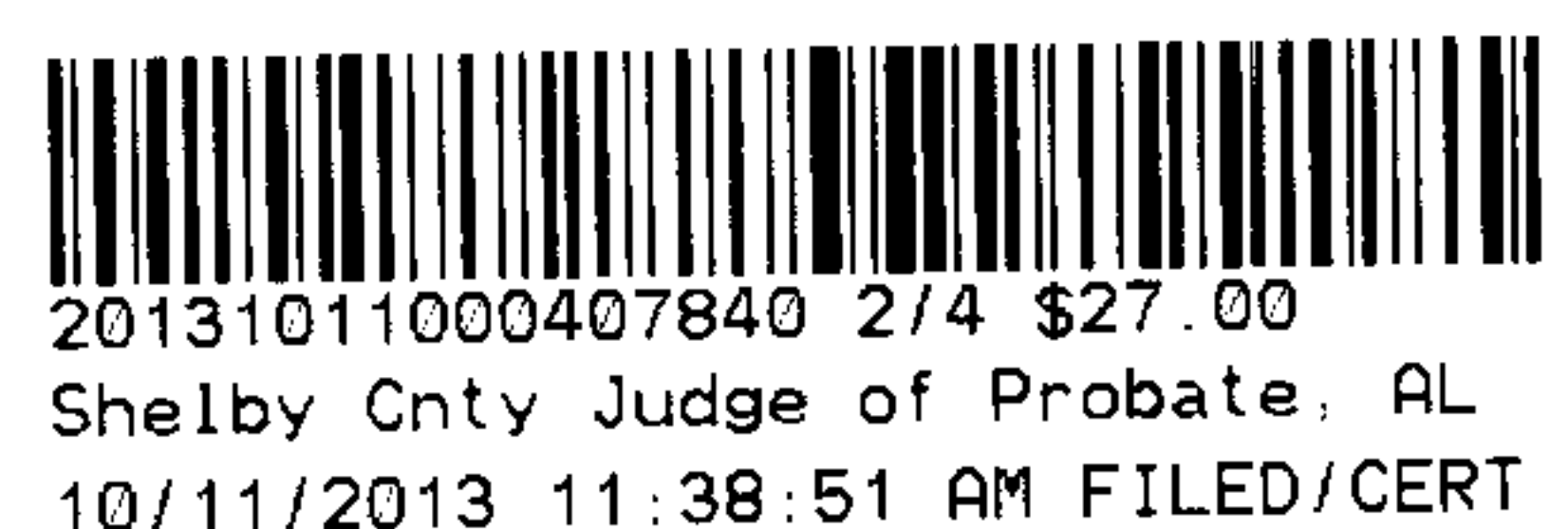
