
Mineral and mining rights excepted. Subject to current taxes, easements, covenants, conditions and restrictions of record.

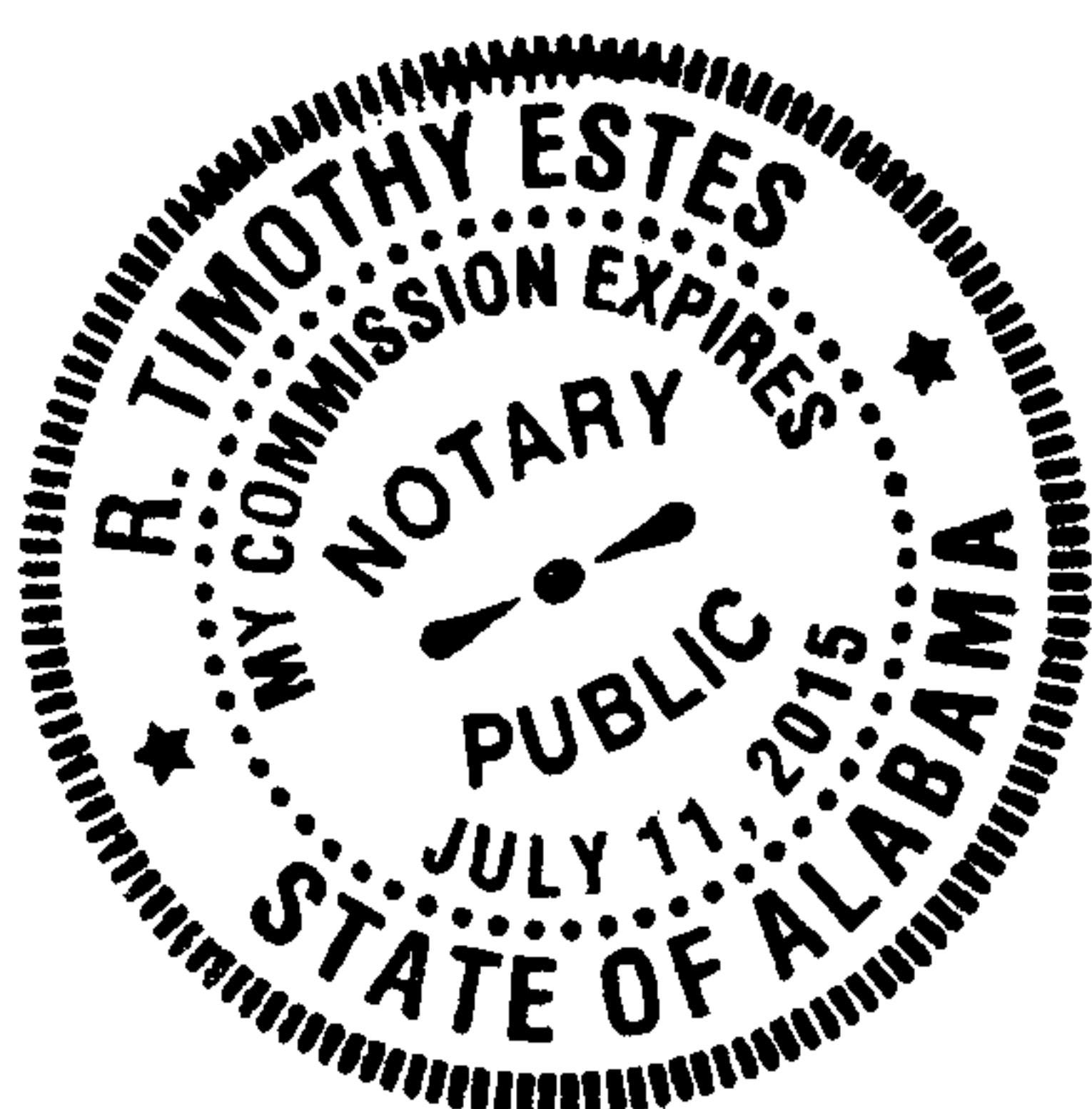


