KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 6th day of December, 2006, Aamara Shazia and Muhammad Arif, a married couple, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Dream House Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument number 20070223000083810, said mortgage having subsequently been transferred and assigned to Citimortgage, Inc., by instrument recorded in Instrument Number 20130318000112010, in the aforesaid Probate Office ("Transferee"); and

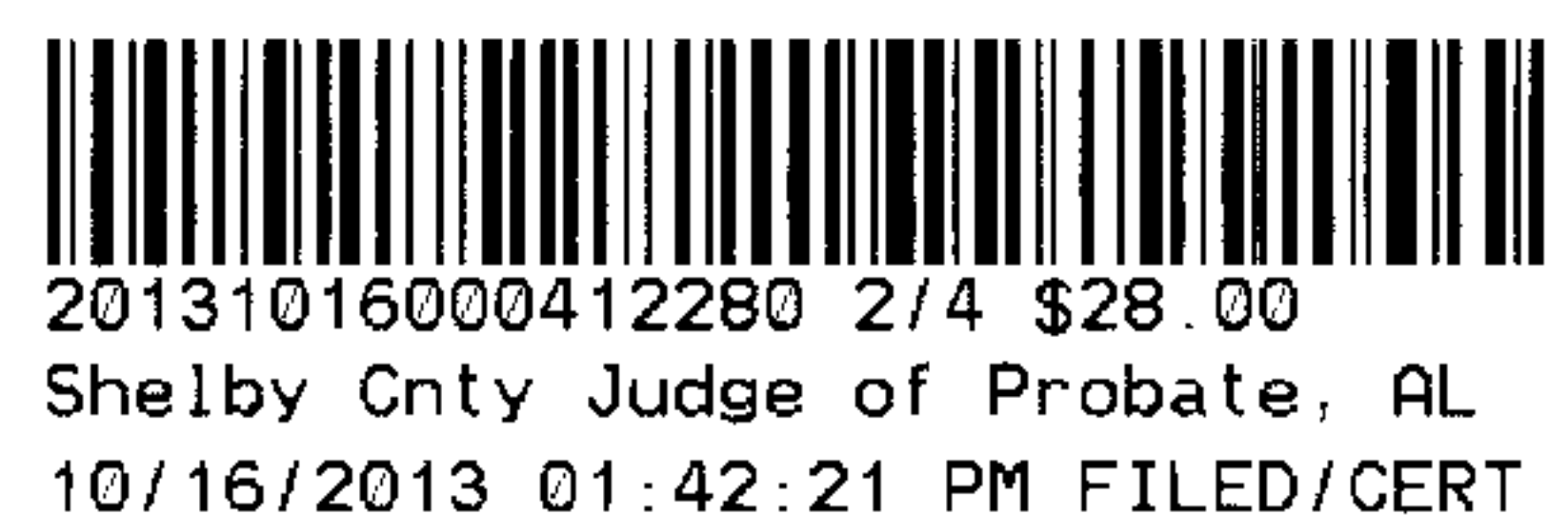

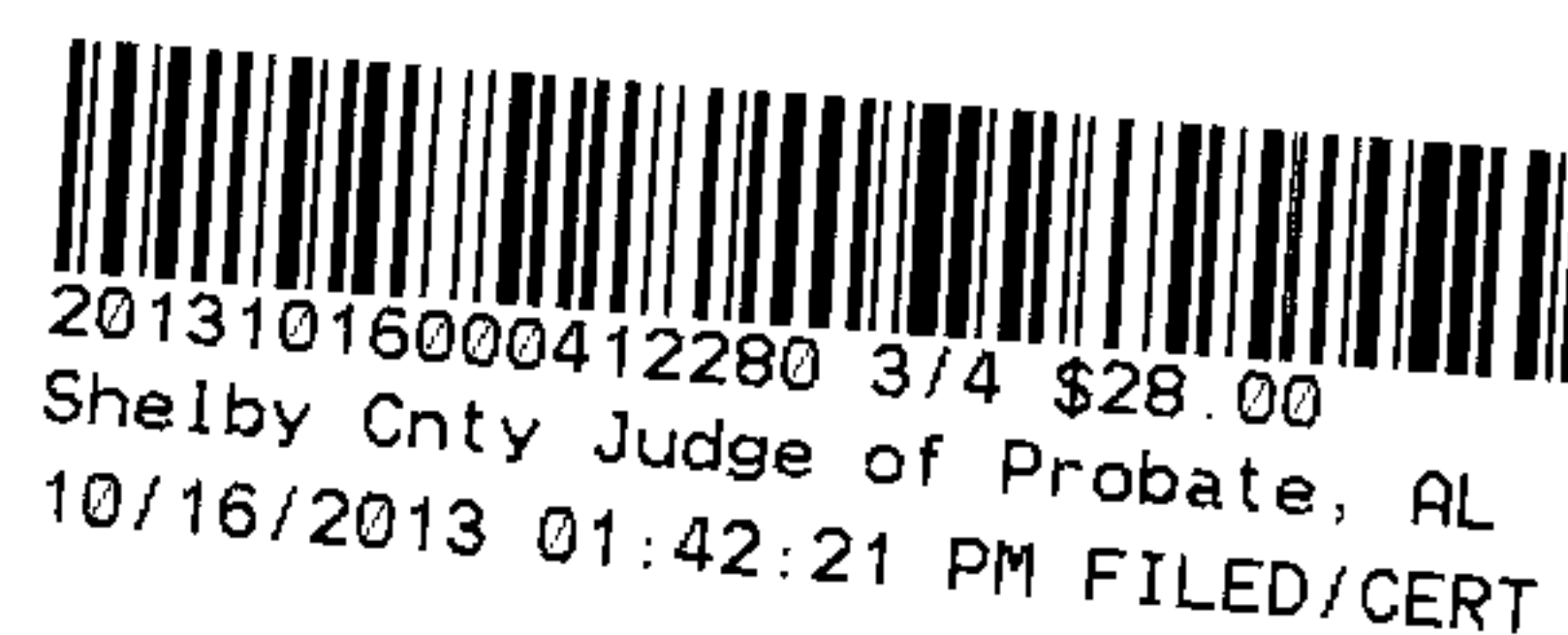
