
KNOW ALL MEN BY THESE PRESENTS, that in consideration of One Dollar (\$1.00) and other good and valuable consideration to the undersigned GRANTORS in hand paid by the GRANTEE, the receipt and sufficiency of which is hereby acknowledged, we, Joseph Cobb and Leslie Cobb, husband and wife (herein referred to as GRANTORS), do grant, bargain, sell, and convey unto the Water Works Board of the Town of Vincent (herein referred to as GRANTEE) a right of way and easement to install, construct, maintain, operate, repair, alter, replace, and remove utility and waterlines, including metering and regulating facilities and any and all appliances, appurtenances, fixtures, and equipment, whether above or below ground, including, but not limited to, lines, pipes, headers, valves, with necessary housing for same and otherwise, as from time to time deemed by GRANTEE to be necessary or desirable in connection with or incidental to the conduct of GRANTEE'S business, and the operation and fulfillment of the purposes provided by this grant or conveyance, upon, over, under, through and across the following described lands situated in Shelby County, Alabama, to-wit:

A utility easement in the Northwest Quarter of the Southwest Quarter of Section 23, Township 19 South, Range 2 East, in Shelby County, Alabama and being more particularly described as follows:

Commence at an existing 2 in. pipe at the Northeast corner of said Quarter-Quarter Section, said point being the Point of Beginning, and run South 00° 36′ 15″ East along the East line of said Quarter-Quarter Section for 20.03 feet to a 5/8 in. rebar set; thence North 87° 29′ 50″ West for 345.56 feet to a 5/8 in. rebar set; thence North 37° 46′ 15″ East for 24.50 feet to a 5/8 in. rebar set on the North line of said Quarter-Quarter Section; thence South 87° 29′ 50″ East along said North line for 330.29 feet to the Point of Beginning.
